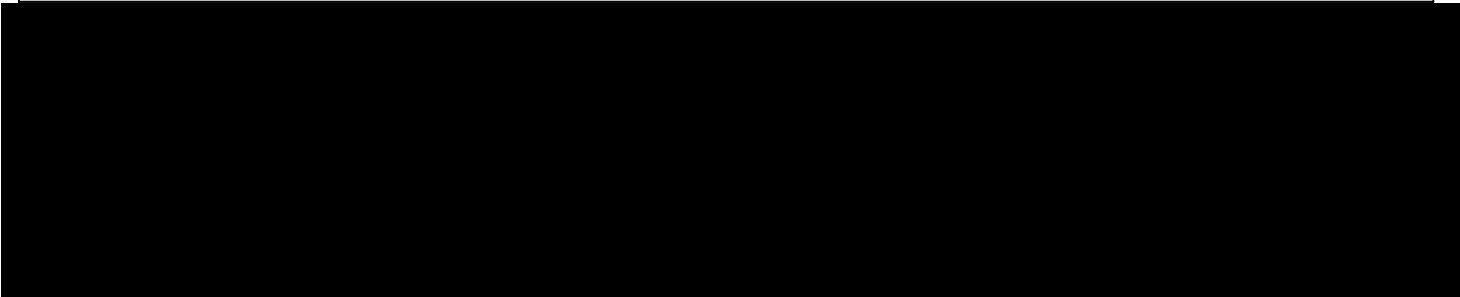

Notes/Narratives

On 4-4-16 around 1015 hours, [REDACTED] (Assistant Principal) got on the school radio to notify all radio holders that an 8th grader, [REDACTED] walked out of the cafeteria without permission and he wanted [REDACTED] to come back immediately. School Security ([REDACTED] [REDACTED]) went looking for him throughout the school. [REDACTED] ran upstairs and ignored the entire Security Staff as well as [REDACTED] (another Assistant Principal). [REDACTED] continued to walk all over the school not listening to any commands and cursing. [REDACTED] would not stop for anyone. [REDACTED] called for my assistance down in the 200 hallway (near door 4). During this time there were several kids and teachers in the hallway. I observed [REDACTED] holding onto [REDACTED], trying to get him to stop and calm down. [REDACTED] was actively trying to get away from [REDACTED]. I ran over to assist. For the safety of [REDACTED] and the other students in the building, I handcuffed [REDACTED]. [REDACTED] was escorted to room 204 where the entire Security Staff, two AP's and myself were in the room. [REDACTED] finally calmed down so I escorted him to the front office and he sat in the principal's conference room while we waited for [REDACTED] mom to come and pick him up. I notified [REDACTED] and his mom that I would be charging him with Disorderly Conduct. Around 1115 hours I uncuffed [REDACTED] and [REDACTED] in the conference room. [REDACTED] mom checked him out of school at 1130 hours.

[REDACTED] was serving lunch detention today and was throwing small plastic pieces in the cafeteria which started this whole incident. [REDACTED] went over to investigate the situation and talk to [REDACTED] about it. However, [REDACTED] immediately became disrespectful, defiant, etc. and walked out of the cafeteria without permission.

I have sent the report and Intake form to Juvenile Intake for processing. Nothing further at this time.
