On 4-28-16 a 7th grade female student, [REDACTED] was brought to my office by one of the P.E. teachers. [REDACTED] stated that she was standing in the small area outside the locker room when a male student grabbed her and pushed her to the ground. [REDACTED] was not injured. [REDACTED] stated that the boy who did this was, [REDACTED] I spoke to [REDACTED] and he stated that he went upstairs to grab his planner/binder from one of the teacher's classrooms. He said he came back downstairs and ran into the gym and when he turned the corner where [REDACTED] was standing he accidentally bumped into her knocking her down. I talked to two witnesses and one story is similiar to [REDACTED] and the other one matches [REDACTED]

Both parents were notified and [REDACTED] mom wanted to press charges for assault. I explained to [REDACTED] mom that based on my investigation I do believe it was an accident. I spoke to [REDACTED] and his mom at length about running in the school and how people can get hurt. I gave [REDACTED] mom the number to South County Intake if she still wanted to pursue charges.
