Supplement Notes

On 5-16-16 at 0800 hours, I met with the homeowner at his residence to discuss this case. We viewed the video surveillance that he had from that evening. I went back to school and interviewed my first suspect, ██████████ said on 5-6-16 his mom dropped him off over at the Waynewood pool with a few other friends. He stated they stopped by a friend's house on ██████████ for about 15 minutes. Then ██████████ and his friends went to the Elkins 7-11. They bought a few snacks and sat outside for a little bit. According to ██████████ they walked back over to the Waynewood pool and his mom picked him and his friends up and they went home. I sent ██████████ back to class because he had an SOL to take but I told him I still had more questions and I would talk with him again in the afternoon. One of the names he mentioned that was with him was, ██████████ so I called him to my office next. ██████████ had a similiar story, however he eventually admitted they went to that house on the corner and did the "ding, dong, ditching". ██████████ said the other boys dared him and he claims he didn't know where the condoms came from. ██████████ said that ██████████ was the other one that did this with him. The other boys in the group just waited around the corner. I talked to ██████████ a second time and his story changed. He admitted to going to that house on the corner and participating in the "ding, dong, ditching" as well. He also mentioned to me that he thinks someone in the group he was with stole the condoms from the 7-11, claims he didn't know who though.

The boys went up to the house and rang the door bell and knocked on the door at the following times: 2147 hours, 2157 hours, and 2204 hours. The first time, ██████████ put a condom on the door.

Parents of both boys were notified of the pending charges. I have submitted this report for the AAP. Nothing further at this time.
