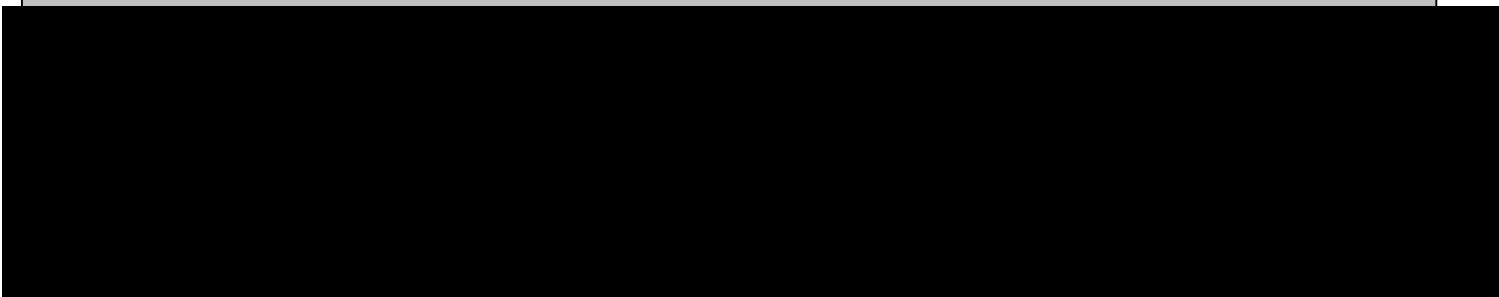

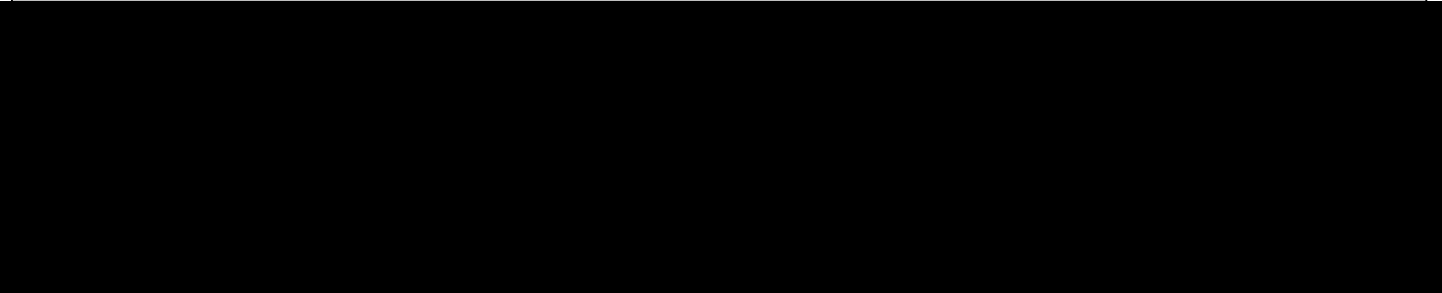

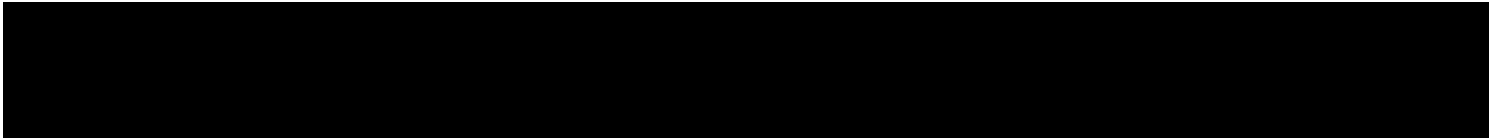

Notes/Narratives

On 5-17-16, an 8th grader [REDACTED] reported to School Security that a 7th grader [REDACTED] just punched her in the back of the head while she was upstairs going to her Advisory class.

[REDACTED] stated that earlier in the morning she got off the bus and was walking in through door 12 (as she does everyday) and there was a large group of kids walking in at the same time. [REDACTED] kept feeling someone pushing her bookbag. [REDACTED] swung around and yelled "stop pushing me" and as she turned around she used her arm to get whoever was pushing her off of her back. Her arm made contact with [REDACTED]. [REDACTED] immediately began cursing at her. A few of [REDACTED] friends came over and cornered her against the wall. One of the girls punched her twice on the right side of her head, she is not sure who did this. The girls also threatened to beat her up. Around 0910 hours [REDACTED] was walking upstairs with [REDACTED] and [REDACTED] followed them. [REDACTED] was saying, "Let`s Go. I didn`t get my hits in this morning." The girls are trying to get away from [REDACTED] [REDACTED] gets up the stairs and is now walking by herself trying to get to class and [REDACTED] ran up behind her and punched her in the back of the head. A teacher, [REDACTED], observed this assault.

[REDACTED] claims that in the morning she was not the one pushing [REDACTED] and she claims she has no idea who cornered [REDACTED]. [REDACTED] stated that she was upstairs and saw [REDACTED] and walked up to her and punched her in the head and said, "I never even touched your bag."

Both parents have been notified. [REDACTED] want to press charges and agreed to send this through AAP. I sent the AAP referral for processing. Nothing further at this time
