On 5-24-16, School Security and this Unit were called to the 7th grade Girl's Locker room. There was a report of three stolen phones and two stolen headphones. The P.E. teachers held the entire class. School Security searched every student and their locker. While this search was being conducting a female student (██████████), told this unit that this student named, (██████████), had two phones in the front of her pants and that she walked out of the locker room once she heard the P.E. teachers calling for security and the SRO. This unit was able to locate (██████████), see case # 20161450210.

This unit continued to follow up on this case on 5-25-16. This unit spoke to (██████████) (7th grader) and she first stated that she had no idea about any stolen phones. Her second story was that she only took a pair of headphones (which she pulled out of her pocket and set them on the table). She stated that three female students were present in the locker room when she stole the headphones (██████████). Her third story was that (██████████) gave her a Samsung phone out at the buses and that she took it home and her older brother took the phone from her. The fourth version she stated was that on 5-24-16 after 3rd period P.E. she went on to her 8th period class. Once in class she got a pass from her teacher to use the bathroom. There is a bathroom two doors down from her classroom but she claims that she saw, (██████████) down the hallway, and (██████████) waved at her to come and meet her. (██████████) and asked her, "where is (██████████)?" (██████████) says, "here" and pulls out a Samsung phone in her back pocket and (██████████) noticed a Rose Gold iphone in her front waistline. (██████████) gives (██████████) the Samsung phone and says, "Don't trip" and walks away.

I spoke to (██████████) on 6-1-16 again because this unit found a witness who saw (██████████) with the Samsung phone in the locker room on 5-24-16. According to this witness (██████████), she observed (██████████) with the stolen Samsung in her pocket in the locker room while Security was conducting their search. (██████████) also told (██████████) "Don't tell anyone." (██████████) final version she stated that she observed (██████████) steal a rose gold iphone and a Samsung phone. While both girls (along with two others) were in the locker room unattended, (██████████) gave (██████████) the Samsung phone. (██████████) knew the phone was stolen but chose to keep it. (██████████) found a locker that was open and hid the Samsung phone underneath a pair of shorts when this Unit and Security were at the other end of the locker room. When asked to open her locker she did, but there was no phone. She grabbed the phone back out of the locker was Security walked around to the next student. When (██████████) was outside the locker room getting a pass to class from one of the P.E. teachers, (██████████) came up to (██████████) and said, "Did you tell (██████████) anything?"
