On 5-13-16, (7th grader) made the following comment on the school bus in the morning "I have a gun in my bookbag." The bus driver overheard this comment. The bus driver told Security once she arrived at school. The principal called for this unit to search the student. There was no gun in the bookbag, however the student had three cell phones in his posession. This unit then notified AP of the situation so they could follow-up. During the investigation stated the first phone (white iphone 5) was his sister's, the second one (silver iphone 6) he found over at Walt Whitman, and the third phone (also a white iphone 5) his mother purchased for him. During the AP's investigation it was discovered that there were several nude photos and other inappropriate videos on two of the phones. parents were notified and the AP handed the cell phones over to this unit.
