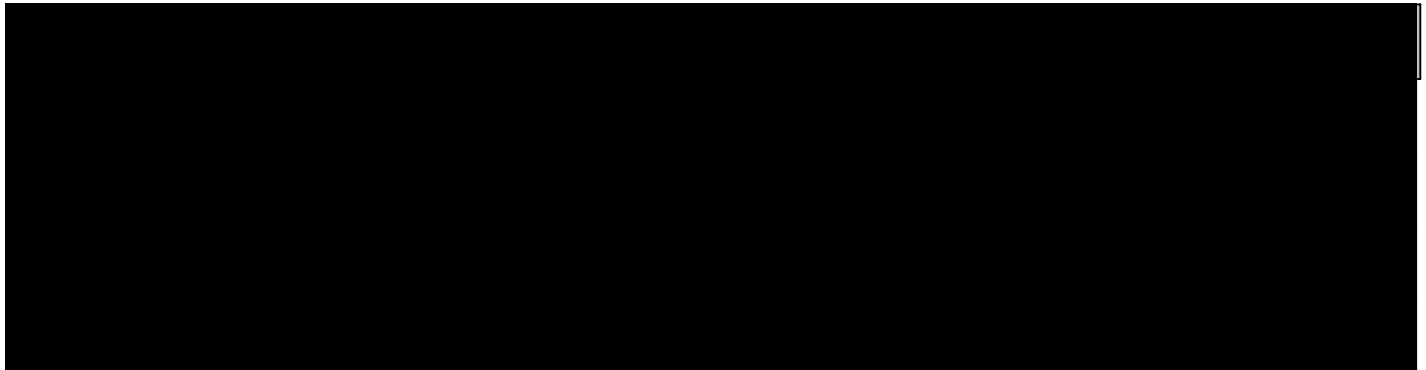

Notes/Narratives

On 6-21-16, this unit was notified by Security that there was a West Potomac HS student walking around the building without permission. This student, [REDACTED] is a 9th grader and he has a brother, [REDACTED], that currently attends Sandburg. [REDACTED] to the front office around 0730 hours with [REDACTED] (front office staff) recognized [REDACTED] and he was told to leave the building because the principal does not want any HS students walking around the building while classes are in session. [REDACTED] chose not to listen and walked out of the office and into the building. Security was looking for [REDACTED] all around the building for about two hours. Eventually the principal located [REDACTED] and turned him over to Security. Security then brought him to this unit's office. [REDACTED] claims he did not know he could not be in the building. He said he walked around to see his brother and old teachers. Two other teachers told him he could not just walk around the building and redirected him back to the front office. [REDACTED] again did not listen and kept wandering around and also spent some time in the restroom.

The principal wants to press charges. While in this unit's office, [REDACTED] called his father at 1010 hours. The father was notified of the trespassing charges and he responded to the school around 1100 hours to pick his son up.

This report was sent to Intake for processing. Nothing further at this time.
