On 07/27/2016 I responded to Springfield Healthplex for a report of an assault. Upon arrival I met with the victim, [REDACTED] and his father [REDACTED]. According to [REDACTED] his son is 15 years old with [REDACTED] and has a hard time communicating. [REDACTED] usually attends Lee High School but is attending Sandburg for the summer. [REDACTED] advised me that today at approximately 1515 hours he was contacted by the principal at Sandburg, [REDACTED] does not know his name, asking that he come pick his son up. [REDACTED] responded to Sandburg where he was advised by the principal that his son was assaulted. [REDACTED] told me that his son was sitting in class when another student approached him from behind and put his arm around [REDACTED] neck and started to choke him eventually pulling [REDACTED] the ground causing him to hit his head. The school nurse looked at [REDACTED] but no other [REDACTED] was then released to his father. [REDACTED] then began complaining of [REDACTED]. [REDACTED] decided to take him to [REDACTED] [REDACTED] was seen by [REDACTED] who determined he had a [REDACTED]. It was decided that [REDACTED] would be transferred to [REDACTED] due to the nature of his [REDACTED].
