



I responded to lobby of the Mt Vernon Station reference an assault complaint. Once there I spoke with a [REDACTED] and her son [REDACTED]. [REDACTED] stated to me that she had just left the [REDACTED] having him checked out due a fight that he had in school "Sandburg Middle School" earlier in the day. [REDACTED] wanted me to speak with [REDACTED] and take a report on the event that took place with her son. I spoke with [REDACTED] who stated that at around 12:50pm he was walking down the hall to his next class when he passed another student. The student ran towards a group of five students that was standing together and stated that "that's him ...that's him". One of the students named [REDACTED] came up to [REDACTED] and started pushing him. According to [REDACTED] then threw a punch but missed, another student named [REDACTED] and also threw a punch and he too missed. [REDACTED] then grabbed [REDACTED] trying to slam him to the ground. As [REDACTED] was falling to the ground he grabbed onto [REDACTED] and pulled him down with him.

While on the ground [REDACTED] began punching [REDACTED] in return threw punches back in an effort to defend himself. [REDACTED] stated while he was engaged with [REDACTED] joined in and began punching him also. About this time [REDACTED] who is a teacher at the school came along, notice what was taking place and separated the three. [REDACTED] stated that he left and went to his 5th period class and later was removed from his class to speak with the [REDACTED]. [REDACTED] stated that he and [REDACTED] was suspended for the incident but [REDACTED] was not. [REDACTED] is upset because it was revealed that [REDACTED] is upset because [REDACTED] as a result of the fight. [REDACTED] want advise on what to do far as clearing her son from any fault since he was jumped and should be considered a victim and a partaker in the incident.

I advised [REDACTED] to speak with the school administration "principle" along with the SRO officer, [REDACTED] about her concerns and what steps to take in clearing [REDACTED] name. TOT to [REDACTED] Sandburg Middle School.

Supplement Notes

I also met with the victim's mother this morning and spoke with her about the incident. After I completed my investigation, I emailed the victim's mother and explained to her I do not have enough to charge the other student with assault. I provided the phone number for South County if she wanted to speak to an Intake Officer. I also referred the victim to his counselor. Nothing further at this time.
