Notes/Narratives

I responded to Carl Sandburg MS, for a report of a destruction. Upon arrival, I met with school security and the assistant custodian supervisor [REDACTED] stated he was cleaning the hallway area near door number 14, when her heard a bang type sound. [REDACTED] did not notice anything out of place and could not see if anyone was outside due to exterior lights being off outside. When [REDACTED] began his exterior security checks, he observed that the glass window pane on one of the doors was shattered with a tiny hole in it.
