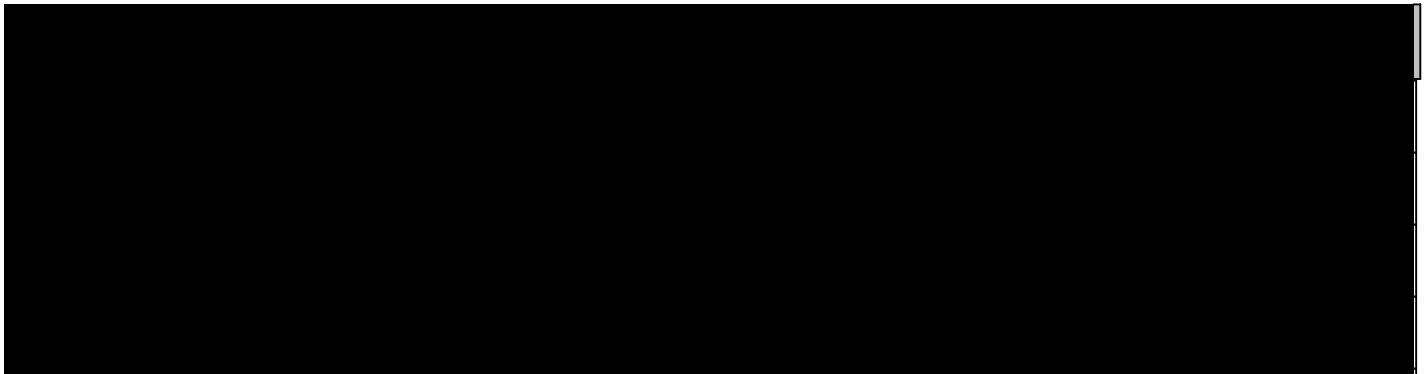

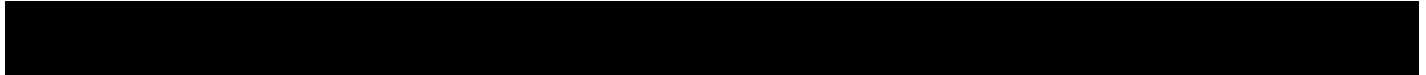

On 11-2-16, this unit was informed that an assault took place in the clinic around 1015 hours. [REDACTED] moved to this area around [REDACTED]. According to the [REDACTED] suffered about 10 years of physical and emotional abuse from his birth [REDACTED] has good and bad days at school. Today, [REDACTED] did not want to go to class, kept trying to leave the building, and not following any adult's directions. [REDACTED] would not calm down for anyone or explain what is going on. [REDACTED] called home to have a parent come and pick [REDACTED] up from school. While waiting for [REDACTED] to come to the school, several administrators and counselors tried to get [REDACTED] to calm down and moved him to the clinic. Once [REDACTED] arrived at the school he was directed to the clinic. [REDACTED] what is going on and he would not answer his questions and kept trying to walk away from [REDACTED]. Two times, [REDACTED] put his hands on his shoulders to push him back so he could not leave the clinic. Then [REDACTED] put his hand on his throat and shoved him into the wall, causing his head to hit the wall. Before anyone was able to check for [REDACTED]. This unit was not able to speak to [REDACTED] before he left the building to go back to work.
