## 2020 Annual Use of Force Summary

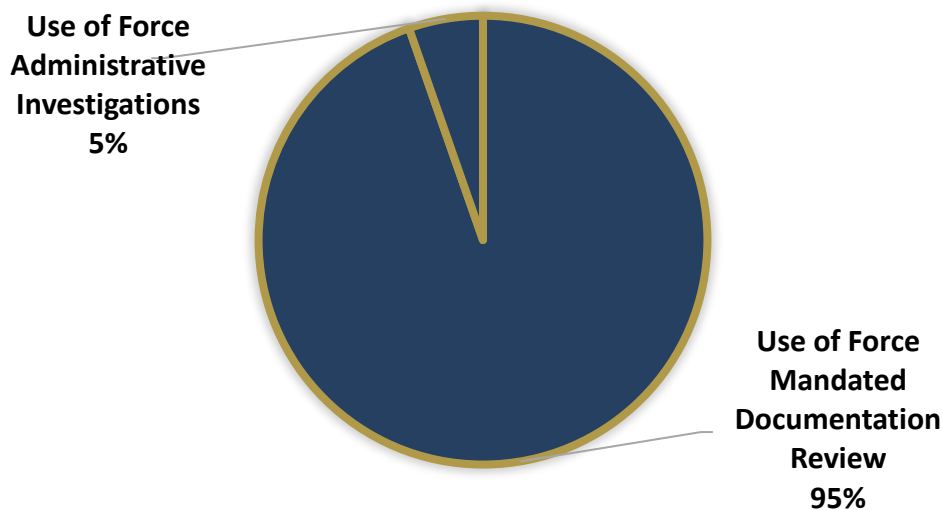

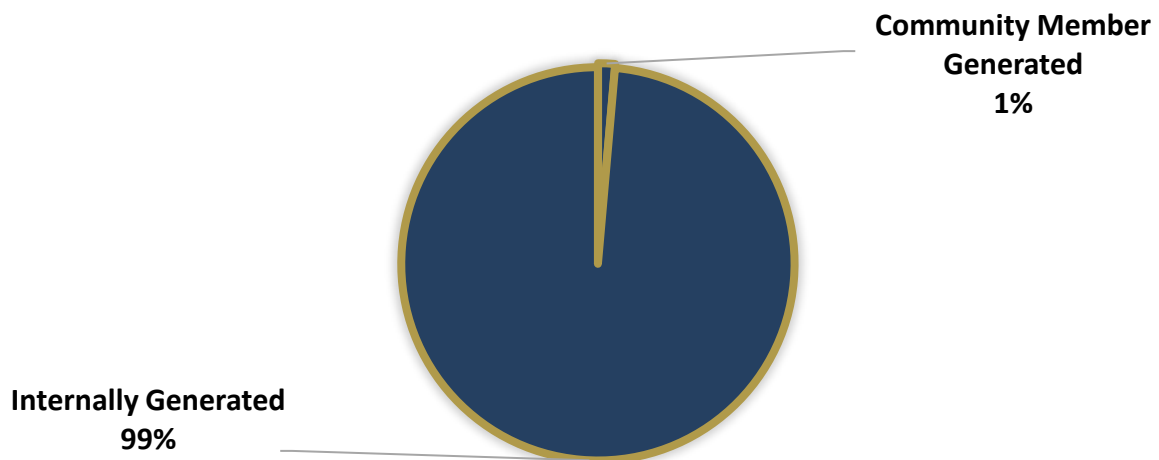

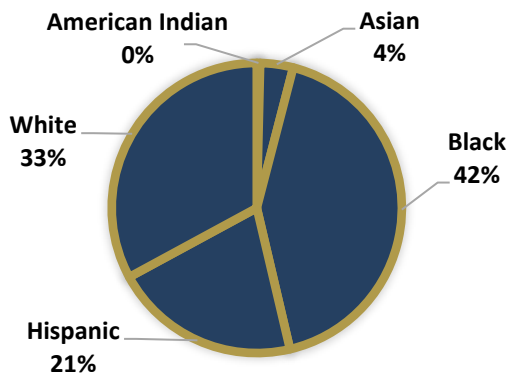

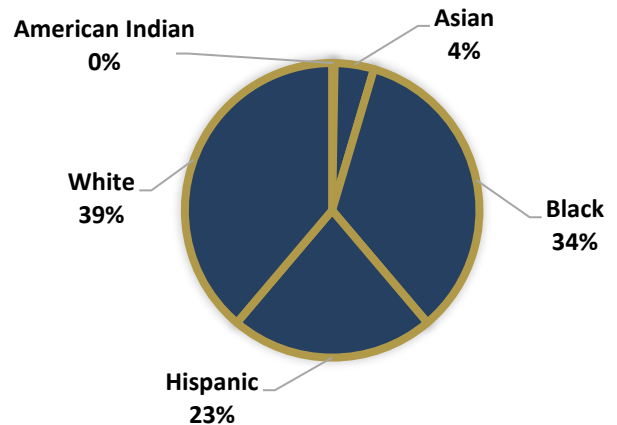

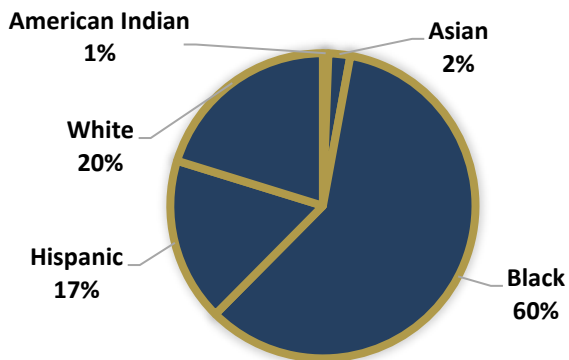
**Use of Force by Community Member Race**



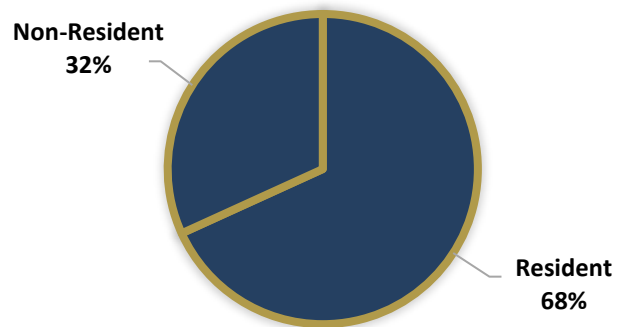
**Use of Force by Community Member Race (Resident)**

**Use of Force Incidents Resident vs. Non-Resident**

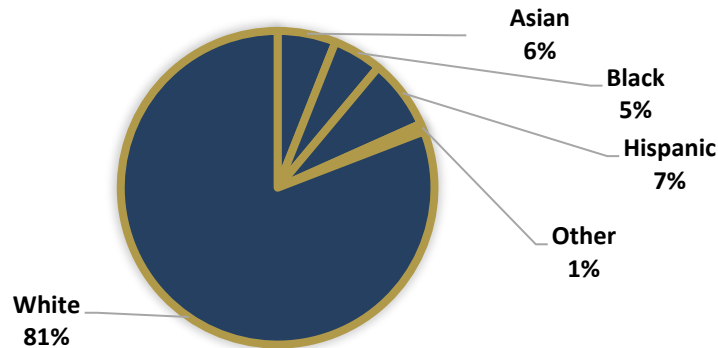

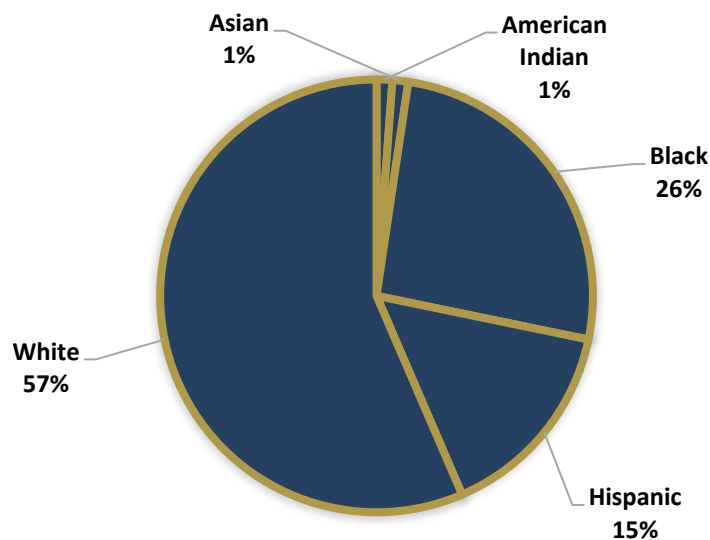

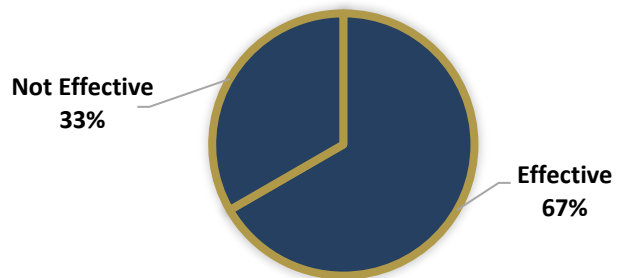

**2019 Effective ECW Usage**



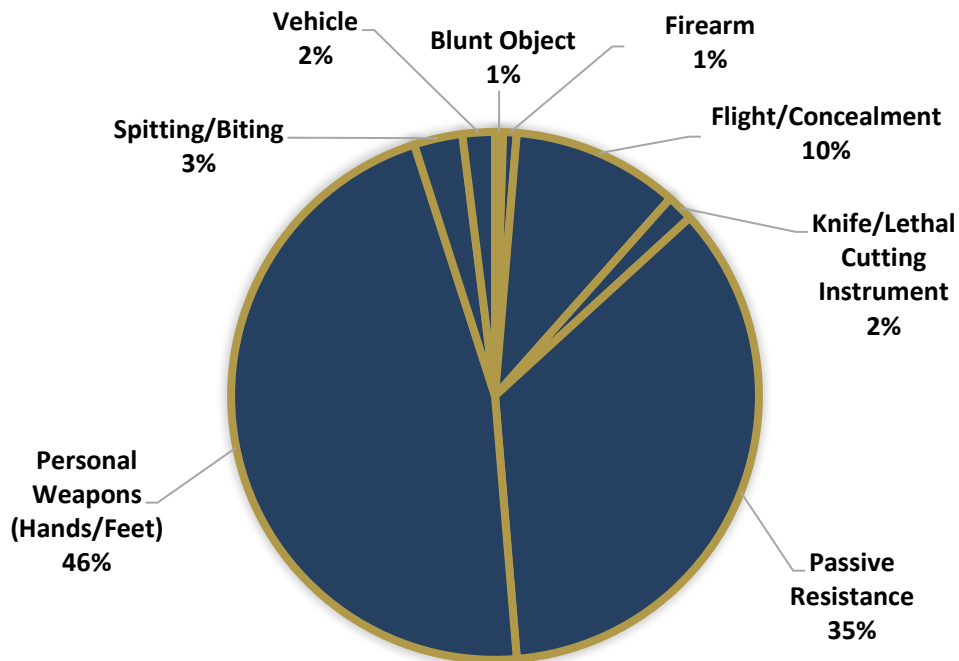
**2020 Effective ECW Usage**

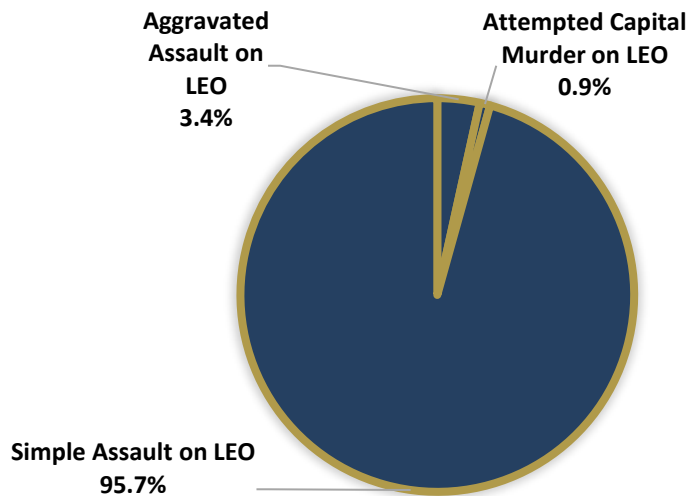
## 2020 Assault on Fairfax County Law Enforcement Officers

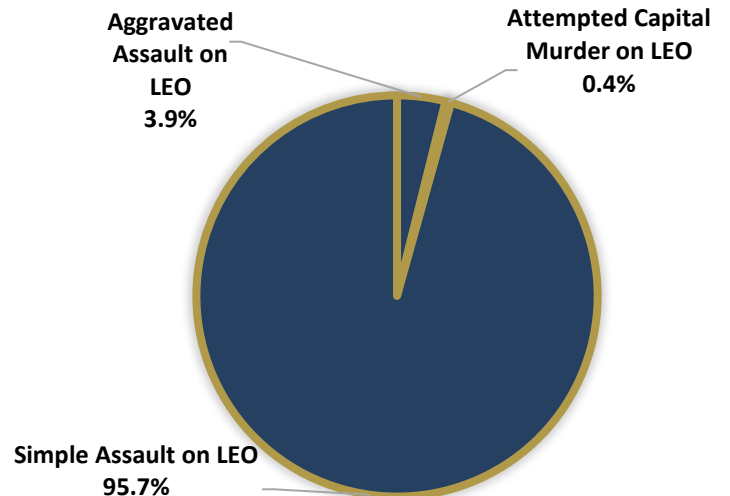

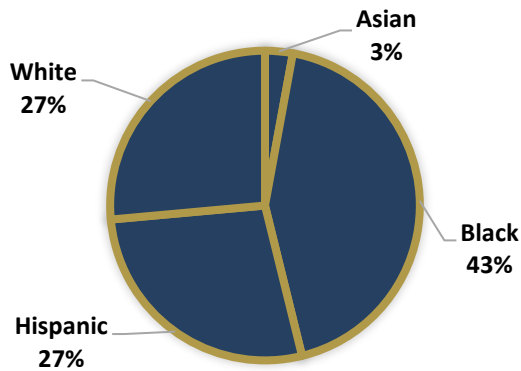

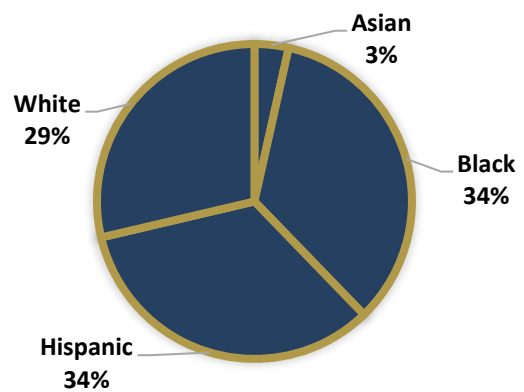

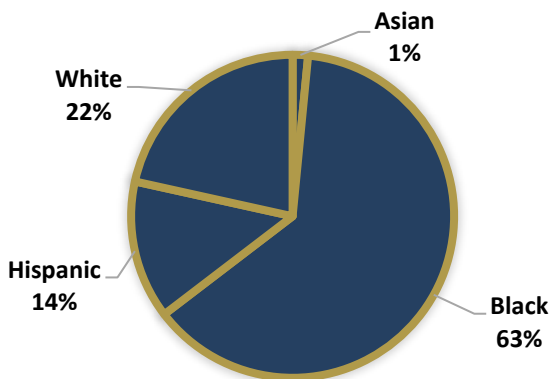
**Assaults on FCPD LEO by Race**



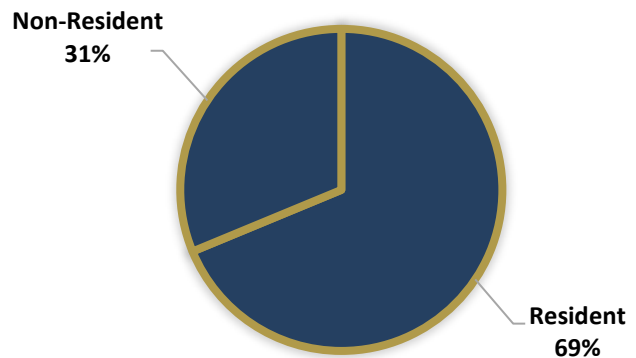
**Assaults on FCPD LEO by Race (Resident)**
