

FCPD 2021 GROUP A OFFENSES

Crime Against Persons are calculated based on the number of victims.

Crime Against Property and Crimes Against Society are calculated based on the number of events.

IBR Offenses captured in this report exclude Disposition Unfounded.

**The population used to calculate the Crime Rate is 1,170,033. The population total is from the 2021 Demographic Report produced by the Fairfax County Economic, Demographic and Statistical Research unit.*

The CY2021 IBR categories which cover all types of reported crimes are:

- Crimes Against Persons (**increased by 2.7%** from CY2020)
- Crimes Against Property (**decreased by 3.6%** from CY2020)
- Crimes Against Society (**decreased by 32.0%** from CY2020)
