#### **Constitutional Policing Conference**

As noted in the May 4, 2023 Executive Director's Report, this office along with our counterpart, the Independent Police Auditor, Richard Schott, as well as our neighboring oversight practitioners in Alexandria and Arlington, participated in the Institute for Constitutional Policing's Constitutional Policing Conference. Topics specifically germane to the work of our body were: Implicit Bias, Police Training, Pre-Textual Traffic Stops, Warrior or Guardian, What's Constitutional Policing, Constitutional Legitimacy, and Objective-Reasonableness-Legal-Fiction. I've included three of the presentations in this evenings handouts.

#### **Outreach**

In continuing our collaboration with the Office of Immigrant Community Affairs on our comprehensive outreach to the County's robust and growing Spanish speaking and immigrant communities, we have been invited by the 2<sup>nd</sup> Story non-profit organization at their sites in Fairfax and in Culmore to hold upcoming monthly Panel meetings. Additionally, the County's Office of Public Affairs is working with us on a new Spanish language brochure. Channel 16 is developing a Spanish language public service announcement to augment our outreach and a draft script is forthcoming.

As the County prepares to celebrate Juneteenth, this office was given the honor of participating on the Juneteenth Advisory Committee and will be supporting those youth being recognized with Resiliency Awards during the Board of Supervisors monthly meeting on Tuesday, June 6, 2023 in the Board Auditorium at 9:30 am. Our office will also be supporting the Gum Springs Community Day on Saturday, June 17, 2023 at Martin Luther King, Jr. Community Park and the Annual Juneteenth Soul Food Lunch and Learn at the Historic Site on June 19, 2023, at 3650 Historic Sully Way, Chantilly, VA 20151. All Panel members are encouraged to attend.

#### **Training**

In collaboration with the Office of the Independent Police Auditor and various County partners, we have produced a mandatory training plan. The goal is to equip Panel members with the insights and nuances of the criminal justice continuum and to add to the legitimacy of Panel reviews, recommendations and calls for expanded authority. A timetable for implementation is yet to be determined, however the training has received the full endorsement of the Chairman of the Board of Supervisor's Public Safety Committee, Supervisor Lusk. Additionally, we have been in discussion with former General Counsel for the National Organization of Black Law Enforcement Executives, Marcia Thompson, on producing Team Building and Strategic Planning recorded training modules (more information to come).
