### A Successful Event!

Our 1<sup>st</sup> Annual Police Civilian Review Panel (PCRP)/Community Reception was a resounding success! In partnering with the Fairfax County Office of Neighborhood and Community Services we were able to bring out more than 100 individuals for our inaugural event! We have received feedback from a variety of community groups interested in hosting our future meetings and helping us with attendance. Additionally, our event has created enthusiasm with regards to opportunities to partner with other County agencies to build bridges between our Public Safety agencies and the community. We are also looking to engage the faith community in our outreach efforts and will be partnering with the County's Interfaith Coordinator towards that goal.

#### **Training**

According to National Association of Civilian Oversight of Law Enforcement (NACOLE) Past President, Brian Corr, the Oversight Training held on November 12<sup>th</sup> went very well. I am told that those able to be in attendance were engaged in learning how to approach the awesome responsibility of Police Oversight and Review.

For our next training, we are working to bring back attorney, Marcia K. Thompson, Esq.in February for round two of her much-needed Team Building and Strategic Planning Training.

In addition, this office will be working with the Office of the Independent Police Auditor (OIPA) on a series of training modules for the Panel. The goal is to better equip the Panel to review Internal Affairs Bureau (IAB) files by familiarizing participants with a more nuanced understanding of policing, the laws of arrests, patrol functions, etc. Creating this curriculum with further enhance our credibility with the community and with the Fairfax County Police Department (FCPD).

### **Outreach**

Tonight's meeting, at the James Lee Center, is yet another step in our outreach efforts.
