SUBJECT: Executive Director's Report

Staffing

The Police Civilian Review Panel, Office of the Executive Director is now fully staffed and functional. Our Management Analyst, Sanjida Lisa, began her tenure on September 26th, 2022, and is already proving herself to be an outstanding asset to the Panel's efforts.

Training

On Saturday October 1st, 2022 the Panel had its first, in a series of trainings that this office is organizing, to effectuate Chairman Hargraves' vision of establishing a "best in class oversight body." The session was facilitated by attorney Marcia K. Thompson, Esq., who brought her vast experience in law enforcement and strategic planning to bear in helping the Panel take a look back at its genesis, evaluate its current operation, and brainstorm on ways to move forward and to maximize the work of the Panel. Each Panel member in attendance got an opportunity to voice their perspective, ask questions, and to give input in an open and thought-provoking forum. Everything from the Panel's historical context to the intricacies of reviewing racially sensitive, or otherwise nuanced, cases were discussed, as well as allowing Panel members a moment of reflection and introspection, and a chance to articulate what they uniquely bring to the Panel (their superpower). We hope to bring attorney Thompson back, before the end of the year, for a follow up session.

Our next training with be held on Saturday, November 12th, 2022, from 9am-4pm, at the Pennino Building, located at 12011Government Center Parkway, Room 200. This will be a Civilian Review and Oversight training conducted by past National Association of Civilian Oversight of Law Enforcement (NACOLE) President, Brian Corr. The training will focus on the crux of the Panel's mandate and equip Panel members with ideas and concepts on how to approach case reviews.

Outreach

To bring further awareness of the Panel and to brand this body as an entity established for "the people," this office is finalizing two locations for this year's remaining public meetings. We have been offered the usage of the Gum Springs Community Center, located at 8100 Fordson Road, Alexandria, VA 22306, for the Panel's November 3rd, 2022 public meeting. Gum Springs is the oldest African-American community in Fairfax County, and it would say a lot about the Panel to be a visible presence in that historical community. I will be visiting the location on Monday morning, October, 10th, 2022, to access whether or not the space meets the requirements to host a Panel public meeting. Once confirmed I will notify the Panel via email. Additionally, I am awaiting a meeting with one of the County's Imams in the hopes of confirming their willingness to host the Panel's December 1st public meeting at a Muslim community center. More information on this matter to follow.
