All bidders shall comply with <u>Article A-21, Fairfax County Construction Safety of Resolution, Information for Bidders</u>. Bidder's request for determination of eligibility to bid must be received by the County no later than fourteen (14) days before bids are due in accordance with Article A-18. E of Section A, Information for Bidders. A determination of eligibility may be requested only if a Bidder is subject to conditions in Article A-21.C of Section A, Information for Bidders.
