## **Transparency**

- Commissioner Reniker provided an update in finding data on regional small business spend in place of Commissioner Freund
- The Fairfax County Economic Development Agency (FCEDA) publishes business data, but the committee has found that it generally pertains to overall business and not small businesses
- Action Items:
  - Commissioner Reniker will research with the data provided by the Business/Professional/Occupational Licenses (BPOL) to show how many small businesses exist based on NAICS codes
  - DPMM to check with the Department of Tax Administration on what information from the BPOL can be released publicly
  - DPMM to ask the FCEDA whether a statistician or data analyst is available to provide a report to the SBC
