Context

Fairfax Recycles Day is Nov. 15, 2023 - SWMP typically runs a contest.

This year we asked Fairfax County residents for feedback on any recycling information they have received from their trash collector (what SWMP and collectors know as the 4TP).

Survey was promoted on Social Media and elsewhere.

Survey was on SWMP website from Oct 3 - 30, 2023. We received a total of 568 responses from residents across the county.

Incentive: public acknowledgement on Nov. 15, as well as a small gift.

About one-third of respondents said they received info in 2023 (n=568)




Of the 388 respondents who said "No"/"IDK" regarding info received in 2023, only 65 said they had EVER received information from their current collector.




Type of information received and its helpfulness




Type of information received vs preferred
