Changes offered.

- Section #4 title to take out the 'or's' except to put 'and/or' at the end.
- Section #4 various grammar edits
- Section #4 agreed to strike "including long term maintenance plans"

In its Annual Report, the Tree Commission indicated to the Board of Supervisors that it would be forwarding recommendations on how to prioritize Strategy #12 (Natural Resources) to the Office of Environment and Energy Coordination (OEEC) which is working on an implementation plan. On this subject, staff has invited OEEC to give the Tree Commission an update on that timeline at the February meeting. ### **Unfinished Business**

On February 5, 2021, a letter agreeing to move the Tree Commission Charter from Article 19 to Chapter 122 was voted on, approved and sent to the Board of Supervisors. Attached to the letter was a proposal for re-writing the Charter. Commissioner Speas asks Commissioner Peters and Commissioner Healy to continue to accept comments/suggestions.

Commissioners will continue discussion on the Charter at the February meeting.

# **Directors Update-Brian Keightley**

Infill Land Development Improvements: preserving large trees on lots that are less than a quarter acre is a challenge but can be done. Approximately 7,000 s.f. lots are where large tree preservation is nearly impossible. Brian has been tasked with working on things that can be done administratively regarding proposal of off-site trees and development. The BOS can make changes to the County Code or Public Facilities Manual within the scope of state enabling legislation.

FYI to the Tree Commissioners that all UFMD staff are 24/7 Emergency Service Personnel. UFMD Staff responds to weather emergency events-storms, snow, etc.

2022 General Assembly Bills: House Bill 311 asks state agencies to prioritize the use of native plant species on state properties.

EQAC Report: Tree Commission recommendations from September 2 and in our Annual Report to the Board of Supervisors were embedded in the EQAC report to the Board.

#### **MOTION: Revised Friends of Trees Awards language**

A Friends of Trees Award recognizes efforts made for **exceptional**, **outstanding**, **and innovative** conservation-based tree actions in Fairfax County that do one or more of the following:

- a. Protect and preserve existing trees and associated habitats
- b. Increase Fairfax County's tree canopy and their related natural habitats
- c. Educate and inspire people to plant more trees and properly maintain them, as well as to convey an understanding of the importance and benefits of trees.

#### **Nominations Categories:**

#### 1. Individual volunteer

e.g. an individual who has provided extraordinary unpaid leadership in conceiving and implementing a tree-related project (see a, b, or c above).

#### 2. Non-profit group or business

e.g. Scouts or other youth groups or clubs, "Friends of" groups, faith community properties, HOAs and Citizens' Associations, county agencies and/or facilities.

#### 3. For-profit company

e.g. corporations or other businesses, HOA management companies, commercial nurseries, landscaping services, office park and property managers.

In the above categories 1-3, a nominee must have demonstrated outstanding, innovative, and exceptional conservation-based actions to preserve trees, to plant trees, to have demonstrated outstanding property maintenance best practices, and/or to engage in a uniquely designed educational program about the importance and benefits of trees. The projects must utilize natural landscaping principles based on using regionally appropriate native species. **NOTE:** priority shall be given to projects that 1) preserve native plant communities, remove non-native, invasive species, and use appropriate pruning and mulching practices and/or 2) that are actualized in underserved communities.

#### 4. Developer, builder, project arborist, and/or landscape architect

A nominee must have demonstrated before, during, and after a project an extraordinary commitment to conservation-based actions to preserve and plant trees above and beyond Fairfax County development requirements. The project design must show preservation of the maximum

number of suitable trees possible, given the existing resources and site constraints. During construction, the project must demonstrate a commitment to installing, maintaining and honoring of tree protective devices to achieve the planned preservation, as well as replacing trees that were unavoidably harmed or destroyed due to development. After implementation, design and planning must include a commitment to tree conservation by choosing the most suitable species based on post-development conditions and providing for the long-term survival of all preserved and planted trees through best practices, including long term maintenance plans. NOTE: priority shall be given to plans that 1) use regionally appropriate native species and utilize natural landscaping principles, and/or 2) design to maximize energy conservation opportunities, and/or to provide specific air and/or water quality or wildlife benefits.

#### **Calendar:**

Nominations will be solicited year-round, with **deadline COB July 1**, followed by Tree Commission voting in the fall. A nominee whose project is exemplary, but who does not win a Friends of Trees Award for exceptional, outstanding, and innovative conservation-based tree actions, may be eligible for a recognition certificate.
