







- Waiver of required minimum size allowed with School Board approval.
- School Board Policy states that the minimum size of school sites shall be in accordance with the Virginia State Board of Education Planning Manual.
- For a vertical or urban school model, reduced acreages may be acceptable.

How Big Is a School Planned?

• For new school buildings, School Board Policy 8120.3 provides the preferred maximum sizes, absent any extraordinary circumstance

Elementary School	950 students		
Middle School	1,350 students		
High School	2,500 students		

• The capacity of a school building shall be determined by the educational program to be housed.

How Many Students Come from Mid-/High-Rise Multifamily Buildings?

- Student Yield of Existing Students coming from Existing Housing Units.
- Calculated countywide.
- Last updated June 2022 Reviewed and updated periodically.

Is There a Need for A School in Reston?

Additional Potential Student Yield, using current yield:

- 2,757 ES
- 713 MS
- 1,382 HS
- Over the next 25+ years
- Assumes a total of 18,716 housing units in Reston

FCPS Needs:

- One new elementary school in the Town Center North District
- One new elementary school in the Central Sunrise Valley District
- One new middle school to the west of Reston, potentially in the Innovation Center area
- One new high school to the west of Reston, potentially in the Innovation Center area
- Capacity enhancements at existing facilities

What is Considered in a School Site Location?

- Public Facilities section of the Fairfax County Comprehensive Plan Policy Plan provides guidance on sites for schools including but not limited to:
 - Safe and convenient accessibility to pedestrian and road networks, and transit
 - Areas conducive to pedestrian traffic
 - Locate schools in relation to residential or mixed-use areas, the road network, traffic patterns and transit
 - Proximity to other public facilities, such as police and fire and rescue services, public parks and libraries

Does FCPS Consider Co-location with Other Facilities?

- Public Facilities section of the Fairfax County Comprehensive Plan Policy Plan provides guidance on sites for schools including but not limited to:
 - Coordinate with the Fairfax County Park Authority and other agencies to ensure maximum opportunities for co-location and efficient use of recreational and other facilities
 - Consider co-location of different levels of education and other types of programs, with the
 option of shared facilities such as cafeteria, gymnasium, auditorium, library, and administrative
 offices
 - Consider co-location of schools with other public uses such as a library or a recreational center
 - Provide space for other public service needs, when possible and reasonable, in underutilized schools
