- One set of comments, from the Friends of Long Branch Stream Valley, was received on August 25, 2021, but has been added to the other comments received during the public comment period to ensure inclusion.
- A summary of all comments received is attached to this report.
- This summary addresses the comments received. However, during the two public meetings there were also a number of questions asked with responses from elected officials and staff from the county and the project design consultant, Arcadis Inc. Those questions and the responses are compiled in the attached public meeting transcripts.

Comment Summary:

\*Note that quite a few comments supported dredging the lake, but their primary purpose was directed at other topics.

Notes:

The comments primarily centered around not using athletic field locations, and an array of comments that generally support the staff recommendations of use of one of four locations within Lake Accotink

Park and Wakefield Park. There are a number of comments that either promote or oppose the use of one of the four staff recommended sites for spoils processing. At least three comments address project funding. There were also a number of comments that praised the current process.

Based on this public feedback staff recommend:

- Move forward with consideration of the four sites recommended by staff.
- Continue to take into account impact to the following public priority categories when finalizing proposed work locations:
  - Active Recreation & Culturally Significant Sites
  - Environmentally Sensitive Sites with Emphasis on Trees
  - o Trails
  - Communities (to include noise)

The staff recommendations presented to the public during the July 29 and August 5 public meetings are as follows:

- Dredging: Pursue hydraulic dredging with mechanical debris removal.
- Pipeline:
  - Pursue lowest impact/cost pipeline alternative: along CCT, lake perimeter trail or Flag Run/Port Royal Road or Beltway.
  - Retain flexibility during design for permanent and temporary pipeline options.
- Dewatering:
  - Retain consideration for four potential locations during design for maximum flexibility, impact minimization, cost efficiency:
    - Dominion Energy ROW Wakefield Park
    - Settling Basin Lake Accotink Park
    - Maintenance Area Wakefield Park
    - Lake Island Lake Accotink Park

# Lake Accotink Dredging Public Meeting Question and Answer Session July 29, 2021 Annandale High School

### Affiliation: area resident

**Comment:** Hi. My name is Wade. I had a little campsite, a secret garden, really close to the trail. You may have seen me saying "Hi. Please be well." I love all of the people who use the trail – the parents of autistic children, the husband with wives, the toddlers running in front of their parents pushing a stroller. I was there 2008. I saw them expanding the island. I am shocked. I love all of you and I love the park, and I ask you to stand and not allow them to expand the island. Thank you. My name is Wade. Peace.

Affiliation: area resident Question: Is the pipeline to the north or south side of the lake?

**Answer – Arcadis:** The pipeline is on the south side of the lake along the old rail alignment.

### Affiliation: Friends of Accotink Creek

**Comment:** If this information had been available earlier in public discussions, we would have taken a different course. The costs of these options are high and so are the negative environmental, recreational, and community impacts. The existing island with rotation of truck traffic is not a good option, but maybe the least bad. Yes, there is the nuisance impact of park users and vagrants, but they are also the most direct beneficiaries of the lake. We suggest that we begin planning now for a longer term future. That of incorporating the dredge spoils to construct the berm that will enable us to reconnect Accotink Creek and have a smaller, deeper, cleaner, purer Lake Accotink. Further, we citizens of Fairfax County must focus on eliminating the sediment at its source, which is excessive stormwater runoff from our own roads, roofs, and parking areas.

**Question:** Why do you see the gravity dewatering drying agents have such a smaller footprint than the other methods?

**Answer – Arcadis:** The overall footprint for the drying agent does have a smaller footprint, but there are some significant limitations on both the dredging methods that can be used as well as the location that would need to be utilized for that method. For the slurry method, what you end up doing is, to be able to transport it by pipeline, there is a significant amount of water. As a result, it's going to significantly increase your costs. You want to only use the drying agent method when you're using a mechanical dredging option, and then you will have to actually physically transport it with a barge.

That will require the use of location, such as the island. It has a smaller footprint, but it does have some other consequences for it that might not be beneficial.

One of the other things to consider when you're looking at the drying agents is that you're going to add some type of drying agent, such as wood chips. Consequently, there is the potential that the amount of material that gets generated as part of the dredging dewatering process increases due to the mixing in of that drying agent.

**Question:** Can you address possible toxicity or waste creation issues associated with the flocculant or the drying agent?

**Answer – Arcadis:** All of that would be tested. Based on the testing that we have done, all of the sediment has met multiple test options and shown that there are no contaminants. By either adding a flocculant or the drying agent, there would be no toxicity added to them.

It would, depending on type of drying agent you use, such as wood chips, help absorb the water. There are other methods that would generate a little bit of heat that would help evaporate the water, but that wouldn't change the overall disposal characterization.

**Question:** The flocculant itself is not something that would turn into any sort of plastic waste-type material?

# Answer – Arcadis: No.

# Question: Is it biodegradable?

**Answer:** Yes. There would have to be additional studies and contractors may have specific brands that they use, but, whenever a flocculant is added, there's always a monitoring component that's associated with it. So, all the water would be collected and confirmed that it meets all the criteria for being returned to the lake.

**Question:** Why does this route that we are seeing for the upper settling basin pipeline follow the trail rather than taking a more direct route from the lake directly to the location?

**Answer – Arcadis:** The reason that we did that was mostly to help with the elevation change. It's a little more gradual. So, if you were going to do something more direct, there is potential for needing more pumps, bigger pumps to overcome that elevation distance.

# Affiliation: Friends of Lake Accotink Park

**Question:** How much is the pipeline going to cost? Is there a ballpark figure per mile or per hundred yards or anything?

**Answer – Arcadis:** At this point in time, it's too early to say, because there are a number of factors that would go into pipeline cost. It's too early to provide an answer to that, but that's certainly something we'll be getting into this fall.

**Answer – County Staff:** Arcadis initially looked at a permanent pipeline because this has to go into the operation and maintenance cycle. The most expensive alternative we have looked at so far is the ductile iron pipe, which is actually buried. We will also look at a temporary pipeline, which could potentially be able on the surface. This could be a lot cheaper, but you have to install it and remove it.

**Question:** Years ago, when this all got started, there was talk of helping pay for it through a loan from a state agency of up to about \$30 million at a rate of about half a percent. Is that still a viable option?

**Answer – Braddock District Supervisor:** That is still the financing mechanism, and the Board approved an application for an additional \$30 million with an additional application. The mechanism is through the Virginia Water Quality Revolving Loan Fund, which is about 1% and the cheapest rate you can find.

Question: How many companies will be bidding on this?

**Answer – Arcadis:** This is somewhat specialized work. There are contractors in Virginia and throughout Virginia that do this type of work. A project of this size and this type of work will also attract interest from contractors across the country. It's difficult to pinpoint how many companies will be interested, but I expect there will be a considerable about of interest in a project like this across the dredging community.

Affiliation: Canterbury Woods subdivision

**Comment:** I endorse the statement of the Friends of Accotink Creek. I was one of the 10% who was not in favor due to the financial implications. In my opinion, we should be returning the creek to its original state. The sediment problem, in my view, could be dealt with through good watershed management and water land management.

**Question:** We have no idea what the various costs of the alternatives are. Is there going to be a subsequent opportunity when there is more certainty over the different costs of the alternatives, where we can come back in and provide input? Are we looking at immediate costs and long-term costs?

**Answer – County Staff:** Yes. As the process moves forward, we will have more certainty in terms of costs. I don't think that there are dramatic differences in costs between the different alternatives that we've seen, but absolutely, we will be coming back to the community with more certainty in terms of costs, and we will be going back to the Board of Supervisors with more certainty in terms of cost.

# Affiliation: Danbury Forest Community Association

**Comment:** Everybody here, we all have one thing on common – we love Lake Accotink. We walk around it. Sometimes we fish in it. We kayak in it. It's a bigger thing than any politics. John Cook, over there, supported it. James Walkinshaw supported it. I love both of you guys. I love the neighborhood. I love the lake.

**Question:** In 1967, six young men from Fort Belvoir were putting up a flagpole at Howrey Field and were struck by lightning. It has significance, but what I can't comprehend is some people are putting up these signs that say, "No mud at Howrey Field." What sense does that make? There's a neighborhood that borders Audrey Moore and Howrey Field. Where do people get the idea that we're going to dump sludge there?

**Answer – County Staff:** I think that the concern was that we did look at that as an option. We would have essentially had to take over the whole park and turn it into a processing area. That's where the concern arose, and we definitely heard that concern. As a result, from a staff perspective, we've recommended to remove Howrey Field from consideration as an option.

# Affiliation: North Springfield resident

**Question:** Are there any long-term plans, like 5 or 10 year projections? It seems to me that we have an every 20-year project that seems to be costing millions of dollars, which doesn't seem sustainable. Are we considering doing something different? In 20 years, are we going to sitting in this auditorium asking the same questions? Is anybody considering more sustainable options, given that climate change is real, and we should be trying to restore our natural landscapes rather than continuing to keep up manmade issues.

**Answer – Supervisor James Walkinshaw:** Absolutely. We don't want to be here in 20 years having the same conversation, and it probably would be sooner than 20 years given the rate of the sedimentation that we're seeing. We don't want to be having the exact same conversation 10 years from now. That's why part of the analysis part of the process is potentially the installation of some permanent infrastructure to allow smaller, shorter term dredges to take place.

I think your real question is what are we doing to prevent the sediment from entering the lake in the first place? And that's a county-wide challenge, a regional challenge, and a national challenge. In this watershed, though, we actually have a lot of projects that have been completed and major ones that are coming up to restore some of the streams and to reduce the amount of sediment. We have a significant project coming up in Long Branch that flows into the lake, ultimately to try to improve that watershed and reduce the amount of sediment that is entering the lake. The reality is that it is not going to happen in time to prevent this lake from filling in, and it's not going to solve the problem entirely.

Part of the challenge is that many of our neighborhoods, including mine, Ravensworth Farms, and yours in North Springfield, were built at a time when there were no stormwater management requirements. Consequently, every drop of rain that falls on your roof and my roof hits the driveway, goes right into the storm sewer, and directly into the lake.

We don't allow building like that to take place anymore. There has to be systems to control stormwater. Most of the communities in this watershed, however, were built when these stormwater requirements didn't exist. A gentlemen suggested solving this problem with better stormwater management, and we have to do that, but the reality is there's no feasible way to go back in and retrofit 50 to a 100 years-worth of development that didn't have real stormwater management.

This is the situation we are in right now, but we do have projects upstream of Lake Accotink that, hopefully, will reduce the problem. You're absolutely right. Climate change is making this worse, because we do know that the storms we're seeing now are stronger than the storms that we saw 10 or 15 years ago. We would still be dredging the lake with or without climate change, but climate change is shortening the amount of time between dredges.

**Answer – County Staff:** We actually have done work in the Accotink Watershed, and we have a lot more plans. We are completing our fourth stream restoration in Wakefield Park. We have stream restorations that have been completed as well as installation of low-impact development structures and solar controls in Nottaway Park into Vienna all the way down into the mainstem of the Providence District, coming off of I-66 and Route 29 and along Prosperity Avenue. We have several in the Braddock Area and the Mason District. In Danbury Forest, the stream restoration design is complete, and we should start construction in about a year.

We have a lot of projects. The one that James referred to – Long Branch – is our most unique project yet. The entire subwatershed drains directly under Braddock Road, past Howrey Park and Wakefield Chapel Road. We are planning the restoration of the entire subwatershed. It is specific that we meet the state mandated goal to reduce the sediment load to meet the total maximum daily load (TMDL) requirement. That is a heavy lift effort for us, and we are excited to work with the community on that.

Your point is very well taken. We are trying to restore the system as best we can. One of the parts of Long Branch that is important is that we're working with multiple communities to do things in the watershed, because private property is where the water is coming from. That is one of the most exciting parts is how do we work collaboratively and take a holistic approach to the watershed and try to reduce the impacts to the system.

**Affiliation:** Ridgewood Farm resident and Board of Directors for Friends of Lake Accotink Park

**Comment:** Thank you to Supervisor Walkinshaw and Supervisor Cook for your efforts in preserving this lake. I am 100% behind this effort.

**Question:** What is to become of land masses and islands in the lake during the dredging process or will the dredging simply remove sediment from low areas covered by water?

**Answer – Arcadis:** There are some sections where, since the 2008 dredging event, the sediment deposits are now above the water surface. Some of those are targeted for removal but the actual island will remain. The focus is on the areas below the existing water. During construction, the plan is that all of the dredging would be done in the wet, so the water level would generally remain at its same elevation and the material would be removed so that it wouldn't expose the island or drain the lake during construction.

**Answer – County Staff:** The island was actually created during the 2008 dredging event and was part of the mitigation requirement of our permit. We actually monitored the island for several years. As Amanda said, under most scenarios, the island would remain as is – as a mitigation site. If we used the island, we would have to mitigate for that impact, which would be another scenario.

Affiliation: Mid-Atlantic Off-Road Enthusiasts (MORE) liaison and Springfield representative to the Trail Site, Cyclists, and Bikeways Committee
Comment: We support off road trails and natural surface trails around the county and around the region. I appreciate the coordination with the community so that we know what's going on and are standing by to help in rerouting for groundwork.

I wanted to mention that, with the north right of way dewatering concept, there are road drains off 495 that you're going to run into or they're going to run into you. That's going to be a very difficult area to work in. Plus, you've mentioned several times the difficulty of getting up and down that hill, I wanted to make sure that you try and drive the truck up and down that hill before you commit it.

Thank you. We look forward to continuing working with you to make sure things at the CCT stay open for commuters and that the trails stay open for recreation.

Affiliation: Friends of Long Branch Stream Valley and resident of Stone Haven

**Question:** I thought I heard that the analysis didn't have the weighted categories, and I was just curious why the weighted categories were not part of the analysis.

**Answer – Arcadis:** The objective that Fairfax County made to Arcadis was to look at the technical component and how feasible the different options are. Because there are a

lot of political and social implications, the idea was that, if there is any weighting, that would start coming out as a part of that process.

**Answer – County Staff:** As the president of the Friends of Long Branch, he is one of our lead stakeholders for the Long Branch project. We've just finished up a weighted analysis process for that project. It's kind of a parallel project. As Amanda indicated, this site is a lot different from Long Branch, because Long Branch was focused on specific parameters that had to do with proximity to properties and a lot of different impacts. We were able to create weights. We had significant measurements in the field of things that we were measuring, so we had a lot of data that we were able to use to create these weighted metrics. With the Lake Accotink project, as indicated, we are going with the more technical component of looking at the analysis. We have not done as much in the field analysis. That will occur once we start to select the alternatives. The weighted analysis was not appropriate in this phase.

# Affiliation: not provided

**Comment:** I first want to just thank everybody for being here – from the county, from the park, from Arcadis, particularly our supervisors past and present. We appreciate you carrying the torch for us.

**Question:** I think I've heard the amount of \$30 million since 2016. I might simplifying it a little bit. We might've spent \$30 million since 2016. We've got another \$30 million teed up.

**Answer – County Staff:** We were authorized to apply for loans for \$30.5 million in 2019 and now, because the cost estimates have been refined, we've been authorized to apply for an additional \$30 million. We have not drawn on any of that yet. At this point, the state has approved a \$30.5 million loan that we could draw on or ask them to put an additional \$30 million. We are not obligated to use any of that money. The current money that has been spent on the Arcadis contract has come out of the stormwater funds.

**Question:** Do we anticipate that that will carry us through 2026 and the completion of the project?

**Answer – County Staff:** We're in the process of refining the alternatives analysis. The current estimate is based on what it will cost us to dredge and dewater the sediment spoils and to process them. What we need to refine further is what it would cost us to dispose of that material.

We don't have that nailed down yet. We will go through the design phase during this fall and winter. By next spring, we'll have much better cost estimates. Once we have those cost estimates, we will come back to the Board, and the Board will have to approve any expenditure to the project. **Question:** It seems like you all have spent a lot of money and that you haven't dredged anything.

**Answer – County Staff:** All that we've spent so far is the money on the design contract. We haven't spent any money toward the actual dredging process. We've just gotten authorization to apply for loans.

Answer – Braddock District Supervisor's Office: The 2019 cost estimate was based on removing 350,000 cubic yards of dredge material from the lake. The estimate that we now have from Arcadis is that we'll need to remove 500,000 cubic yards of dredge material from the lake. That has been the most significant driver thus far. There's still a lot of uncertainty, and that's why we'll be coming back to the community and to the Board with a more refined cost estimate.

Affiliation: Parks and Recreation and Committee Chair for the North Springfield Civic Association

**Question:** You mentioned when the gentleman had a question about Howrey Park that it's not the staff recommendation that the park be included as an option. Who is receiving the staff recommendations and who ultimately make those decisions?

**Answer – County Staff:** It's a collaborative process between the Department of Public Works, the Park Authority, the Park Board, and the Board of Supervisors. I think there's close to unanimity among all the players that Howrey Field is not a good option. It's a collaborative decision making process. Ultimately, the Park Authority Board and the Board of Supervisors will be responsible for the decisions that are made.

**Question:** What is the process for the contractor selection, finalizing designs, and public input after this forum?

**Answer – County Staff:** We will certainly come back to you during the different design phases. When we get to the 35% design phase, we will have another public meeting. We'll post the design on the website and it available for public review. We will get your feedback, and we'll probably have some workshops too. We had a walk a couple of years ago with James and the Friends of Accotink Creek. We will do several of those.

The 35% design locks in where we're going to do things, and that's the piece where we get the most community feedback. Going forward from the 35% design, we'll be refining how the project's going to be completed. We will brief you during the design phase, before we go to construction, and toward the end of the project.

In terms of hiring a contractor, all of our hiring processes are defined by the State of Virginia. There are very specific guidelines on how we can contract. We're considering two alternatives. One is called construction management or risk process, and that would mean that when we hit the 35% design phase, we could advertise for and hire a contractor who will then work with us to complete the design and lock in the price for us.

There're multiple advantages to that. You'll get a guaranteed maximum price, and you have a collaborative relationship with the construction contractor, where they can help advise how they would do it. They can also target where they hire people to do the work to make sure it's done in the most effective way. We also may be able to get the project done more quickly. The other alternative is called design/bid build where Arcadis completes the design and permits it. We bid it and get the contractor to do the construction, which is the most common practice the county uses. We're going to weigh that option through the design phase work with our Arcadis and others and determine which contracting method to use.

**Question:** Is passive dewatering included in the timeline? What will the cycle be for the maintenance dredge, especially regarding decisions for the pipeline and the dewatering?

**Answer – Arcadis:** The passive dewatering timeline is accounted for. Although it is passive, the actual sort of sequencing of what construction might look like is that there might be three different dewatering cells where one cell is being actively built as part of the dredging, while one cell is sitting there and dewatering, and the last cell is being loaded out. Based on what we typically see, the waiting period can be as short as 1 week and as long as a month. Based on the information that we have so far, our current assumption is that it will probably be about a 2 week period of each cell.

Between dredging events, in theory, especially with the passive dewatering system, it's a fairly simple process. All of the depressed cell tubes and any of the areas that the tubes will be in will be removed. The base cap underneath it will remain in place. The actual frequency of those events will be evaluated. There is a little bit of a variable as the sediment comes into the lake each time. It depends on a number of different variables, such as if it's a wet or dry year. The idea is that dredging will be on a more frequent basis than every 20 years.

Question: Do we know how often the cycle will be for the maintenance dredge?

**Answer – County Staff:** There's a couple thoughts. As you empty the lake, it becomes more efficient at trapping sediment. The irony is that even though it is shallow, it's not trapping as much. When you dig it deeper, it actually can capture more sediment. We can't know how quickly the lake will fill. We think the sediment is coming into the lake at about 46,000 cubic yards per year. As of 2016, our analysis indicated that the lake was capturing about 50% of the sediment load. It's capturing less now, according to Arcadis' analysis. As we dig deeper, it will capture a larger percentage of sediment, which will mean that the lake will fill faster.

Another variable – we know that Tropical Storm Lee, for instance, 3 years after the last dredge, probably contributed a significant percentage of material that filled the lake in. That one event was dramatic. The other thing that occurred was that 2018 to 2019 was the wettest year on record in our region. We got almost 80 inches of rain. That year probably triggered a disproportionate amount of sediment. The weather patterns

determine a lot, and so we will look at whether we do frequent, smaller dredges or do larger dredges.

**Question:** Wouldn't we want the dam to accumulate as much sediment as possible so that it doesn't end up in the Chesapeake Bay?

**Answer – County Staff:** The issue is the frequency at which you do the exercise and there's a cost implication. We're going to try to get the most efficient balance between keeping that capacity and the cost implications of doing it. But you're correct. We're going to try and maintain that efficiency of that lake system. That efficiency also provides the best recreational aesthetic benefits for the community.

#### Lake Accotink Dredging Public Meeting Question and Answer Session August 5, 2021 Virtual Meeting

#### Affiliation: None provided

**Question:** Thank you for providing this forum. Please don't use Howrey Park for mud processing. As an FCPS teacher, I am aware that our county places an emphasis on equity, and I have to say that using Howrey Park for this project would NOT be consistent with equity.

- 1. The townhome communities bordering Howrey Park are affordable for people like me FCPS teachers and single parents. By putting this industrial zone literally in our back yards, Fairfax County will be forcing us to tolerate more than our fair share of the burden of rejuvenating Lake Accotink.
- 2. Our homes are far too close to the park. This project would be literally in the back yard of New Chapel HOA, as well as some single family homes. My back yard on Overlook Park is 75 yards from the park entrance. The report didn't talk about the relative distance of homes to the proposed sites, but it's an important consideration.
- 3. Truck traffic is not the only impact on homes. I would have not only truck traffic, but an unobstructed view of the mud processing, 24-7. The report talked about 95 trucks per day for certain county residents, but at the end of the day, those residents don't have an industrial site in their back yard. But what about me? I would have 95 trucks per day PLUS live next to an industrial site 24-7, a site that may NEVER regain its current beauty and usage.
- 4. The park has a memorial that honors 5 soldiers who died there. Community members worked hard to improve and publicize the memorial, preserving a significant part of community history. Please don't use Howrey Park for mud processing!

**Question:** Using the island in Lake Accotink as a dewatering site avoids laying a pipeline and taking away land from parks. Barges and trucks would carry the dried silt away. Although this would present inconveniences, it seems the least bad option. What do you think of using the island in this way?

**Answer – Charles Smith:** I think that that's exactly why this was a consideration. This came from Arcadis staff as a potential solution to minimize impacts overall. Although it has potential challenges, it also simplifies some aspects of the operation. I think you're right, and that's why, as a staff, we're recommending that we continue to consider the island option as we move forward.

**Affiliation:** Friends of Lake Accotink Creek **Question:** Can you clarify the nature and footprint of gravity dewatering?

**Answer – Amanda Wood (Arcadis):** As far as what the footprint of the gravity dewatering area looks like, it's pretty much a berm-lined area that would be temporary in nature. There would be an underlying stone pad. That's what it would look like in operation. Then, there would be the

geotextile tubes on top. After they're filled, the material would be removed and transported away from the dewatering location.

#### Affiliation: None provided

**Question:** I appreciate the efforts of the County and Arcadis teams to develop plans for dredging Lake Accotink. It's a complex project, as folks have noted. Why isn't residential impact (noise or truck traffic) listed as a "key challenge" for the Dominion ROW dewatering alternative? What specific analysis has been done to assess the impact of noise in Wakefield Park and in the neighborhoods on the east side of Wakefield Chapel Road? If you live in the neighborhoods on the east side of Wakefield Chapel Road, you know that noise carries through Wakefield Park. The Beltway is loud, and you can hear it more often than one might expect. The dredging project calls for 95 truckloads (round trip) per day, starting at 7 AM on weekdays and 9 AM on weekends for 2+ years of dredging activity.

Answer – County Staff: I think you're correct. This would definitely need to be part of the analysis as we move forward with the design. I think the key is that this alternative, comparatively, keeps the trucks the furthest from any residents, which is the lesser of evils in this case. We need the trucks to pull the material out, which would not be without impact. At first look, this alternative would have a much lower impact than some of the other alternatives but will require more analysis.

#### Affiliation: None provided

**Comment:** Any option that requires the least amount of tree clearing has my vote. Sounds like "keeping it in the park" is the way to go. Trail closures and such are part of the deal.

#### Affiliation: Friends of Accotink Creek

**Question:** Would the Flag Run portion of a pipeline route:

- Be underground?
- Be possible without extensive tree loss?
- Be coordinated with the planned stream restoration or have impacts on the stream restoration?

**Answer – County Staff:** We anticipate the need to carefully plan to minimize impacts to the stream valley. In addition, we have in our work plan, the restoration of that portion of Flag Run from the Beltway to the lake. Last year, we completed the restoration upstream of the Beltway. We hope these projects can coincide – that we can bury the pipeline while conducting the stream restoration to minimize the overall impacts. We will definitely be looking at coordinating these efforts.

#### Affiliation: Friends of Accotink Creek

Question: Could there be an option for a slower dredge to reduce trucks per day?

**Answer – County Staff.** That's certainly something we could look at to reduce impact. We'd have to balance that with costs. There's also a couple of other factors to consider, like trucks per day for a shorter duration versus trucks over a longer duration. What's the trade-off? The other thing to consider is that the lake continues to silt in. The longer we prolong the dredge, the greater the quantity of silt accumulates while we're dredging, which may increase the total

amount of material to be removed. All of these factors would have to be balanced, but they are certainly something to consider.

Affiliation: None provided Question: Is this project fully funded?

**Answer – Braddock District Supervisor's Office:** As you've seen from the presentation, we're still working toward finalizing the cost estimate. We've been approved for application of up to \$60.5 million worth of funds. The commitment that we've made to the Board of Supervisors is to go back to the full Board when we have something closer to a final cost estimate and get approval. I think the answer to that question right now is that we don't know, but we'll be public and transparent as we know more, and any additional funds will be approved by the Board of Supervisors.

#### Affiliation: Friends of Accotink Creek

**Comment:** Fish/eel passage solutions need to become a part of the future life of the dam.

**Answer – County Staff:** We talked about this with the Friends of Accotink Creek a few years ago. We also talked to the State Department of Wildlife Resources, and what we determined, at this point in time, is that the consideration of fish passage is not part of this particular project. We're looking at dredging and not dam modification. We did, however, get some preliminary information from the state experts on fish passages, and it's certainly something we can discuss going forward. We will have to have the community, the Park Authority as the owner, and the State help us with the conversation.

#### Affiliation: None provided

**Question:** Talk more about the relationship between the lake and the Bay. Which option manages the Bay-damaging stormwater best?

**Answer – County Staff:** Of the dredging options, I'm not sure any one is particularly different. Arcadis has looked into the fact that, in order to discharge the water that comes out of the dredge material, we have to treat it. So, I think that the answer is that all of the alternatives would remove a lot of sediment and continue to keep that sediment out of the system below the dam. Amanda, please talk about how you clean the water once you treat it.

**Answer – Arcadis:** Any of the water that gets separated would be required to meet discharge permit requirements. There are other substances coming directly from the geotextile tubes that may be able to be discharged directly. If there's other options, there may be a secondary solids removal phase prior to the water being discharged. The goal would be that the water quality being returned to the lake is at least as good as what was pulled out if not better.

#### Affiliation: None provided

**Question:** Sediment keeps entering rivers from private properties – our yards. Has the county a plan/education outreach for homeowners to keep stormwater on their properties?

**Answer – County Staff:** We do continue to do outreach education. Probably the project that's going to help us with that conversation is also in the Braddock District. It's the Long Branch

Central Watershed Management Area project, which is now underway. It's a partnership with the Park Authority, Public Works, and many, many stakeholders in the Long Branch Central Watershed. This project is looking at, not only what can the county do to stop sediment generation within channels, but also working with the communities to look at strategies to reduce runoff from the uplands along all the private land and to improve quality of life and the natural landscape. Yes, absolutely. That's a critical need and something that, going forward, will be something that's important for all people in the community to participate in.

#### Affiliation: None provided

**Question:** What actions are being proposed to reduce the amount of sediment coming into the lake in the future?

**Answer – County Staff:** I think there are more projects (in Lake Accotink Watershed) than any other drainage area in the county. There are projects in the Providence District, the Mason District, and the majority of them are in the Braddock District. We have some downstream also. We have projects all the way from Nottaway Park, near Vienna, down through the mainstem over to Merrifield and Mantua neighborhood. We have projects at Annandale Community Park, Wakefield Park, Long Branch Central Management Area, and Danbury Forest. We finished Turkey Run stream restoration in Truro several years ago. We're doing a project right now on the mainstem of Lake Accotink and Wakefield Park. We have a lot of activities. We're certainly very committed to that, and as you mentioned, continuing to work with all the stakeholders and trying to cut the loads in the future in terms of runoff and sediment generation.

#### Affiliation: None provided

**Comment:** Despite the Beltway expansion, Wakefield Park is hanging on as a wonderful oasis for County residents and wildlife. The County should think carefully about selecting an alternative that further degrades Wakefield Park to save Lake Accotink ... perhaps temporarily. All Wakefield Park options involve clearing trees and vegetation, disturbing wetlands/RMAs, constructing facilities, shutting down or altering trails, and tolerating an increase of truck traffic and noise over a multiyear period. The Dominion ROW option also takes the project out of the County's control, as Dominion can alter/change requirements. I hope the County focuses on dewatering and pipeline alternatives within the Lake Accotink Park footprint, which, while presenting challenges, will not result in the degradation of Wakefield Park.

#### Affiliation: Friends of Accotink Creek

**Question:** Deterioration of the Upper Settling Basin is currently returning the 1980's dredge sediment directly to the lake. Its failure has catastrophic potential. It must be repaired as a part of this project.

**Answer – County Staff:** I really appreciate the Friends of Accotink Creek bringing this issue to our attention. We will work hard to consider whatever option we do – how we can address that particular issue with the plumbing in the 1980s dredge operation, its current condition, and how we can prevent it from worsening and being repaired as part of this project.

#### Affiliation: None provided

**Question:** Thank you for the great presentation. For the CCT and West options, how long would the trails be closed to recreational and transportation users? What would the final trail look like – paved or something else?

**Answer – Arcadis:** The intent and goal are to minimize any impacts for any trail. It really depends on which option for pipeline alignment is selected. We don't know yet if the pipeline is going to be above ground or underground. We would leave that up to the contractor, but again, the goal is to minimize any impacts or closures. What the expectation would be of the actual trail itself is that the final trail will be similar to what it is existing now, so there wouldn't necessarily be a change from a gravel trail to a paved trail.

#### Affiliation: None provided

**Question:** What is the best medium to provide our "vote" for which methods we prefer based on the information provided?

**Answer – County Staff:** The best method is probably going to be to provide comments online through the DPWES page in the portal. We're taking comments until August 22nd. I do want to reiterate that it's not a vote, and I'm glad you put that in quotes, because we know, with the Park Authority, sometimes we get hundreds and hundreds of comments on both sides of an issue. All of this information will be taken into account based on the comments and based on the kind of input that you're giving us tonight, which is so gratifying to see people caring as much as they do.

#### Affiliation: None provided

**Question:** Will the project go out for bid when ready? How many dredging companies are out there, ballpark?

**Answer – County Staff:** The state directs localities on how we bid projects. We'll likely use one of two methodologies. One is called construction management at risk, where we engage a contractor early, during the design phase, and they help us finish the design and they can often help us do some problem solving. The other option is to complete the design and do a design/bid/build, which is where we go to the end of the design and permitting process and then we put it out for bid.

**Answer – Arcadis:** There are several contractors in the area that could accomplish a project like this, and I think that this is the kind of a project that would attract interest from contractors on a nationwide basis. I think that we expect to see ample interest in a project like this and see a number of bidders respond.

**County Staff:** It's really gratifying to know that more people have joined this meeting. We're up to about 125 people who are participating this evening.

#### Affiliation: Friends of Accotink Creek

**Comment:** The Current Island dewatering site option presents the least negative environmental impact with least sacrifice of trees and habitat. It does present a nuisance factor for neighbors that would need to be managed.

**Question:** Could we have more than one dewatering site? This would mitigate the use trucks disturbing residential areas.

**Answer – County Staff:** That's absolutely something I think we should consider. Maybe the contractor will come up with some different strategies. Arcadis has been very creative in looking at strategies. I think we certainly should consider the possibility. On one hand, it could add a lot of cost and complexity and spread the impacts out and have larger impacts. On the other hand, it potentially could lower the overall community impacts. We definitely should consider it.

# Statement Opposing Fairfax County Potentially Using Citizen-Owned Howrey Park as a "Dewatering"/"Spoilage" Site Associated with Lake Accotink Dredging Project AC89-0009 During Years 2022, 2023, 2024, 2025

#### **Overarching Objection:**

Howrey Park is the <u>only</u> potential "dewatering/spoilage" site that Fairfax County Public Works and Environmental Services team has named that is both a longstanding, Fairfax County <u>youth</u> sports complex and longstanding tragic, <u>historic site</u>. None of the other four potential sites have either of these characteristics. Please see details below.

# 1. Selecting Howrey Park <u>Prevents</u> Longstanding, Supervised Youth Sports Activities; Choosing One Of the Other Possible "Dewatering/Spoilage" Sites Would Not Interfere With Youth Sports.

Public Works and Environmental Services lists non-sports sites as:

- (1) Wakefield Park powerline assessment;
- (2) Wakefield Park forested area along Braddock Road between the park entrance and Accotink Creek;
- (3) Lake Accotink former spoils settling basin next to Danbury Forest along the old railroad grade trail;
- (4) The Lake Accotink island in the middle of the lake.

Surely the locations above are more feasible as "dewatering/spoilage" sites than Howrey Park/Soldiers Memorial Fields because the above four sites do not stop youth athletics.

Annandale North Springfield Little League, founded 1956, and Braddock Road Youth Club, founded 1966, will suffer significantly, given the limited county athletic fields available. Plus, youth league officials constantly hauling athletic equipment to 'make due' fields for four years is costly and burdensome.

#### 2. Selecting A Non-Historic Site Is More Suitable Than Choosing a Fairfax County <u>Historic</u> Site; Such As Howrey.

Why use a Fairfax historic site when non-historic sites are available, as listed in paragraph one above?

Howrey Park became a publicly-known historic site the moment Fairfax County officially dedicated the three <u>memorial</u> athletic fields in the name of the six perished soldiers.

The Ft. Belvoir soldiers' tragic sacrifice – and inspiring idealism -- represents a valued and instructive part of Fairfax County's robust heritage and history. Three soldiers were only 17 years old when they perished. Please see attachment. Age information furnished by United States Department of Veterans Affairs, Office of the Under Secretary for Memorial Affairs, Washington, D.C.

3. Selecting Howrey Park <u>Curtails</u> *Friends, Inc.'s* April 5, 2021 Existing Howrey Park Memorial Enhancement Plan <u>Now;</u> and Also For <u>2022-2025</u>. Howery Park, as a currently listed, potential "dewatering" site, has prevented us from implementing our FCPA favorably-reviewed, four-page architectural site plan. See attachment, please.

The plan enhances the <u>existing</u> flagpole and memorial plaque at a cost of about \$15,000, in privately-raised funds. Source of written April 5, 2021 favorable approval: Fairfax County Park Authority (FCPA), Division of Planning and Development.

On May 11, FCPA retrospectively "deferred" its April 5 favorable review on permitting *Friends, Inc.* to enhance the existing soldiers' memorial. *Annandale North Springfield Little League* and the FCPA worked jointly on creating the existing memorial plaques and flagpole in the mid-1990s.

 Selecting Howrey Park As A "Dewatering/Spoilage" Site <u>Stops</u> Friends, Inc.'s <u>Long-Term</u> Vision For Honoring The Fallen Soldiers <u>Throughout</u> The Park's Infrastructure. This choice prevents, for 2022-2025, Friends, Inc. implementing its draft February 10, 2021 long-term working plan.

The plan would transform the infrastructure of the <u>entire</u> Howrey youth athletic complex from an arguably <u>uninspiring</u> one to an <u>uplifting</u> one, as an honored, dignified, in-perpetuity tribute to the fallen soldiers.

In a March 12, 2021 meeting at the park, Friends, Inc. orally advised four FCPA managers of the existence of its working long-term vision for the entire Howrey Park complex; and offered to furnish a copy.

5. Selecting Howrey Park May Cause The Current Howrey Family to Oppose This Choice. The family has no claim to this public land. But we doubt that Mr. Howrey, a President Eisenhower appointee and former head of the United States Federal Trade Commission, intended Fairfax County to use the site essentially for processing mud for four years. We believe he intended Howrey for the youngsters. *Friends, Inc.* also believes that, more likely than not, the current family would share their patriarch's view regarding the Park's youth/recreational mission.







Friends of Long Branch Stream Valley (FLBSV) appreciate all of the efforts that have been made to ensure a thoughtful and transparent process was developed to evaluate alternative spoil locations and pipeline corridors associated with the Lake Accotink Dredging Project. Additionally, we would like to thank staff for the opportunity to provide comment on the analysis and offer the following comments below for consideration of the project.

1. Comment: Desktop analysis for determining potential wetland and utility impacts when considering alternatives is not adequate. Using GIS applications to identify sensitive areas will not be as accurate as field reconnaissance. Many linear transportation and utility entities (private and public) have gone away from desktop GIS analysis in alternative analysis due to the inaccuracies is GIS analysis versus when field surveys are performed to identify existing resources. Not including field studies in your alternative analysis will inevitably increase the cost of the project as the contractor's cost will be inflated higher than estimated due to increased risk of having to mitigate impacts to unknown resources. Preliminary field studies to field map potential resources is more appropriate to more accurately assess the presence of potential natural and utilities and will ultimately reduce the cost of design and construction of the project.

Question: If additional field studies is not feasible at this point for the alternative analysis, would the County consider performing these supplemental studies as an addendum to the RFP package prior to advertising the project for interested design/build teams to reduce risk to the teams which should translate to a more economical competitive bidding and ultimately less money spent by the County?

2. Comment: Not weighting or assessing the magnitude of impacts such as natural resource, utility and noise will present an inadequate comparison of the prioritization of the alternatives. Noise levels from construction or frequent passing of construction vehicles by a school versus a residential community during school/business hours has a different level of impact. A school in session will have

more people present and present more of a distraction versus a residential community which during standard construction hours will have a diminished presence of homeowners to be impacted by construction noise. Alternatives that will transect through a wetland or forest have a higher impact over clipping the edge of a wetland or forest. Alternatives that will parallel a stream system such as Flag Run have a higher impact level over alternatives that will transect perpendicular through the stream channel. Amount of potentially impacted utilities, type of utilities impacted, cost of mitigation utility impact would affect prioritization of alternatives. Size of a waterline, sewer line or gas line to be impacted affects cost of mitigation or relocation and should be a consideration in the alternative analysis. An adequate alternative analysis should go further than presence/absence in an assessment and measure the preliminary or approximate level of impact to each category to provided potential bidding design/build teams sufficient information for competitive bidding and ultimately advancing a design.

Question: If weighting the level of impact for each category of each alternative is not feasible at this point in the alternative analysis, would the County consider as part of the next stage in the project to more appropriately evaluate and prioritize the alternative considerations in lieu of letting the design/build team conduct these assessments?

3. It's understood that the County doesn't have ROW authority, but consideration of parcel acquisition, easement dedication, land leasing at locations not zoned for residential or recreational use if adequate space is available would greatly reduce impacts to park, residential and other resources as well as reduce cost in materials if these parcels/locations are situated in more favorable alignments and areas. This approach still results in impacts to other resources. However, during an economic environment where landowners of commercial/industrial-zoned parcels are seeing a decrease in demand, utilizing a mechanism to purchase, lease, or dedicate easements on available parcels would be more advantageous to both the County and landowner rather than imposing impacts to natural resources and residential communities because of its construction easement convenience factor.

Question: Aside from the concrete plant, did the County consider other undeveloped commercial/industrial zoned parcels such as along Southern Drive (Parcel 0792 01 0019 and 0794 01 0003) downstream of the Lake or an alignment along the Southern Railroad line to the Washington Gas or Dominion facilities (Parcel 0791 01 0002 and 0791 01 0005) to reduce and minimize impacts to residential communities?

4. Comment: As is with most infrastructure projects, the less of a footprint the project has, the less impact it causes, which translates to a more cost effective and efficient project. Second to minimizing the footprint of a project, prioritization of alternatives should the greatest extent practical avoid bisecting intact natural resources with higher ecological value such as mature forest, forested wetlands, floodplains. Instead, alternatives need to demonstrate that limits of disturbance maximize within practical reason the existence within predisturbed corridors (such as existing trails, utility easements, transportation easements) or are immediately adjacent to aforementioned areas prior to disturbing higher valued resources such as mature forest, wetland and floodplain areas.



The innovation and valued engineering that is proclaimed to be a "benefit" of the design/build project delivery method has proven to more costly to projects and not as beneficial to the environment or community members. The primary objective of private design consultants and construction contractors is not modeled around selecting an alternative that will be the most cost effective for the County or will be the least impactful to the human and natural environment. The primary goal will be to maximize profit in the least amount of time and materials. This project delivery method also tends to put a higher risk on the consultant, which translates to a higher cost to the County. If this project delivery method approach is preferred, the County needs to heavily scrutinize the methodology, data and analysis presented in the alternative and preferred alternative by any selected design/build team to ensure the County's best interests are protected. Prescriptive elements build into the contract for a project may appear counterintuitive in a design/build project delivery approach that valued engineering opportunity to a design/build team. However, it establishes boundaries and protections to ensure the valued engineering is focused towards benefitting the County's and community's interest as well as the environment. Since private industry focuses on profit, fiscal incentives for least impactful alternatives may be a way to incentivize a design/build team to prioritize low impact design.

Question: Would the County consider including prescriptive items such as thresholds for wetland and forest impacts for the selected alternative to ensure protecting the County's human and natural environment is at the forefront of the design/construction considerations. Or Would the County consider including fiscal incentives for a design and construction implementation that demonstrates a reduction in overall impacts compared to the selected alternatives provided by the County?

To summarize, the project team has done a fantastic job with their considerations with the scope of work performed to date, but there may be additional considerations and opportunities to the analysis that may better ensure a more favorable compromise for the project's goals, the Community and the natural environmental.

I read in the Braddock Buzz that Howrey Field Park is under consideration by Fairfax County as the dewatering site for the spoils from		
the dredging of Lake Accotink. If the report is correct, I believe its selection would be a disaster.		
I was living in Kings Park when the 1967 tragedy took place. While not an eye witness to the electrocutions, I saw the bodies of the		
soldiers on the ground from my seat on a metro bus and was shaken to my core by the vision and the unfolding story over the		
ensuing weeks. It was a very dark time for all residents of what is now the Braddock District.		
The soldiers sacrificed their lives so that local boys and girls could play Little League Baseball. The thought that the fields would not		
be available to regional youth for up to five years – if all goes well – is an insult to the memory of those service members. Relatives		
and friends of those killed would be appalled at the callous behavior of the County in disregarding the tragedy.		
We are all aware that the lake needs to be dredged. We are also aware that the sediment that has taken decades to accumulate		
includes the residue of pesticides, herbicides, and many other carcinogenic chemicals. Should these chemicals accidentally leak into		
any of the ball fields, the bike and walking trail, or the parking area, the use of the facilities might be unavailable for their intended		
use for many more years than planned. The related cleanup would have to be monitored by the EPA.

impacts to natural resources and residential communities because of its construction easement convenience factor. Aside from the

As is with most infrastructure projects, the less of a footprint the project has, the less impact it causes, which translates to a more		
cost effective and efficient project. Second to minimizing the footprint of a project, prioritization of alternatives should the greatest		
extent practical avoid bisecting intact natural resources with higher ecological value such as mature forest, forested wetlands,		
floodplains. Instead, alternatives need to demonstrate that limits of disturbance maximize within practical reason the existence		
within predisturbed corridors (such as existing trails, utility easements, transportation easements) or are immediately adjacent to		
aforementioned areas prior to disturbing higher valued resources such as mature forest, wetland and floodplain areas. The		
innovation and valued engineering that is proclaimed to be a "benefit" of the design/build project delivery method has proven to		
more costly to projects and not as beneficial to the environment or community members. The primary objective of private design		
consultants and construction contractors is not modeled around selecting an alternative that will be the most cost effective for the		
County or will be the least impactful to the human and natural environment. The primary goal will be to maximize profit in the least		
amount of time and materials. This project delivery method also tends to put a higher		
risk on the consultant, which translates to a higher cost to the County. If this project delivery method approach is preferred, the		
County needs to heavily scrutinize the methodology, data and analysis presented in the alternative and preferred alternative by any		
selected design/build team to ensure the County's best interests are protected. Prescriptive elements build into the contract for a		
project may appear counterintuitive in a design/build project delivery approach that valued engineering opportunity to a		
design/build team. However, it establishes boundaries and protections to ensure the valued engineering is focused towards		
benefitting the County's and community's interest as well as the environment. Since private industry focuses on profit, fiscal		
incentives for least impactful alternatives may be a way to incentivize a design/build team to prioritize low impact design. Would the		
County consider including prescriptive items such as thresholds for wetland and forest impacts for the selected alternative to ensure		
protecting the County's human and natural environment is at the forefront of the design/construction considerations. Or Would the		
County consider including fiscal incentives for a design and construction implementation that demonstrates a reduction in overall
