



- 4. Proximity to transportation and commercial/retail opportunities.
- 5. Surrounded by residential
- 6. Not owned by BOS Purchase or lease required
 - Other parties interested in site
 - No timeline for possible listing of parcel

The site would require purchase or lease. There is no timeline established for possible listing of the site and other developers have shown interest. The site is not feasible for locating the emergency and supportive housing program.



Meeting Minutes

9:30 Quick Introductions/Roll Call

- Committee Members Present: Keary Kincannon, Josh Delmonico, Ray Novitske, Liz Yap, Erik Rhoads, Dave Levine, Mary Paden
- County staff: Tom Barnett, Vrushali Oak, Danilo Nunez, Tiya Raju, Christine Morin & Nick Rinehart of Supervisor Storck's office.

9:35 Approve minutes/Recap – The May committee meeting minutes are still in the works, will be posted to the website shortly.

9:40 Spanish Community Meeting Recap - Nick Rinehart of Supervisor Storck's office gave a recap of the June 7th virtual community meeting conducted in Spanish. Two interpreters were present providing simultaneous interpretation. 33 people attended, and there were very few native Spanish speakers in attendance.

9:45 Upcoming Community Meetings and Eleanor Kennedy

- Tom Barnett gave an overview of upcoming community meetings and tours of the Eleanor Kennedy shelter upcoming for Thursday. People are still able to sign up. First tour starts at 9 am.

Christine Morin, Supervisor Storck's chief of staff, mentioned that Pam Michelle will be retiring from New Hope Housing effective October 1st.

A reminder was given about the upcoming on-site community meeting: June 29th. The advisory committee was reminded that this was a commitment from Supervisor Storck's April community meetings. The meeting will be set up around the back patio/gravel area behind Hybla Valley Nursery building, planning for speaker/microphone, open Q&A forum.

Supervisor Storck, Tom Barnett, Lieutenant Chambers from FCPD and and Deputy Chief Tom Arnold from Fire & Rescue will be present. Additionally, Tiya Raju and Vrushali Oak from DPWES Capital Projects will be present.

9:50 Alternate Sites Considered - presentation given on alternate sites proposed in Mount Vernon (6 sites considered). Danilo Nunez, project manager for DPWES, reviewed evaluation criteria as part of presentation of potential sites.

Christine mentioned that the Lee District sites are on hold, County staff is still gathering information on the Lee District sites, per request of Supervisor Lusk. Staff also reiterated that Supervisor Lusk wanted to be present with the advisory committee to share those.

Concerns were raised about the evaluation criteria. Some felt they seem very nebulous, not very detailed, making it hard to have an analytical discussion.

DPWES staff clarified they were considering both supportive housing and emergency shelter on alternative sites, but are also considering separating these components, however it would be inefficient.

10:20 Questions/Discussion with Committee

Some committee members emphasized concern that the timing of the build-out was not included in site evaluation criteria. That should be considered. In addition, committee members felt County staff needs to consider what's best from residents in considering co-locating supportive housing and emergency housing.

Some committee members also concerned about the timing with bond referendum, and if there was a deadline to use that money. Tiya Raju of DPWES explained there are timelines on bond money, but this project is still within the timeline.

Tom Barnett gave an overview of his experience with shelter & supportive housing. Tom indicated that they're not located directly next to single family homes, but there are shelters next to condos/townhomes, apartments, etc. Same lessons learned in these other scenarios would apply here, but willing to speak to residents to learn new lessons.

Committee members asked what lessons were learned. Tom Barnett explained that staff started to regularly meet with nearby residents and keep open lines of communication to quickly resolve any disputes that come up. An example of Gregory House on Gregory Lane was given.

Committee members stated that the community involved in other shelters could speak to advisory committee in July or August meetings.

Proposed next meeting:

Committee agreed to have next committee meeting on July 16th at 9:30 am. Meeting topics will include: Q&A on site selections, follow up on site tours, possibly Lee sites, and presentation from Karla Bruce on Equity implications of the project.

10:40 Q&A with community callers

An example of issues with supportive housing/group homes was cited in Belle View units owned by the county for group homes cited for lack of response, concerns expressed about the same thing happening on Beacon Hill Road.

Letter from Bucknell Manor resident was brought up. This letter claimed that Fairfax County was not considering One Fairfax and not considering equity, was placing another shelter in a community with a higher minority/working class population. County Staff agreed with the committee to address this by Karla Bruce, Chief Equity Officer for Fairfax County, in July meeting.
