


Graphic of the I-95 Energy/Resource Recovery Facility Showing Waste Processing Flow






VICINITY MAP -- I-95 ENERGY/RESOURCE RECOVERY FACILITY

Municipal Solid Waste Landfill Locations



VICINITY MAP -- I-66 LANDFILL






VICINITY MAP - BAILEY'S CROSSROADS LANDFILL





VICINITY MAP - LORTON FURNACE ROAD LANDFILL






VICINITY MAP -- CRIPPEN STUMP DUMP, INC.


VICINITY MAP -- E&R DEBRIS LANDFILL


VICINITY MAP -- FRANCONIA ROAD DEBRIS LANDFILL
