

Certification of Wastewater Discharge From Commercial/Industrial Businesses to the Fairfax County Sanitary Sewer

In accordance with Title 40, Part 403.8(f)(2) of the Code of Federal Regulations, Fairfax County is required to identify, locate, and evaluate industrial and commercial users of the sanitary sewer that discharge wastewater with the potential to:

- Cause an interference with the publicly owned treatment works (POTW);
- Pass through the POTW, inadequately treated, into receiving waters or the atmosphere or otherwise be incompatible with the POTW; or
- Expose POTW personnel and the public to health or safety hazards.

This form **must** be completed to help us understand your facility's wastewater discharge. A wastewater discharge permit and/or pretreatment of wastewater may be required if any of the above characteristics exist.
