HEADS UP FOR EMERALD

ASH BORER AND DYING TREES



This is an alert from the Fairfax County Forest Pest Management Branch about an impending tree mortality caused by an exotic, invasive insect, the emerald ash borer (EAB).

Look for ash trees on your property. These trees are infested with emerald ash borer. EAB will kill ash trees within three years of infestation. Many ash trees in Fairfax County have already succumbed.

Ash trees become very hazardous once they die, as branches may randomly fail due to brittle wood. It is important to recognize this issue and manage it proactively.

WHAT IS FAIRFAX COUNTY'S ROLE?

Urban Foresters provide information and advice to homeowners who have ash trees on their property that are infected with EAB. The county manages EAB infestations on public land by treating ash trees with a systemic insecticide known as TreeÄge®. Upon request, county urban foresters give presentations to organizations such as homeowner or community associations or garden clubs.
