Retiree Payroll Fraud

Mr. Yeatman described recent fraudulent activity regarding his Fairfax County Retirement benefit check that was deposited to a different bank. Mr. Weiler explained the new protocol for confirming retirees have initiated changes. Mr. Pietsch shared that the Finance Department calls all vendors when bank information is being changed. Ms. Schafrik confirmed that HR does the same.

Deputy Director Position

Mr. Weiler said the Deputy Director position has not yet been advertised due to salary scale updates. Ms. Schafrik confirmed that if the request is submitted by September 23, then the posting would be next week, and the new scale would be used.

Public Meetings Guidelines

Mr. Weiler provided the FOIA Public Meeting Compliance chart. It is for informational purposes only and includes addresses as well as times for posting agendas to the public website.

Governance Articles

Mr. Weiler referred the Board to several articles in the agenda, from Funston Governance Advisors, which address the fiduciary duties of trustees.

Measuring Public Pension Health

He also talked about the Measuring Public Pension Health article which describes different ways to measure the health of pension plans. It is more than just looking at funded status. The actuarial status and the fiscal status of the government need to also be considered.

Mortality and COVID

Mr. Weiler reviewed an article that discusses COVID-19 and the Short-Term Impact on Future US Mortality article. Mortality rates changed due to COVID-19. This is considered a short-term impact and will affect lifespan until about 2030 when the excess mortality number near expected levels.

Future Agenda Items and Board Requests

Mr. Weiler referred the Board to the Future Agenda Items and Open Board Requests.

Actuarial Valuation

Ms. Liston and Ms. Taylor, both from Cheiron, provided the Actuarial Valuation for FY 2022. Ms. Liston gave a historical review of the ERS and then Ms. Taylor reviewed the current statistics. The actuaries presented an option that would lower the required County contribution slightly. To-date, any remaining actuarial liabilities have been effectively amortized over 14 years. The proposed change would extend the amortization period to 15 years, which is the Board-approved assumption.
