Administration/Benefit Matters

Retirement & DROP Applications

Mr. O'Carroll moved:

APPROVE ALL RETIREMENT AND DROP APPLICATIONS

Mr. Bitner seconded the motion and the motion passed unanimously.

The active DROP participant was noted for the record.

Deputy Director/Chief Operating Officer

Mr. Weiler gave a brief update on the Deputy Director/Chief Operations Officer position. He asked for members of the Board to consider volunteering to be on the interview panel. The timeline was estimated that the interviews might occur in October for a start date in November. Mr. Krause indicated an interest in being on the panel. Mr. Weiler anticipated the advertisement to be included in Pensions and Investments, on the National Association of State Retirement Administrators (NASRA) website, and in other national publications.

Cost Estimate for Increasing Police Officers' Core Hours

Mr. Weiler reviewed the letter from Cheiron regarding the possible cost increase if police officers' core hours are increased. There was a brief discussion about whether there would be an actual cost associated with this increase because there are currently 138 vacancies and the county is not currently contributing for those positions.

A summary list of proposed benefit changes was noted for the record.

DRAFT Board Policies

Mr. Weiler noted that draft Board policies were included in backup materials, for the Board's review. These have not been shared with or reviewed by the County Attorney's office and will not be until after the Board has reviewed and commented on them. The intent is for these policies to compliment and underly the Board's bylaws when they are finalized.

Board Requests and Follow-ups

Mr. Weiler referred the Board to the lists of open and completed Board requests, as well as the list of future agenda items.

Mr. Dooley requested that a second trustee position to represent retirees be considered for the Board. Major O'Carroll noted that there are currently three trustees to represent active employees and one trustee who represents retirees, yet the population of the PORS now has almost as many retired members as active officers. It was also noted that the Fairfax County Police Board of Trustees is smaller than the other two Fairfax retirement boards. Mr. Weiler noted that this change will need to be presented to the Board of Supervisors as part of their 2023 legislative process and then be enacted in state legislation.

Mr. O'Carroll moved:

TO INCREASE BOARD MEMBERSHIP TO INCLUDE A SECOND RETIREE REPRESENTATIVE.

Mr. Bitner seconded the motion and the motion passed unanimously.

Mr. Harold mentioned that, in the past, the Board member's terms were listed on the agenda each month. Staff agreed to find a way to post the members' terms in the agenda each month.
