Administrative Matters

Mr. Dooley moved

Mr. Bitner seconded the motion and the motion passed unanimously.

Changes to Handbook re: handicapped child terminology

Mr. Weiler explained the out-dated use of the word "handicapped" and said the term will be replaced with the word "disabled."

Deputy Direct Hiring Update

Mr. Weiler acknowledged that the process is taking longer than expected; however, the classification has been approved and the position can now be advertised. It is expected to be advertised on the County website as well as in other public forums.

Disability Medical Services

Mr. Weiler briefly explained the historical process for evaluation disability retirement applications and reevaluations. He suggested that the new process would use an outside firm so that medical reviews would be contracted. This will not be initiated until the Deputy Director position is filled.

Position Upgrades to Manager Positions

Mr. Weiler confirmed that classifications to several manager positions have not been made since the late 90's and the managers are currently in DROP. He is reviewing and updating the classifications they it will be accurate when these positions are advertised in the near future.

Diligent Community to replace DiligentBoards

Mr. Weiler announced that Diligent Community will replace DiligentBoards. It is a better program for public entities and will make the backend process easier. It will also be accessible without a web browser which will be easier for the Trustees to access.

Consolidated List of PORS Benefits Changes

Mr. O'Carroll explained the importance of updating the spousal benefit. Removing the limitation to provide for a spouse only would be more accepting of a diverse workforce and would prevent discrimination. He referred to the language that VRS uses.

Mr. O'Carroll spoke about the subsidy for health insurance premiums that is currently paid when a retiree is age 55 or older. He acknowledged that this is an issue that affects Human Resources but believes that it should be offered at retirement regardless of the age of the retiree.

2022 Actuarial Valuation: Salary Increases

Further review is requested to confirm the reported 15% average salary increase is accurate.

Collective Bargaining

Mr. Weiler confirmed that collective bargaining is ongoing. He noted that the pension has not been excluded and could be a part of the collective bargaining down the road. Mr. Krause questioned what the effect of collective bargaining that included the pension would have on the PORS members who are not part of the collective bargaining unit.

Meeting Calendar for 2023

Mr. Weiler submitted proposed dates for board meetings in 2023. The board members will review and discuss next month.

Financial and Member Statistics

Mr. Weiler presented financial and member statistics for the fiscal year ended June 30, 2022. When the new DiligentCommunity website is ready, we will include links to interactive versions of these reports.
