Domestic Violence Awareness Month

October is Domestic Violence Awareness Month, and at next week's Board of Supervisors meeting, I'll ask my colleagues to join me in rededicating ourselves to the important



work of ending domestic violence in Fairfax County. Domestic violence is a family, community, and public health issue with enormous impacts. The ripple effects of domestic and sexual violence spread to all parts of our Fairfax community, and it will take all of us working together to build a safer Fairfax County. One in four women and one in ten men will experience sexual, physical, or psychological violence from an intimate partner in their lifetimes. Additionally, nearly all domestic violence survivors face financial abuse, creating an increased risk of violence and adding obstacles to safety.

As Chair of the Fairfax County Council to End Domestic Violence,

I'm proud to say that incredible progress is being made by organizations that are part of our coordinated community response.

- In FY23, Fairfax County police responded to more than 3,700 domestic violence related calls, including 357 calls through the lethality assessment program.
 - There were 253 strangulation charges, and 45% of homicides were domestic violence related.
 - The Inova Forensic Assessment and Consultation Team conducted 377 exams, and the County's 24-hour hotline received a monthly average of 150 calls.

These numbers are hard to hear, but it is likely that they would be higher if not for the excellent work happening across the County and community to create safety for victims and survivors and accountability for those who cause harm.

Together, we can eliminate the attitudes, stigmas, environments, and policies that enable domestic violence. We can reduce our acceptance of violence, reject practices that place girls and women at risk, and confront gender and racial injustices. Individually, we can also take steps during this Domestic Violence Awareness Month to be visible and vocal in supporting programs that promote peaceful conflict resolution, healthy relationships, and equality in our interpersonal relationships. Fairfax County offers many resources dedicated to serving those who have been affected by domestic violence and educating the broader community.

Lord and Lady Fairfax Awards

This week, we honored two amazing Braddock District residents at the Lord and Lady Fairfax Awards Program, Shari Zamarra and John Rephlo. Both have a long history of service to our community, and I was honored to recognize them!

Shari has lived in Northern Virginia since 1969, she originally hails from the Midwest. She has devoted her time to various organizations, including the Girl Scouts, her Sorority's Alumni group, Gabriel Project, Fairfax Partnership for Youth, and Faith Communities for Action. Additionally, Shari holds positions on several boards and committees, such as the Community Action Advisory, Braddock Land Use Committee, the Board's Affordable Housing Advisory, and FCPS' FLE Curriculum Advisory. She is currently chairing the Board of Toward Educating America's Children, which supports educational opportunities for children in Guatemala. Shari has a heart



for youth and families, particularly immigrants, and is passionate about recycling.

John has been an integral member of the Braddock District Land Use and Environment Committee since its inception. Serving as Vice Chairman and Chairman, he has guided

members through detailed examinations of Comprehensive Plan amendments and site plans. His leadership helped ensure that the best interests of the residents are included in the decision-making process. For 25 years, Mr. Rephlo volunteered for the Boy Scouts of America, receiving the prestigious Silver Beaver Award for his dedicated service. He has been an active member of the West Springfield Civic Association.

This Monday is Indigenous Peoples' Day. Here are a few reminders:


- The Fairfax Connector will operate its holiday weekend service on Monday. See routes on the **Connector's website**.

Early Voting is Happening Now!

Early voting for the November 7 election is underway.

In addition to the school bond referendum, ballots for Braddock District residents include elections for the House of Delegates, State Senate, County Board of Supervisors, School Board, Commonwealth's Attorney, Sheriff, Clerk of Court, and the Northern Virginia Soil and Water Conservation District Board.



You can vote early in person at the Government Center (12000 Government Center Parkway, Fairfax) at the following times:

- **Saturdays** (October 28, November 4) 9:00 a.m. 5:00 p.m.
- **Sunday** (Only October 29) 1:00 5:00 p.m.

On October 26, 13 additional <u>early voting locations</u> throughout the County will open, and will remain open until Sunday, October 29.

Installation of new playground at Lake Accotink Park!

The Fairfax County Park Authority (FCPA) has completed the installation of the playground at Lake Accotink Park, including the spreading of mulch in the play area.



A walk-through inspection took place earlier this week to determine what final adjustments were needed to the equipment and play area. Funding for this project was made available thanks to a budget request by Supervisor Walkinshaw in the Fiscal Year 2023 Third Quarter Review process.

Task Force on the Future of Lake Accotink Update

The Task Force on the Future of Lake Accotink held its sixth meeting on October 2. Craig

Taylor, a Hydraulics and River
Rehabilitation Specialist with consultant
LimnoTech, gave a presentation on
potential options for Lake Accotink.
Topics included whether managing the
lake as a wetland is a viable or
potentially desirable option, whether a
managed wetland option could include
open water area(s), and how the dam
could be incorporated into a managed



wetland option. Mr. Taylor discussed the features, amenities, and benefits different types of managed wetlands could provide.

The three subcommittees created to explore topics in more detail provided updates on their progress. Those groups are the Subcommittee on the Value of Lake Accotink to Lake Accotink Park and to the County, the Subcommittee on Impacts of and Issues with the County Staff Recommendation to Not Dredge, and the Subcommittee on Options to Consider Other than Traditional Full Dredging. The subcommittees are continuing to meet separately through the fall to analyze, review, and discuss their topics.

The next meeting of the full Task Force will be held on Monday, November 6, at 7:00 p.m. in Conference Room 11 at the Government Center. Consultant LimnoTech will provide an update on their examination of the questions posed by the community and Task Force. The subcommittees will provide preliminary reports on their findings in preparation for a final Task Force Findings Report to be formalized on December 4.

Meetings are open to the public and interested community members are welcome to attend to observe the Task Force's work or live stream the meetings on <u>Channel 16</u>. October's Partial Solar Eclipse

An annular (ring-shaped) eclipse, also known as a "ring of fire" eclipse, will take place on October 14. The annular eclipse takes place when the moon is at its farthest point from Earth. It appears smaller than the sun and does not completely cover the sun, which results in a ring around the edge.

FCPA has prepared for extraordinary eclipse viewings throughout the County. Join experts to view the partial annular solar eclipse at one of three locations:




- Burke Lake Park (7315 Ox Road, Fairfax Station) from 12:00 2:00 p.m.
- Sully Historic Site (3650 Historic Sully Way, Chantilly) from 12:00 2:00 p.m.
- Historic Huntley (6918 Harrison Lane, Alexandria) from 11:30 a.m. 2:30 p.m.

Enjoy games, activities and demonstrations while waiting for the eclipse and at noon, watch as the moon partially eclipses the sun as they travel across the sky. A limited number of eclipse-viewing glasses and sun-spotting scopes will be available to view the eclipse at each location. Entry fee is \$10 per person at all locations, <u>register today</u> to secure a spot.

Update on the Solarize NoVa Program

The Northern Virginia Regional Commission (NVRC) and their local government partners, the Local Energy Alliance Program, and local solar installers recently shared data on the


impact of the Solarize NoVA program. Here are some of the results:

1. From 2014 to 2021, 9.4% of all new arrays in Northern Virginia were the result of the Local Energy Alliance Program.

- 2. Nearly 1 in every 10 solar arrays in the region were the result of the Solarize program.
- 3. The program through 2022 has resulted in 690 contracts for 6.2 megawatts of solar with a private sector investment of nearly \$18 million.
- 4. The arrays produce enough renewable energy to offset 6,220 tons of CO2 on an annual basis.
- 5. One local solar installer has grown from 100 employees four years ago to slightly more than 300 in 2023 as a result of the volume of work they are receiving including from the Solarize NoVA program!

Compliance Corner

Fitted Vehicle Covers – With falling leaves, cooler temperatures, and winter weather coming, you may decide to protect your vehicles with fitted covers. The Zoning Ordinance has regulations about vehicles under cover. Here is information to help keep you in compliance:

- On lots located in Residential Zoning Districts and residential areas of Planned Districts, up to two vehicles can be stored outside under a fitted cover.
 - Additional vehicles may be kept outside on the lot, but not under a cover.
- There are no regulations specific to fitted vehicle covers for commercial or industrial zoning districts.
- Vehicles under a tarp are regulated as outdoor storage. Limitations on outdoor storage vary based on zoning district.

Information about vehicle covers and other <u>vehicle storage regulations</u> is available by <u>visiting the County's website</u> and searching "vehicle storage."

How does the Department of Code Compliance (DCC) enforce codes?

- DCC Investigators inspect and photograph the property to determine if there is a violation and try to contact the property owner to discuss the nature of the complaint or violation.
- If there is a violation, a Notice of Violation (NOV) is issued directing the property owner to resolve the violation.
- The NOV provides the owner with a specific timeline to come into compliance.
- DCC Investigators reinspect the property after the provided time to comply has expired to determine whether the violation has been resolved.
- Failure to comply with the NOV can result in the County taking legal action, such as seeking civil penalties or a court order to resolve the violation.

The <u>public comment period</u> for changes to Virginia Railway Express (VRE) fares, as proposed in the <u>Fiscal Year 2025 budget</u>, is open until Thursday, November 16 at 5:00 p.m. The proposed budget provides for the first-ever operation of VRE weekend service, as well as a proposal to allow children under 18 to ride free and changes to simplify fare payment.

Transportation Projects Considered for Funding

Fairfax County Department of Transportation (FCDOT) has developed a <u>proposed list</u> of projects that will be narrowed down further with input from the



community to receive a portion of \$100 million funding allocated by the Board of Supervisors. To fund safer active transportation facilities, the Board approved \$100 million in new funding for one-time investments in pedestrian and bicycle infrastructure through FY 2027. To date, 30.2 million of the dedicated \$100 million has been allocated for active transportation improvements and maintenance.

FCDOT held two virtual community meetings to present how the current list of projects was developed, including the methodology and criteria staff used to select projects for consideration. The project list was narrowed down from a list of over 2,000 unfunded projects to 317. To further narrow down projects for the third round of funding, public input is sought from the community through an online survey.





FCPD's Drone Program Leading the Way in Fairfax

Fairfax County Police Department (FCPD) has used drones for small jobs since 2019, but in the past year, FCPD's drone program has expanded to assist the department's

helicopter program with a lot more detailed work.

In May 2019, the Fairfax County Unmanned Aircraft System (UAS) program, more commonly known as its drone program, was approved to be used by the Fairfax County Fire & Rescue Department, Department of Emergency Management (DEMS), Fairfax County Police Department and the Fairfax County Sheriff's Office. Since then, their place in



FCPD's public safety operations has been an invaluable tool for FCPD.

A recent example of the benefit of drones was an armed barricade incident in Fair Oaks. Officers and members of FCPD's Crisis Negotiation Team were on the scene negotiating

with an armed man who barricaded himself inside his home. A drone provided officers, negotiators, and our Co-Responder team with invaluable eyes on the situation. The drone's continuous view, along with our officer's ability to create time and space in this situation, were factors that allowed for a peaceful resolution to this tense situation.

FCPD's drones are not weaponized and are equipped with high-resolution cameras and recording devices. The expansion of the drone unit and the means to have rapid deployment, tactical support, and real-time information for officers during critical incidents is just one of the many ways FCPD is keeping Fairfax County safe. Results of 2022-2023 Fairfax County Youth Survey

The School Year 2022-2023 Fairfax County Youth Survey has been successfully

completed. Since its inception, the survey has provided insights about the behaviors and attitudes that affect the health and well-being of Fairfax County youth.

A total of 27,814 students in 8th, 10th, and 12th grades participated in the survey, representing 64.7% of all 8th, 10th, and 12th grade students enrolled in Fairfax County Public Schools (excluding alternative schools). Simultaneously, a



total of 11,384 students participated in the 2022 Fairfax County Youth Survey of 6th Grade Students, representing 84.9% of all 6th grade students enrolled.

Overall, the percentage of students who reported risky behaviors continued to decrease this year in many areas including substance use, sexual activity, and aggressive and delinquent behavior. Mental health indicators including feelings of sadness/hopelessness, suicidal ideations, and suicide attempts, also improved noticeably compared to 2021. Students who reported the recommended amount of physical activity increased compared to the prior year as well. While the percentage of students who reported spending one hour or more on extracurricular activities went up from 2021, the rate was still significantly lower than the pre-pandemic rates. Most Fairfax County students



Rezoning of the Mary Day Property on Zion Drive Scheduled for Board of Supervisors Hearing on October 10

On July 27, the Planning Commission voted to recommend approval of a rezoning proposal for 10121 Zion Drive, a wooded, undeveloped site known as the Mary Day property. This 2.8-acre site is located on the west side of Zion Drive, just north of its intersection with Guinea Road and adjacent to the Burke Junction community.

The applicant has proposed rezoning the property from the R-1 District to the PDH-3 District to build six single-family detached homes. Access to the property would be provided through an extension of James Young Way, a private street that connects to



Zion Drive opposite Hillard Lake Road and links to the Burke Junction neighborhood to the south. The applicant has stated that they intend to make this development compatible with Burke Junction.

Prior to the Planning Commission hearing, the applicant made a number of revisions to address concerns on issues including landscaping, tree preservation, and details on the establishment of a Homeowners Association (HOA). The development plan was revised to more clearly identify the widths of the proposed landscape buffer along the southern border of Lots 1, 2, 3, and 5 and easement at the rear of Lot 4, which now range from 5 to 8 feet. Specific language was included to clarify that construction activities on the Day property will not cut into the critical root zones or damage any off-site trees. This was a major concern of the residents of the Burke Junction community.

Although the proposed houses are of similar height to those in Burke Junction, they are higher in elevation due to the topography. The applicant revised the proffers to state that the basements on Lots 1 through 4 would be buried a minimum of 6 feet, as opposed to being walk-out, to make them more comparable in appearance. The floor height of rear decks has also been limited from a maximum of 11 feet above ground level to a maximum of 5 feet above grade on Lots 1 through 4. Decks on Lots 1 and 2, which are adjacent to the Burke Junction pergola and open space, will only be permitted to extend 12 feet into the minimum rear yard.



Regarding HOA membership, an interpretation request submitted by the applicant determined that the current owner or future owners of the application property are not precluded from joining the Burke Junction HOA subject to the provisions in the Burke Junction HOA governing documents. Based on that, the proffers for the Mary Day property have been written to allow for either annexation of the new development into the Burke Junction HOA or establishment of a separate and independent HOA. The applicant will either relocate the existing Burke Junction monument sign to Zion Drive if the new community is annexed into the Burke Junction HOA or install a separate monument sign for the new community if they do not merge.

At the Planning Commission hearing, residents of the adjacent Burke Junction community expressed concerns that the revisions presented by the applicant had not been fully discussed with them and the hearing format did not give them an opportunity to ask questions. Supervisor Walkinshaw held a community meeting on September 13 to give the residents an opportunity to meet with the applicant and get answers to their questions regarding elevation, grading, landscaping, and the potential merger of HOAs in advance of the Board of Supervisors hearing.


A Staff Report analyzing the proposed rezoning was published on February 1, and memos updating the Planning Commission on subsequent revisions were issued on May 17, June 14, July 20, and July 26. Application Filed for Adult Day Care Facility at 8003 Forbes Place

Friends Adult Day Care has filed an application for a Special Exception to operate an adult day care facility on the third floor of an existing office building at 8003 Forbes Place in Springfield, near the intersection of Forbes Place and Port Royal Road and south of the Ravensworth Shopping Center. The property is zoned to the I-5 District.

The applicant had operated an adult day care within the Calvary Church of the Nazarene in Annandale and now proposes to relocate and enlarge its operation. According to the application, they are proposing to convert the third floor, or approximately 15,329 square



feet, of the office building to adult day care use for up to 200 adults, with the first two floors of the building remaining occupied by office uses. A grassy area along the side of the building, measuring approximately 20 feet by 170 feet, would be used for outdoor recreation, consisting primarily of walking. Four standard picnic tables would be located in that area. Approximately 40 employees would be on site at any one time. Operating hours would be 7:00 a.m. to 5:00 p.m., Mondays through Saturdays. The applicant has stated that there would be minimal traffic impact, because the majority of clients would arrive by buses or minivans. The daily impact is estimated at 100 trips, primarily at 7:00 a.m. and 5:00 p.m.

The Health Care Advisory Board (HCAB) will hold a public meeting to review this Special Exception application on Monday, October 9, at 7:30 p.m. in Government Center Room 232. The meeting will also be available via Zoom:

At the October 9 meeting, the applicant will have 15 minutes to present the proposal, then HCAB will ask questions and discuss the proposal, hear public comments, and develop its report. 
Church of the Good Shepherd Applies for Special Permit Amendment to Subdivide Its Property

The Church of the Good Shepherd has applied for a Special Permit Amendment for their 10.31-acre property at 9350 Braddock Road in Burke. In general terms, the Fairfax County Zoning Ordinance allows religious assembly uses to locate within residential zoning districts under the controls, limitations, and regulations of a Special Permit approved by the Board of Zoning Appeals (BZA). Similar to a Special Exception, the purpose of this is to help ensure the proposal is compatible with the surrounding residential uses. The Church of the Good Shepherd has received several Special Permit approvals over the years, the most recent of which was approved by the BZA on May 13, 2003. That approval permitted building additions, site modifications, and an increase in land area for the Church and a nursery school. The approval included a large playfield on the northernmost portion of the site.

According to representatives from the Church, they want to sell approximately 3.12 acres of land at the northern end of their property as they no longer anticipate a need for all of the building improvements or the playfield approved in the 2003 application. The remaining 7.185 acres will continue to be used by the Church, with two possible phases of additional development on that land.

The prior approval permitted four phases of future development. Phase 1 was an addition to the existing church, which has been constructed. Phase 1B was an additional expansion of the existing building by approximately 9,000 square feet, and phases 2 and 3 allowed for the construction of a new worship center and an administrative building totaling 29,587 square feet of gross floor area. The plans also included a large playfield.

In conjunction with the request for the deletion of land area from the Special Permit, the Church is also seeking to reduce the ultimate size of the previously approved improvements. The building addition approved as Phase 1B would be reduced to approximately 3,963 square feet, and the approved sanctuary capacity of 900 seats would be reduced to 688. In addition, Phases 2 and 3 would be combined into a single building referred to as Phase 2 and consisting of approximately



10,000 square feet. The Church would continue to operate a nursery school with a maximum enrollment of 99 children. The conservation easement along the eastern property line, which is approximately 34 feet wide, would be maintained and enhanced with supplemental trees and evergreens. Twenty-five feet of transitional screening would be provided between the Church and the new parcel that would be separated.

The applicant is not proposing any new uses on the parcel that is to be separated, nor are they proposing a rezoning of the property removed from the Church's parcel. This application would only remove 3.12 acres of land from the Church's Special Permit area and that land would revert to what is currently permitted by right in the R-1 Zoning District, which is residential use at a density of one house per acre with a minimum lot size of 36,000 square feet. Any development proposals beyond that would require a Comprehensive Plan amendment and rezoning approval by the Planning Commission and Board of Supervisors.

The Special Permit Amendment application was accepted on August 24. Pursuant to the Special Permit standards in the Zoning Ordinance, staff will be looking at what the removal of 3.12 acres of land from the Special Permit area means for the continued function and operation of the Church use. No decisions will be made on the future of the 3.12 acres as a result of this application.

The Special Permit process is open and transparent and public input is encouraged. Residents may submit comments to bzaclerkmail@fairfaxcounty.gov. The Statement of Justification from the applicant and the Special Permit plat are available on the PLUS website. If the link doesn't take you directly to the application, select the "Zoning" tab and enter the application number, SPA-81-A-025-02, in the search box on the right side. Click on the magnifying glass and you will see the application. Click on the "Record Info" arrow on the left and then click on "Attachments" in the drop-down menu. The most recent documents will be at the end of the list. The PLUS website is updated in real time, so any updates will be available when submitted.

Update on Construction at Woodleigh Chase

The construction team is actively working through the punch list process on the first three buildings at Erickson Living's Woodleigh Chase campus on Braddock Road. During this process, the contractor goes through the buildings and identifies any work that has not been completed, anything that was damaged during construction and needs to be repaired, or other minor fixes needed before the final inspection. At Emerson Square, the community building in the center of the three buildings, work is approximately 98 percent complete, punched, and almost ready for the community. At Fulton Landing, the residential building connected to Emerson Square on the west, the contractor has punched up to the fourth level and is putting finishes in the common area. At Stafford Glen to the east, quality control inspections are underway in preparation for the punch list process. Landscaping is being installed at the main entry to Emerson Square.





Construction of the next phase of buildings is now underway. Although it isn't visible from Braddock Road, work has started on the fourth residential building, located just south of Fulton Landing. Progress on the garage level is visible in the photo.



Update on Ilda's Overlook Senior Residences on Braddock Road

The Arlington Partnership for Affordable Housing's 80-unit affordable senior project on Braddock Road is 90 percent complete. Installation of mechanical, electrical, and plumbing trim and fixtures is continuing. Appliances are continuing to be delivered and installed. The second-floor unit flooring has been completed. Units are being cleaned and punched. Around the exterior, caulking and landscaping work is continuing.

Over the next few weeks, elevator construction will continue. First floor unit flooring, fourth floor corridor flooring and wall sconces, and wall coverings will be installed. Additional units will be cleaned and punched. Exterior light poles will be put up, and building signage will be installed. Toward the end of the month, the parking lot will receive a topcoat of asphalt.

Construction should be completed in late November. For those who are interested, APAH has a website where potential residents can sign up for more information. There is also a phone number for the property management team.

The Fairfax County Board of Zoning Appeals (BZA) hears and makes decisions on requests for variances (relief from specific zoning regulations such as lot width, building height, or minimum yard requirements) and Special Use Permits. It meets on Wednesdays beginning at 9:00 a.m. BZA meetings are aired live on the county government's cable TV Channel 16. Residents who have concerns about an application are encouraged to submit a letter for the record or testify at the hearing on the case in person, by telephone, or by pre-submitted video. For information on how to submit comments or testify, please visit the **Board of Zoning Appeals website**. These matters will not come before the Board of Supervisors but will be decided by the BZA. Staff reports are normally available online a week before the scheduled hearing.

Access to information on BZA cases is available through the Planning and Land Use System, or PLUS. This system allows users to create and submit applications online, pay fees, track the status of applications, and receive electronic notifications. It also offers more information to the public than the previous system and does so in real time. Visit the PLUS website for more information on this land use platform.


Farzaneh Hajiaghabozorgi and Nini Daycare LLC – 5002 Wheatstone Drive, Fairfax

The applicant requested a Special Permit to expand a home childcare facility to care for 12 children and a reduction in setback requirements based on errors in building location for an accessory structure to remain 0.0 feet from a side lot line. The childcare is open from 7:30 a.m. to 5:00 p.m. Monday through Friday. Arrival times would be between 7:30 and 9:15 a.m. Pick-up times would be between 2:45 and 5:00 p.m. There would be four employees, two for the morning shift and two for the afternoon shift. Parking would be in the driveway and along the street. The BZA approved this application on September 20. Information, including a map of the site and staff report, may be found on the PLUS website.

Saint Bernadette Catholic Church and School – 7600 Old Keene Mill Road, Springfield SPA-78-S-276-03

The applicant is requesting to amend their Special Permit previously approved for a Place of Worship, Private School of General Education, and Child Care Center to allow for modifications to site and development conditions to permit construction of a fellowship hall, and to make condition modifications. A new two-story building with 13,500 square feet of gross floor area would be added on a portion of the existing parking lot and connect to an existing church building. The first floor would include meeting rooms, classrooms for church programs, and administrative facilities. The second floor would include a fellowship hall. Although the number of parking spaces would be reduced, the total would exceed the requirement under the previously granted parking reduction. At the applicant's request, the BZA hearing on this application has been deferred until November 15.
