Fairfax-Falls Church Community Services Board Compliance Committee Meeting Minutes February 19, 2020

The Compliance Committee of the Fairfax-Falls Church Community Services Board met in regular session at the Merrifield Center, 8221 Willow Oaks Corporate Drive, Fairfax, VA.

The following staff were present: Daryl Washington, Cindy Tianti, and Lyn Tomlinson

1. Meeting Called to Order

The meeting was called to order at 4:00 p.m.

2. Review of Meeting Minutes

Meeting minutes of the December 11, 2019 and the January 15, 2020 Compliance Committee were provided for review and revision. As no recommendations were forthcoming, Diane Tuininga made a motion to approve the minutes as presented, which was seconded and approved.

3. Follow up items from the prior Compliance Committee Meeting

Lyn Tomlinson distributed copies of an updated organizational chart for the Office of Compliance and Risk Management, providing an overview of the changes that included:

- x Luann Healy will directly supervise the three manager positions following removal of the Certified Compliance Program Coordinator position.
- x Efforts are underway to fill the vacant Human Rights/Incident Management position, noting the challenge in filling this position as it requires specific knowledge and skills.
- x Management staff will be provided technical assistance and content training to increase content expertise. This will provide layers of support to the Director position as well as supporting management responsibilities.

4. Updates

ComplyTrack

Lyn Tomlinson directed attention to the ComplyTrack reports included in the meeting materials, providing clarification to each report, the highlights for which are provided below.

- x Audit: Potential Risk was clarified as including new programs and programs that have been recently expanded or modified, noting this may include a new level of care or billing implementation. It was further clarified that this higher risk level is assigned as risk increases while new, revised, or updated program requirements are learned and implemented.
 - o It was confirmed that an audit plan may be prompted by a Corrective Action Plan (further defined below) to assist staff with tracking errors and implemented corrections in response to a licensing audit.
- x CAP (Corrective Action Plan); results from a licensing audit/review. An overview of the process was provided, clarifying that following an audit/review, a CAP is submitted to

the state (licensing) and, once accepted, is implemented and tracked until the requirements of the CAP are met.

- Members confirmed that closed CAPs should continue to be included on the report as committee members continue to become familiar with the reports and the actions that supply the data.
- x Education: an overview of each of the data points was provided.

Credible Operations Update

Daryl Washington, noting no significant changes, clarified that a meeting has been scheduled with the Credible CEO and the 25 Virginia CSBs that use Credible. The meeting is set for Wednesday, February 26 in Richmond.

CSB Serious Incident Report ±January 2020

Lyn Tomlinson provided the Serious Incident Report for February 2020.



CSB Board Compliance Committee Meeting, March 17, 2021

Since March 2020, the following changes/clarifications have occurred with the regulatory agencies that govern the CSB.

Centers for Medicare and Medicaid Services (CMS):

- Telehealth/Behavioral Health Services:
 - flexibility to bill for services via telehealth
 - January 2021, more Telehealth billable services added

Health Insurance Portability and Accountability Act (HIPAA):

- COVID19 clarifications:
 - use of HIPAA compliant telehealth equipment to provide services

Substance Abuse and Mental Health Services Administration (SAMHSA) (42 CFR Part 2-Confidentiality rules):

 Some alignment of confidentiality rules with HIPAA-42CFR Part 2 to be more stringent: e.g., HIPAA allows client verbal consent to disclose information, 42 CFR Part 2 requires written consent. Fed. Reg. changes due to be published 3/27/2021

Department of Medical Assistance Services (DMAS):

- Regularly send out memos extending the Public Health Emergency and flexibilities
- Working re: alignment of rules with DBHDS, e.g., DBHDS allowed flexibilities for attaching Service Plan Reviews to client chart in conflict with DMAS rules
- Behavioral Health Enhancements:
 - regulatory guidance due next month
- Managed Care Organizations (MCO) required training for clinical staff the VACSB (Virginia Association of Community Services Boards) is working to determine if current training will fit these requirements.

Department of Behavioral Health and Developmental Services (DBHDS):

- Department of Justice (DOJ) settlement agreement is driving many changes, as well as the public health emergency
- Structure of DBHDS:
 - created Incident Management Unit
- Increased auditing due to the changes within DBHDS and to comply with DOJ settlement Corrective Action Plans (CAPs) and Citations more frequent with increased oversight in both licensing and human rights regulations
- COVID19 reporting added to Serious Incident Reporting as a Level II incident
- Care concerns:
 - established thresholds to trigger a review by programs
- Expectations for Risk Management Plans and Quality Improvement plans indicated in 2018 regulations were further defined
- Training:
 - flexibility for completing required training remotely for training that has a "hands on" component, e.g., First Aid
