As a result, 32 units were evacuated and many residents were displaced while damages are being assessed and repairs being made. Fortunately, no one was injured. Thanks for the tremendous support of Fairfax County's Office of Emergency Management, Police Department, Fire Department, the County Building Division, Department of Code Compliance, Department of Neighborhood and Community Services, the Red Cross, the County Executive's Office and many members of our office. Everyone in the County pulled together for the benefit of community. For many of the residents still displaced, this will be a continuing personal, emotional and financial hardship because it will still be some time before they can return to their units. We will continue to provide support in the coming weeks as the damage repair work and restoration efforts continue.

# Original Mount Vernon High School Gym Reopens



Teens, adults and county officials gathered recently to celebrate the reopening of the gym at the <u>Original Mount Vernon High School</u>.

This marks the first milestone in the efforts to reuse this 1930s-era building and campus at 8333 Richmond Highway. Until its lease ended this year, the Islamic Saudi Academy rented the campus for the past 31 years.

"We have a chance to really return this fully to the Mount Vernon and Lee communities and, frankly, make a difference for all of us," said Mount Vernon District Supervisor Dan Storck.

The former school's gym was refurbished to provide programming space for the South County Teen Center, which is located at the South County Government Center.

### **Gymnasium Renovated**

The gym was temporarily closed this summer while the space was improved. The refinished and repainted court will be enjoyed by basketball, volleyball, and **pickle ball players**.

Other improvements included:

- Cleaning and painting
- Repaired lighting
- Installation of an administrative area
- Improved safety and security
- New sports equipment purchased
- Installation of a new scoreboard

### **Looking to the Future**

The <u>Original Mount Vernon High School reuse project</u> supports our <u>Economic Success Strategy</u> and <u>Embark Richmond Highway</u>. We are looking at many possible options, such as:

- Using the campus for economic development activities
- Creating housing
- Providing educational opportunities
- Offering nonprofits or others space for delivering services

Options for long term reuse are being explored by a cross-agency team and representatives from the private and nonprofit sectors. The campus also is located near a possible future rapid bus transit station, one of nine planned as part of Embark Richmond Highway.

# **Embarking on the Future of Richmond Highway**

Embark Richmond Highway is a multiyear effort involving land use, transportation planning, design and construction, which will result in a bus rapid transit system to operate primarily on dedicated lanes along Richmond Highway. The stations will run initially from the Huntington Metrorail Station to Fort Belvoir and will include a



possible future extension of the Metrorail Yellow Line to Hybla Valley.

### Fairfax County Receives \$400,000 Grant to Advance Embark Richmond Highway Initiative

On October 17, Fairfax County reported that the Federal Transit Administration (FTA) announced the recipients of its 2016 Transit Oriented Development (TOD) Planning Pilot Program projects, and Fairfax County was one of the 16 organizations across the country selected to receive a share of the \$14.7 million in grants. The \$400,000 grant awarded to the Fairfax County Department of Transportation (FCDOT) will support the Embark Richmond Highway initiative's TOD planning activities and the implementation of a Bus Rapid Transit (BRT) system along Richmond Highway.

"This grant is another step forward in the county's efforts to plan for the future growth in the Richmond Highway Corridor," said Tom Biesiadny, director of Fairfax County Department of Transportation. "These funds will directly assist our collective work currently underway to plan for and implement effective multimodal transportation and land use solutions for the Richmond Highway community."

The <u>Virginia Department of Rail and Public Transportation</u> (DRPT) and FCDOT will each contribute \$200,000, for a total of \$400,000, to match the TOD grant awarded by FTA. **For more information** on Embark Richmond Highway:

# **New and Improved Bike Lanes Coming Soon!**

Bicyclists can look forward to more dedicated lanes in Fairfax County thanks to VDOT's 2016 Paving Program. Additionally, 3.5 miles in upgraded buffered bike lanes are planned on Telegraph Road from the Fairfax County Parkway to Hilltop Village Center Drive. This year's efforts will result in about 20 miles of new and upgraded bike lanes.



The county currently has 368 miles of bike lanes, paths and trails, which include approximately 70 miles of on-street facilities. The county's goal of creating a 1,130-mile bike network was approved by the Board of Supervisors in the Bicycle Master Plan in fall 2014. Watch out for new and upgraded

**Domestic violence affects one in four homes** in Fairfax County and is a leading cause of homicide in our community.

Our domestic violence hotlines receive **over 200 calls each month**.

Every month, more than **160 family abuse arrests** are made.

• In a recent two-year period, there was a 47% increase in the number of residents served by the Domestic Violence Action Center, a partnership of the county and nonprofit organizations.

There are many steps - small and big - that each of us can take to create awareness of domestic violence in our community.

### Read About Lisa, Be Informed

Lisa, four months pregnant, entered the emergency domestic violence shelter Artemis House with her young son. She was fleeing her husband, who was increasingly drinking, gambling and becoming more aggressive. He was financially abusive and had restricted Lisa's access to the family bank account. In a fit of paranoia, he physically attacked her. While at Artemis House, she received the resources needed to move out of state, where she had her family's support throughout her pregnancy. The Board of Supervisors designated October as *Domestic Violence Awareness Month* in Fairfax County, recognizing the impact of domestic violence in the community and urged all residents to become involved in efforts to prevent and respond to domestic violence.

# VDOT v. FCDOT



Many of the complaints that come through our office relate to issues on the roadways. You may not be aware of this, but a majority of Fairfax County roads are owned and maintained by

the Virginia Department of Transportation (VDOT), a state funded and organized entity.

Therefore, many times when Mount Vernon District constituents contact our office to report an issue on the roadway, we submit these complaints directly to our VDOT representatives, and not to Fairfax County Department of Transportation (FCDOT).

A VDOT owned road generally has a route number associated with it (ex: Fairfax County Parkway - Route 286). This also includes most primary and secondary roads in the county. Maintenance includes potholes; traffic signals and signs (except street name signs); trees/branches; roadside ditches, curbs and gutters; and snow removal.

Part of the role of our office is to serve as a liaison between Mount Vernon District residents and state agencies like VDOT. With that being said, there are limitations to what our office can request of VDOT, such as road paving. Each summer, VDOT decides what roads are in need of repaving based on a number of factors, such as current pavement conditions, funding availability, ride quality and volume of traffic. VDOT quotes that "while a road may not look deficient to the casual observer, samples of the roadway under testing can reveal distresses that are concerning to VDOT." Repaving requests are frequent and we continue to pass these requests to VDOT, but it is important that you also contact your state representatives who ultimately impact funding and changes within state run agencies.

FCDOT "plans, coordinates and implements multi-modal transportation system for Fairfax County" working on projects such as the RTAP and Parking District programs, bicycle and pedestrian related projects and trails. It is often that FCDOT and VDOT work on projects together, FCDOT does most of the planning aspects of a project and VDOT does the physical portions.

As mentioned above, our office is available to assist and direct you with questions, we also encourage you to utilize the resources below to help address old or new issues.

# Habitat NOVA Celebrates Completion of Two New Homes

Two local families achieved their dream of building and owning their own home, thanks to Habitat for Humanity of Northern Virginia (Habitat NOVA).

On September 18, the Mans aye and Omar families were joined by more than 90 volunteers, Habitat NOVA board members and staff, project partners, and guests in celebration of their newly completed homes.



Supervisor Storck served as guest speaker and underscored the necessity for more affordable housing in the region and how Habitat NOVA leads that effort. "Along with Supervisor Jeff McKay [Lee District, Fairfax County], I deeply believe in providing people opportunities to live, work, and

play and be part of this community. Habitat for Humanity NOVA is a key facilitator, a key

organization helping to make that happen. I'm thankful for them and their work."

The new homes were designed pro bono by Sanchez Palmer Architects & Triad Engineering. Key corporate included E\*TRADE, The Stafford Foundation, Capital One, Leidos, Inc., Wells Fargo, Freddie Mac, Fannie Mae, and Bean, Kinney & Korman, P.C.



Community volunteers worked more than 1,500 hours over the course of 19 months to build the two Clayborne Avenue homes. Moreover, each family completed 400 hours in "sweat equity" to finalize the construction. Built to EarthCraft Gold standards, each house is energy-efficient while maintaining long-term affordability. The homes are also Habitat NOVA's first construction projects to feature solar panels.

For Amna Mansaye, the celebration marks a milestone in fulfilling her family's goal toward greater stability and resilience. "This home is an investment in my family and in our future."

On Monday, October 17, at the Walt Whitman Middle School, dozens of residents attended the Mount Vernon-Lee Tree Forum.

The forum featured a presentation by two arborists from the County's Urban Forest Management Division, Nick Drunasky and Rachel Habig-Myers. Prior to the presentations, Supervisor Storck



commended outgoing Mount Vernon tree commissioner Eleanor Quigley for her years of service preserving trees in the Mount Vernon District and throughout the county.

Storck commented that Mount Vernon is the "most livable" district in the county because of its extensive tree canopy and credited "Tree Lady" Quigley, for her tireless efforts on behalf of trees.

Storck also introduced the new Mount Vernon Tree Commissioner Cathy Ledec, the President of the Friends of Huntley Meadows.

Aimed at homeowners, the topics presented included:

- the value, health, lifetime and economics of trees;
- replacing aging trees, what to plant;
- utility companies and trees; and
- managing invasive plants like English ivy, multi-flora rose, Bradford pear and honeysuckle.

know, our local Office of Elections has received reports of mailings from other organizations with misleading or incorrect voter information. Also, please read up on the Meals Tax Referendum, which will be on your ballot this November. If voters approve a meals tax, 70% of the revenue (approximately \$70 million) would supplement funding for Fairfax County Public Schools.
