Dear Neighbors,

February is one of my favorite months as we honor our presidents with Presidents' Day, particularly recognizing our most beloved presidents, George Washington and Abraham Lincoln, and pay tribute to the historically under-

recognized contributions of African Americans as we celebrate Black History Month.

Two land use cases were decided unanimously at our February 14 Board of Supervisors meeting. Thirty-five years after Fairfax County acquired a failing trailer park, [North Hill](#) is a step closer with the approval of these zoning changes to becoming an affordable, mixed-use community of families, seniors, work-force and market-rate housing. While a key financing hurdle later this year remains, North Hill's 35 acre innovative 1/3, 1/3, 1/3 land use design for a public park, 175 market rate for sale townhomes and 279 affordable and work force apartments (60 dedicated to seniors) have been winning wide praise in and outside our community.

For the **Bock Farm** application, the Board supported my decision to not accept the original proposal and refer the matter back to the Planning Commission, enabling the property owner to modify and more expeditiously and less expensively resubmit a revised application. It is anticipated that the applicant will submit one of the other two options recently presented for either a modified 55+ senior independent living community or family townhomes. Any resubmission would require Planning Commission and Board of Supervisors' public hearings and approval by the Board.

welcome and celebrate one another's differences and backgrounds. Fairfax County has nurtured the [Communities of Trust Committee](#) and other connections to encourage community dialogue and build relationships between all residents. The recent Immigration and Customs Enforcement (ICE) Richmond Highway raid across from Rising Hope Church and Shelter is inconsistent with ICE policies and our values that churches are refuges. ## Bock Farm

On Feb. 14, Supervisor Storck made a decision to withdraw the current proposal before the board. The decision will permit the developer to modify and resubmit the application resulting in potential new public hearings.

Supervisor Storck's motion was a "referral back" to the planning

commission to allow the applicant the opportunity to bring forward an updated proposal. The formal language is below:

*Given the needed changes to the development plan, these changes will require a new public hearing before the Planning Commission and Board of Supervisors. This action will not require the applicant to re-start the process but will require them to continue to work with staff and community on refinements to their concepts.*

*Remove applications PCA B-715, RZ 2015-MV-015 and SE 2015-MV-030 from the Board's current agenda and*

*Pursuant to Paragraph 1 of Section 18-204 of the Zoning Ordinance direct the Planning Commission and the Department of Planning and Zoning to prepare new notices for a new public hearing on an amended application and direct the Department of Planning and Zoning and the Clerk to the Board to prepare new notices for a new public hearing after Planning Commission action.*

The motion was approved unanimously by the Board of Supervisors.

#### Background Information:

Supervisor Storck has held several meetings with area residents, the Bock family and the developer Joe Francone to answer questions and identify other potential options. Three options discussed:

1. Proceed with the original application for senior 55+ age community proposal with four, four-story buildings with 128 units;
2. Senior 55+ age community proposal modified with lower building heights and approximately 5-10 fewer units; or
3. Townhomes with 35-40 units, not age restricted.

## North Hill



The development plan for North Hill includes workforce and affordable housing that will be spread across five four-story buildings that front Richmond Highway. One of these five buildings will be dedicated for the 60 units of independent senior living. The 175 market-rate townhouses will be built along Dart Drive.

One of the development's focal points will be a public plaza at the corner of Richmond Highway and Dart Drive. It may include benches, plantings, lawn, fitness and other recreational equipment. ## Fairfax County Executive Presents Proposed FY 2018 Budget



County Executive Ed Long presented his proposed FY 2018 Budget and FY 2019 Multi-Year Budget Plan to the Board of Supervisors at their meeting on Tuesday, Feb. 14. The proposed General Fund budget is \$4.10 billion, a \$77.2 million (or 1.9 percent) increase over the current FY 2017 budget. If you include other appropriated funds such as federal and state grants, the total budget is \$7.99 billion.

## Covanta Fairfax Fire



*Fire at Covanta's Waste-to-Energy Facility - Feb. 2*

On Thursday evening, Feb. 2, a fire at Covanta's Lorton waste-to-energy facility started as a one alarm fire and progressed throughout the event. Fire investigators determined that the fire originated on the tipping floor and extended to the holding pit of the facility. When contacted by staff, Supervisor Storck immediately went to the site and joined our fire and rescue crews and James Patteson and John Kellas from the Department of Public Works and Environmental Services. There were no reported civilian or fire fighter injuries.

As of Feb. 14, the fire at Covanta's waste-to-energy facility has been completely extinguished. Environmental monitoring is in progress by an independent testing company.

Historical Highway



**Learn more about what your real estate tax dollars pay for with this [new tool](#):**

**Real estate taxes account for almost 65 percent of the county's General Fund budget. That equals \$2.6 billion** of the almost \$4.1 billion our current FY 2017 General Fund budget (adopted by the Board of Supervisors last year). The rest of the [General Fund Revenue](#) comes from the Personal Property (car) Tax, business taxes, sales tax, fees, etc.

This educational tool helps illustrate where tax dollars go to meet the [priorities set by the Board of Supervisors](#) and the community for county programs and services. Certain fees, including those for community centers, solid waste fees and service district fees, are not included in this simulation tool since they do not impact all taxpayers. Enjoy taking this online visual history map tour, which takes you to 48 historical highway markers in Fairfax County. 
