#### **Welcome and Introductions**

Mr. Cameron welcomed all to the meeting and noted there was a quorum with four board members in attendance in person.

#### Minutes - September 23, 2025

Ms. Barakat reported that she had reviewed the minutes of the September 23, 2025 board meeting and that they had been distributed in advance of the meeting.

## Treasurer's Report - September 2025 and First Quarter FY 2026

Ms. Bitterli reported that the Treasurer's Reports for September 2025 and First Quarter FY 2026 had been distributed in advance of the meeting. Hearing no comments, the Treasurer's Reports for September 2025 and First Quarter FY 2026 were accepted by consensus to be filed for audit.

#### **Technical Review Committee**

Ms. Bordas noted that the VCAP Steering Committee is being more rigorous in its review of applications. Projects with a ranking score of 85 or more are most likely to be funded. She said a project the district sent for approval last month was waitlisted and so will be funded through the local CAP instead.

## Next Meeting of the Technical Review Committee

The next meeting of the TRC will be held on Tuesday, November 18, 2025, at 10:00 am.

### **Legislative Report**

Mr. Cameron reported that the Virginia Association of Soil and Water Conservation Districts' Board of Directors met in October to review the amendment to the state association's policy on dams reflecting NVSWCD's recommendation to support state funding for dams owned or operated by Watershed Improvement Districts (WIDs). The policy will now go before the state association for review and approval at its annual business meeting in Williamsburg on Tuesday, December 9, 2025.

Mr. Cameron also reported that the state association's proposed legislative agenda, which will go before the VASWCD for approval at the December business meeting, will advocate for \$4 million annually for environmental education, \$8 million for VCAP for the biennium, and a \$3 million increase annuallyforSWCD operating funds.

Mr. Cameron noted that NVSWCD traditionally sends an annual letter to the entire Fairfax County delegation to the General Assembly urging support for VASWCD priorities, emphasizing items of special interest to the district. Mr. Cameron asked Mr. Lecos to give him a Lake Barcroft Dam funding request amount and asked Mr. Woode to provide a similar amount for urban agriculture, so both could be included in the draft NVSWCD letter. Mr. Cameron will draft the letter in November to be sent at the end of December.

## **Finance Committee Report**

Ms. Bitterli reported that the Finance Committee met on September 23, 2025, and October 21, 2025, to review NVSWCD's FY 2027 Fairfax County Budget and Contributory request. She highlighted some of the changes made to the budget this year

A **motion** (Bitterli-Barakat) to approve the FY 2027 Fairfax County Budget and Contributory Request in the amount of \$697,722, as included in the board package, and authorize its submission to Fairfax County's Department of Management and Budget, passed by voice vote.

Mr. Cameron voiced his appreciation for the work the staff put into streamlining the budget.

Mr. Koerner also commended Mr. Woode and Ms. Shackley for their work on the budget, noting it was very readable and comprehensive.

# **Potomac Council Grant Submission**

Mr. Woode said that the Potomac Council (council)/Potomac Watershed Roundtable (roundtable) grant comes from the Virginia Department of Environmental Quality, and that the roundtable is comprised of Soil and Water Conservation Districts in the Potomac Watershed. He reminded the board that NVSWCD is the administrative district for the council and the roundtable.

A **motion** (Barakat-Koerner) to approve NVSWCD's grant application to the Virginia DEQ for the administration of the Potomac Council/Potomac Watershed Roundtable in calendar year 2026 passed by voice vote.

# **Approval of Revised Attachment D**

Mr. Woode reported that there was a slight error in the FY 2027 Attachment D Budget Template that was approved by the NVSWCD Board of Directors in June and submitted to DCR. He updated the board on changes made.

A **motion** (Barakat-Koerner) to approve the revised version of the FY 2027 Attachment D Budget Template passed by voice vote.

#### **Green Breakfast**

Ms. Feth said the next Green Breakfast is virtual and will be held Saturday November 8, 2025. Rama Mitry and Maggie Beetstra from the Fairfax County Office of Environmental and Energy Coordination will discuss three programs: Charge Up Fairfax, the Energy Conservation Assistance Program, and the new Fairfax Energy Compass.

#### **Tree Commission**

Ms. Bitterli reported that the Tree Commission met on October 9, 2025, where they heard a presentation on the Fairfax County deer management program. She also reminded the board that the Friends of Trees Awards ceremony is Thursday, October 30, 2025, in the Government Center, and that NVSWCD Associate Director Jerry Peters will be given an award.

#### Other Items—Directors, Associates, Consultants

Mr. Koerner reported that he was a presenter at the Climate Action Conference hosted by Congressman Walkinshaw on October 18, 2025. He said that Fairfax County Department of Public Works and Environmental Services (DPWES) Director Chris Herrington shared his appreciation for the partnership between NVSWCD and the county.

### **Executive Director's Report**

Mr. Woode highlighted some things from his report which had been included in the board package:

- Mr. Woode expressed gratitude to the board for approving the FY 2027 budget.
- At the Potomac Watershed Roundtable meeting on October 10, 2025, there was a discussion about changing the dates of the roundtable meetings as the current schedule coincides with districts' end of quarter reporting.
- Ms. Colter, Ms. Cunha and Ms. Fraser represented the district at the Climate Action Conference held on October 18, 2025. Mr. Woode said that NVSWCD was mentioned throughout the conference.
- Mr. Woode reported that in response to VCAP running out of funding, DPWES will allow NVSWCD to use CAP funding for projects that were wait-listed for VCAP, including a small amount for technical assistance funding.
- Mr. Woode recognized that Ms. Fraser is celebrating her fifth year with the district leading CAP/VCAP and that she has made significant contributions to this and other programs.

### **Staff Presentations, Reports and Announcements**

- Mr. Schwartz said NVSWCD hosted a successful worm composting workshop in partnership with Pollinative, where 15,000 worms were distributed. He said the district will host another one next year
- Ms. Murdoch reported that two of the local conservation poster contest winners won at the state level.

<u>Fairfax County Department of Public Works, Stormwater Planning Division</u> Linda Barfield provided updates from her report.

Virginia Department of Conservation and Recreation

Ms. Cross provided updates from her report, which had been included in the board package. She highlighted upcoming FOIA training for board directors on November 12, 2025 and December 3, 2025. Ms. Cross also stated that districts need to have an updated Associate Director job description and have adopted current Associate Director guidelines. Mr. Cameron asked Mr. Woode to bring an Associate Director job description and guidelines document to the board at the November 25, 2025 meeting.

Ms. Iames is furloughed and unable to provide a report or attend the board meeting.
