Please note that absentee voting at all satellite locations is from 3:30 to 7:00 p.m. on weekdays, and 9:00 a.m. to 5:00 p.m. on Saturdays.

Election Day is coming up in a few weeks and I want to share some important information about the 2017 School Bond Referendum. This bond will provide funding for building and renovating schools in the County, which is not financed through the school system's operating funds. The school improvements in the Sully District selected for this bond are: funding for the renovation construction for Rocky Run Middle School and Oakton High School; funding for the planning of renovations for Oak Hill Elementary School; and funding for the planning of capacity enhancements for Madison High School. Volunteers will sort and organize incoming donations at the NVFS Clock Tower Thrift Shop, change out display items, restock shelves, and more.


#### Garden Go-Getters

# Sully Land Use Spotlight



#### The Site-Specific Amendment Process (SSPA) has launched!

Do you have an idea to amend the Comprehensive Plan - the county's guide for land use and development? Are you interested in gaining more knowledge about land use planning or participating in the land use planning process? The county has launched the 2017 North County Site-Specific Plan Amendment process (SSPA) with an open nomination period for land use Plan changes extending from September 5 through December 5, 2017. A community screening of submitted nominations will occur prior to the addition of proposed amendments onto the Fairfax County Comprehensive Plan Amendment Work Program. Areas eligible for the North County review cycle include the Dranesville, Hunter Mill, Providence, and **Sully Magisterial Districts**. Additional eligibility requirements apply. The Sully District Council of Citizens Associations (SDCCA) and West Fairfax County Citizens Association (WFCCA) will be holding their next joint land-use committee meeting on Tuesday, November 7, 2017 at 7:00 p.m. in the McDonnell Room at the Sully Government Center (4900 Stonecroft Boulevard, Chantilly, VA 20151). As of right now, association members will be reviewing two special permit requests filed within the Sully District. One special permit would involve the establishment of an indoor archery range and the other an indoor recreational area. Links to both permits are provided below.

# **Project Completed: Old Centreville Road**

Rehabilitation of the nearly 50-year-old Old Centreville Road bridge over Bull Run has been completed, according to the Virginia Department of Transportation. Construction began in January, with bridge traffic reduced from two lanes to one. Traffic was controlled via temporary traffic signals, which allowed the project to be completed more quickly. The bridge reopened to two lanes in late August.

The \$4 million <u>project</u> was completed on time and under budget. The contractor was <u>Martins Construction Corporation</u> of Falls Church.

The bridge was built in 1968 and averages about 13,000 vehicles a day.

# Police Auditor and Civilian Review Panel Now Accepting Complaints



Two new entities are up and running tasked with enhancing police accountability, trust, and transparency. The newly established Independent Police Auditor and the Civilian Review Panel are ready to receive complaints and requests for reviews, but how does it work?

### Complaints to the Independent Police Auditor:

You may submit a complaint or request a review of an already completed

police investigation regarding alleged police misconduct. The police auditor, <u>Richard Schott</u>, will lead complaints about the following:

- An officer-involved shooting
- In-custody death
- Use of force

### **Complaints to the Civilian Review Panel:**

If the request involves alleged abuse of authority or serious misconduct by a police officer, the nine-member <u>Civilian Review Panel</u> will be in charge of that review. Examples of complaints and cases for the Civilian Review Panel to review may include:

- Use of abusive, racial, ethnic or sexual language
- Harassment or discrimination based on race, color, sex, religion, national origin, marital status, age, familial status, or disability
- Reckless endangerment of a detainee or person in custody
- Serious violations of Fairfax County or police procedures

# Rarely Seen 19th Century Objects on Display at Sully



A delicate black lace shawl, a white pillowcase with a name penned in ink, a patched shirt, and a top hat worn to Abraham Lincoln's first inauguration are

some of the rarely seen 19<sup>th</sup> century artifacts on display at Sully Historic Site **now through November 20, 2017**. Visitors can see these unique objects during guided house tours and take a glimpse into the lives of the Haight and Barlow families who lived at Sully and Little Sully from 1842 to 1876.

The intricate black lace shawl belonged to Phebe Haight, who was likely the same 'P. Haight' identified by the ink-blotted writing on the cotton pillowcase. A carefully patched men's shirt, hand-made by Amy Haight for her husband Jacob, gives insight into the high value these objects had for the families. The dark top hat was worn by Jacob Haight to Abraham Lincoln's inauguration, according to family tradition. These objects and more are displayed in a special exhibit.

House tours are \$7 for adults, \$6 for students, and \$5 for children and seniors and are offered every day except Tuesday, 11:00 a.m. to 4:00 p.m. on the hour with the last one being at 4:00 p.m. Sully was the 1794 home of Richard Bland Lee, the first Congressman from northern Virginia. Tours of Sully focus on the 18<sup>th</sup> century residents and the featured exhibit.

# **Tree Care Information Spotlight**



Hypoxylon Canker

Hypoxylon canker is a fatal disease of already stressed trees and is unable to colonize healthy wood. Often, trees with Hypoxylon have been declining for years which is common in urban areas with altered water tables and compacted soil. The disease affects hardwoods, particularly red oaks and maples. If a tree is declining or stressed (especially from drought), it likely will be killed eventually by Hypoxylon.

Diagnostics: Silvery-grey or black flat patches on bark in long, vertical sections. These dark patches may be overlooked as decaying wood with bark sloughing off. Affected trees may have dieback in crowns or reduced numbers of live branches.

Prevention is the solution for reducing damage from this disease. Keep trees healthy by watering. Prune only during dormancy and apply mulch properly around the tree.
