**Size:** Small

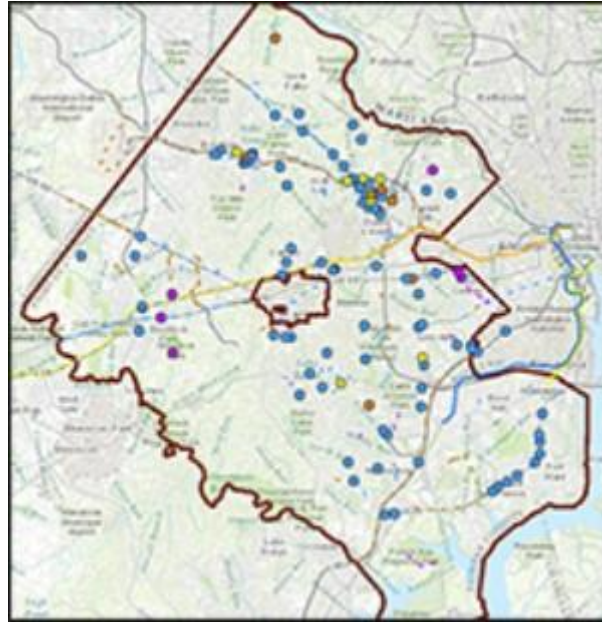
**Declawed:** No

## Transportation Status Report and Interactive Map

---



The Fairfax County Department of Transportation (FCDOT) prepares its biannual report to the Board of Supervisors on transportation projects and activities within the county. The report includes updates on all active projects, including those projects in the Third Four-Year Transportation Program for FY2013 through FY2016 and the Board approved [Transportation Project Priorities \(TPP\)](#) for FY2015 through FY2020. The report has a new title, "Fairfax County Transportation Status Report," replacing the previous title, "Status Report on the Board's Third Four-Year Transportation Program." Since the report covers projects and activities beyond the Four-Year Program, the new name more accurately reflects the contents of the report.

**Helpful Tips: Reviewing the Status Report**

---

- The project status report is organized by District. Within each District the projects are listed in alphabetical order
  - Roads that are more commonly recognized by their route number are listed by Route #. For example, projects involving Leesburg Pike are labeled as Route 7 and would be found in the "Rs"
  - Interstate projects will be found in the "Is" These include: I-66, I-95, I-395, I-495
  - Each project is identified by type in the bottom left corner as one of the following:
    - **INT = Interstate Project PRI = Primary Road (Rte. 1- 599)**
    - **SEC = Secondary Road (Rte. 600+)**
    - **TRAN = Transit Project**
    - **PED/BIKE = Pedestrian and/or Bicycle Project**
  - When searching for a project in the electronic document use "Ctrl+F" to open the Find tool. You can use this tool to search for a project using information you know. For example, you could use the tool to search for all pedestrian and/or bicycle projects by pressing "Ctrl+F" and typing in "ped/bike" This will allow you to find all pedestrian and/or bicycle projects in the report regardless of the district or route number

    - Projects not located along a road can be found at the end of the report and are designated with route number "XXXXX"
    - Interstate projects are listed after all of the projects on numbered routes because they are labeled I-66, I-95, I-395, and I-495

## Explore History with Your Dog on a Walk at Ellanor C. Lawrence Park



Take a walk back in time with your canine companion at the [Walney History Dog Walk](#) on **Sunday, March 26, 2017**, at Ellanor C. Lawrence Park (ECLP).

Visitors enjoy many animals today at Walney's visitor center, but critters are nothing new to this property. Take a guided hike at ECLP from 2:00 to 3:00 p.m. and learn about the animals that lived at Walney in the past. Walk the Historic Loop and the grounds from Walney to Middlegate while learning about animals in the property's history. Participants "and their dogs" must be able to walk a half-mile.

This program is designed for participants age three to adult. The cost is \$6 per person.

## Accessing Critical Human Services With One Phone Call



An average of 350 calls are made each day to **703-222-0880** (TTY 711), the county's lifeline for human services information and resources. It is the number you call if you need emergency help such as food, a place to sleep, or getting your electricity turned back on in your home. You can also call for information on how to access long-term assistance, such as getting a job, finding child/elder care or applying for food stamps.

That number is answered by a team of up to 40 social services specialists in our Coordinated Services Planning (CSP) Division in Neighborhood and Community Services. The CSP operates as a hotline call center for human services, Monday to Friday from 8:00 a.m. to 4:30 p.m.

### Why People Call:

---

For the first six months of FY 2017 (July to December 2016), the most frequent topics discussed on calls to CSP were for assistance or information in the areas noted below. These numbers do not reflect actual call volume, but the number of times assistance or information was provided in each area. Callers may receive assistance or information on multiple topics per call.

- Emergency Food: 2,969
- Rent Aid: 2,597
- Emergency Housing/Shelter: 1,554
- Food Stamps: 1,260
- Utility Assistance: 1,230
- Medicaid: 947

The CSP staff is trained to help a resident who may be overwhelmed and will work with them to develop creative solutions that address both immediate and long-term needs. A typical day for the team includes managing the call queue, staffing complicated cases, exploring resources to meet needs, communicating with nonprofit partners and managing complex caseloads of people who have a host of emergency needs.

The specialists who answer the CSP hotline are based in four different locations, one in each of the county's [human services regions](#). The four human services regions provide integrated community-based services that respond to the unique needs of individuals and families within a specific geographic area.

In addition, the multilingual staff can assist callers in **Amharic, Dari, Farsi, Hindi, Italian, Korean, Pashto, Punjabi, Somali, Spanish, Swedish,**

**Tigrinya, and Urdu.** Services are also available in other languages through the use of an interpreter.

## Free Carseat Inspections



Certified technicians from the Sully District Police Station will perform free, child safety carseat inspections **Thursday, March 30, from 5:00 to 8:30 p.m.**, at the station, 4900 Stonecroft Boulevard, Chantilly, VA 20151. No appointment necessary. Residents should install the child safety seats themselves so technicians may properly inspect and adjust them, as needed. Because of time constraints, only the first 35 vehicles arriving each date will be inspected. This allows inspectors to have enough time to properly instruct the caregiver on the correct use of the child seat. Call 703-814-7000, ext. 5140, to confirm dates and times.

## Grass Height

*Do you know about Fairfax County's rules on Grass Height?*

- ◆ Complaints regarding grass height are accepted from **April 1st – Mid-October**
- ◆ **RESIDENTIAL:** Grass may not be taller than 12 inches in height on any developed residential lots (vacant or occupied) that are one-half acre (21,780 sq. ft.) or less. This also applies to undeveloped residential property, which is less than one-half acre and which is located in a recorded subdivision where 90% of the lots have been developed.
  - ◆ Grass height is not regulated for properties that are larger than one-half acre.
- ◆ **COMMERCIAL/INDUSTRIAL:** While some exemptions may apply, grass may not be taller than 12 inches in height on any vacant developed commercial/industrial property.
- ◆ After sending a Notice of Violation to the owner, Fairfax County may have tall grass cut at the owner's expense if compliance was not met.
- ◆ **Virginia Department of Transportation (VDOT)** is responsible for cutting tall grass along roads or in medians on state maintained roads. To make a complaint call: **1-800-367-7623**.
