It was a busy week in the Sully District! On Tuesday, I chaired my first county-wide Development Process Committee meeting where we had informative presentations from County staff about two pieces of legislation from Richmond that effect Fairfax County.

First we discussed a change to Fairfax County's ability to regulate monopolies and cell phone towers in certain districts. The new legislation requires Fairfax County to designate what areas will require a public hearing before construction of monopolies and cell towers. The second bill we discussed regulates re-zonings for residential developments. There are new restrictions on what we can request in proffers form the developers. We're meeting with County staff to understand the proffer bill's impacts on future residential developments. I'll provide updates in future newsletters. After that meeting, my colleagues and I went straight into discussing the prospect of a meals tax referendum in the upcoming November election. I believe voters should decide if Fairfax County is to impose a new meals tax to diversity our revenue stream. **I support putting this on the ballot in November for you to decide.**

Farmers Markets Opening Up

The Fairfax County Farmers Markets operate 11 farmers markets across Fairfax County, under the Fairfax County Park Authority. **By providing access to locally grown foods, our farmers market program strives to improve the health of Fairfax County citizens, support local food producers, and protect the environment.**

Make sure to check out our Chef at Market demonstrations throughout the season, where the VCE's Master Food Volunteers demonstrate how to make easy recipes using market produce. We also support access to the farmers markets for low-income citizens, through our SNAP at Market Double Bucks program.

Our markets are strictly **producer-only**, meaning that all of our farmers and producers may only sell what they raise on their farms or make from scratch. We encourage our vendors to use local ingredients in the creation of their products as much as possible. Our farmers and producers all come from within a 125 mile radius of Fairfax County.
