History Spotlight: Old Stone Church



The Old Stone Church, built in 1854, has become an iconic picture of the Civil War. It was the first designated Union Army surgical hospital, receiving major casualties from the Battles of Blackburn's Ford (1861), First Manassas (1861), and Second Manassas (1862). As Centreville changed hands between Union and Confederate forces throughout the Civil War, so did the medical services of the Old Stone Church. Honey Bee Initiative Pollinator Program



Honey bee hives in Virginia have declined by two-thirds since 1970 due to colony collapse disorder, invasive mites, and manmade pesticides. Bees pollinate one-third of the food we eat, so their health is tied to ours.

The Department of Public Works and Environmental Services has partnered with <u>George Mason University's Honey Bee Initiative</u> to create pollinator habitat at the I-95 landfill complex and build apiaries, clusters of bee hives.

GMU's program began in 2012 and now includes 40 hives located throughout Northern Virginia. The goals of GMU's program are education, collaborative research, and improving the security and sustainability of Northern Virginia's ecosystem.

Landfill complex supervisor Eric Forbes, a GMU alum, contacted former classmate and bee expert German Perilla about managing bees at the landfill. Nearly five acres of previously mowed turf at the landfill complex have been seeded to grow a native meadow for pollinating insects. The meadows will beautify the landfill, improve water quality, create pollinator habitat, and reduce mowing costs. Landfill staff have built 12 bee hives (three apiaries) and the goal is to build more to support 30,000 bees.

Dredged material removed from Lake Royal was used as topsoil. The landfill

complex composts leaves on-site and that organic material was used to enrich the soil.

The Honey Bee Initiative Pollinator Program will receive \$50K over the next five years (\$10K/year) from the county's Environmental Improvement Program. The program supports the county's 20-year Environmental Vision and creates educational opportunities for students and community groups. This program is one of the ways in which the landfill is transforming into a destination for environmental experimentation and education.

Cooling Assistance & Fan Care Programs



Fairfax County residents who need help to keep their homes cool this summer and to prevent a health emergency resulting from extreme heat may be able to get assistance from two programs locally administered by the

county's Department of Family Services.

The Cooling Assistance Program:

The Cooling Assistance program, a federally funded program, helps eligible low-income households with at least one person considered especially vulnerable to heat: a child under age six, a disabled individual, or an adult age 60 or older. Cooling assistance can be used to help with:

- Payment of electric bills to operate cooling equipment.
- Payment of security deposits for electricity to operate cooling equipment.
- Repair of a central air conditioning system or heat pump.
- Purchase of a whole-house fan, including ceiling or attic fans.
- Purchase and installation of one window unit air conditioner for households where there is no unit or where the unit must be replaced.

Applications for the Cooling Assistance Program will be accepted from June 15 through August 15.

The Fan Care Program:

The Fan Care program is another way to help older Fairfax area residents stay safe in the summer heat. This electric fan distribution program, sponsored by Dominion Virginia Power in partnership with the Virginia Department for the Aging, annually provides about 200 free fans and/or window air conditioners to eligible senior adults in the Fairfax area.

To qualify for Fan Care, a person must be at least 60 years old, need a fan to prevent heat-related health problems and meet income eligibility requirements. Not everyone in the home needs to be an older adult to qualify for a fan, but all incomes must be counted. There is a limit of one fan per household.

The Fan Care program begins on June 1 and runs through the end of September. To request an application, call the Fairfax County's Department

Comment Online on the E.C. Lawrence Draft Master Plan Revision



The Fairfax County Park Authority (FCPA) continues to explore new ways to engage with the community in its park master planning efforts. As the Park Authority requests public input related to the revision of the Ellanor C. Lawrence Park Master Plan, citizens who wish to comment are now able to use CiviComment as an alternative to email.

CiviComment is a crowdsourcing website that allows users to comment directly into the draft master plan document and discuss comments made by other reviewers. We understand that many residents will choose to provide their comments via email, in writing, or in person, which is fine. We welcome all comments! For those who are unable to download and print large documents (such as on a public computer) or those who prefer a more collaborative experience, please consider giving CiviComment a try.

The Ellanor C. Lawrence Park draft master plan revision is available for review on the project's website at Ellanor C. Lawrence Park Master Plan Revision. After following the link from the project's website to the CiviComment site, users will be asked to create an account before participating.

As CiviComment is a new tool for the Park Authority, we would appreciate any feedback about your experience using CiviComment. If the experience is beneficial, we may expand use of the service to supplement our public planning process on future projects.

All comments on the Ellanor C. Lawrence draft master plan revision must be received by July 10, 2017, to be included in the official public record. If not using CiviComment, written comments should be directed to Project Manager Ryan Stewart, Planning & Development Division, Fairfax County Park Authority, 12055 Government Center Parkway, Suite 421, Fairfax, VA 22035. Email comments may be sent to: Parkmail@fairfaxcounty.gov. After all comments have been considered, the plan will be modified, as necessary, and presented to the Park Authority Board for final consideration and approval.

Protect Your Wallet: Scammers Using High-Tech Skimmers at Gas Stations



Scammers have found a way to empty your bank account within minutes.

Our police department's financial crimes detectives are seeing a concerning trend at local gas stations. Criminals are using high-tech skimming devices to steal your bank card information and money. In the last year, our investigators have removed 21 individual skimmers from 15 different locations in Fairfax County.


What's also concerning is a new wave of Bluetooth skimmers are harder to detect. They're completely inside the pump and there's no real warning sign to look out for when you go to pay.

The financial crimes unit is working diligently, but there are some steps you can take to better protect your pocketbook:

- Use a credit card when possible and not a debit/ATM card where you need to enter a PIN. New technology allows them to get your PIN and clone your card in no time. It also may be more difficult to have personal bank funds reimbursed.
- 2. Try to **avoid older gas pumps** which are easier to infiltrate and alter.

- Check your bank and card statements regularly for any suspicious charges. If you notice anything fraudulent or questionable, contact your bank or credit card company immediately.
- If you feel you've been a victim of financial crime in Fairfax County, you can report it online through the Financial Crimes Online Reporting (FiCOR) system Report a Financial Crime




Meet Smokey!

Mentor With BeFriend-A-Child!

The BeFriend-A-Child Mentoring Program matches adult volunteers with children between the ages of 5-12 who are in need of a mentor. All have experienced trauma in some form or another, such as child abuse or neglect, familial substance abuse, domestic violence, or parental absence. Our hope is that through developing a relationship with a mentor, these children will increase their confidence, have a healthy and positive outlet, and develop resiliency against life's adverse experiences. Mentors and mentees are matched for two years. Mentors must be at least 21 years of age and able to pass background checks. Mentors must be able to make a two year commitment, spending at least 8 hours every month with their mentee and participating in monthly program outings at least once per quarter. Mandatory training is provided
