A MESSAGE FROM KATHY SMITH

At this week's board meeting we debated a tax rate advertisement and held a Snow Summit to review what happened during January's blizzard event. You can read more about "Snowzilla" below, but I want to update you first on the tax rate advertisement.

As a local government we are required to balance our budget. But at this time in the process we do not yet have completed state or federal budgets that tell us exactly how much money to expect for our many jointly funded programs. So the Board has to maintain some flexibility until we get all of this information.

This week, we advertised a tax rate of \$1.13 per \$100 of real estate value. This is up four cents from last year's rate. The rate we advertised is not the final real estate rate- but the maximum that we have as an option. After getting a state budget mostly completed later this month we will have more information and will be able to select a final tax rate in April.

I look forward to hearing your thoughts on the budget, and I hope you can join me Monday March 7th at 7:00 at Rocky Run Middle School for my budget meeting and discussion with Sully School Board member Tom Wilson. I-66 INSIDE THE BELTWAY DESIGN PUBLIC HEARINGS

The Virginia Department of Transportation (VDOT), in partnership with the Virginia Department of Rail and Public Transportation (DRPT), will host Design Public Hearings for the Transform 66 Inside the Beltway Project on March 7, 8 and 9, 2016. Information on how dynamically-

priced toll lanes will operate on I-66 inside the Beltway, as well as proposed locations of toll gantries and pricing signs will be provided. All of the hearings will include the opportunity to view project displays and attend a formal presentation, followed by a public comment period.

All hearing times are 6-8 p.m., with a brief presentation beginning at 6:30 p.m.

DULLES SUBURBAN CENTER STUDY

You are invited to a community meeting with County staff and Supervisor Smith on **Tuesday, March 29, 2016 at 7:00 pm** to learn about the Dulles Suburban Center Study. This study will assess current conditions and update recommendations for future land uses and development for the 5,000 acre area adjacent to the Washington-Dulles International Airport, along the Route 28 and Route 50 corridors.
