Deadline Extended Until June 3 for Fairfax County & Franconia-Springfield Parkways Survey:

The Fairfax County Department of Transportation (FCDOT) has posted [Frequently Asked Questions](#) about the [Fairfax County & Franconia-Springfield Parkways Alternative Analysis and Long Term Planning Study](#), and has extended the deadline for the [online survey](#) for two weeks. **The online survey will close on June 3, 2019, at 11:59 p.m.**

The survey was developed based on community input from first round survey results last year. The current survey will gather feedback from residents on future corridor transportation improvements and help the project team decide which improvements will be selected for screening and testing.

Fairfax County Seeks Board of Zoning Appeals Member



The Fairfax County [Board of Zoning Appeals](#) (BZA) has an opening for one member. The BZA's powers, duties, and procedures are set forth in state law, and they are further detailed in the county's [Zoning Ordinance](#). Such powers and duties include: hearing and deciding appeals of administrative decisions made pursuant to the Zoning Ordinance, hearing and deciding upon applications for special permits and variances as authorized by the Zoning Ordinance, and hearing and deciding on applications for interpretation of the Zoning Map where there is uncertainty as to the location of a zoning district boundary.

Interested candidates must apply by Wednesday, June 5, 2019, to the [Fairfax Circuit Court](#), which appoints the board's seven members. Applicants should send their resume to Judge Bruce D. White, Fairfax Circuit Court, 4110 Chain Bridge Road, Fairfax, VA 22030.

The appointment for this open position will be effective until April 15, 2023. BZA members are appointed for staggered, five-year terms. **Applicants must be residents of Fairfax County and serve as private citizens, not as county employees.**

Reducing the Number of People With Mental Illness in Jail



[Stepping Up](#) is a nationwide initiative to reduce the number of people with mental illness in jails, and this May, Stepping Up is leading the a full Month of Action, during which time counties will demonstrate their impact and highlight their efforts toward reducing the number of people with mental illnesses in jail. So how are we "Stepping Up?"

Diversion First:

We operate a successful [Diversion First](#) program, which offers alternatives to incarceration for people with mental illness or development disabilities who come into contact with the criminal justice system for low level offenses. Close to 1,400 people have been diverted from potential arrest thanks to the initiative.

Mental Health Docket:

The [Mental Health Docket](#) will allow commonwealth and defense attorneys to require a defendant to complete different phases of treatment and "graduate" before that defendant's charges will be resolved. A pilot docket, which began in August 2018, has already helped more than 180 people. The docket has been approved by the Virginia Supreme Court and will officially launch in Fairfax County this July.

Veterans Docket Graduation:

The [Veterans Treatment Docket](#) provides court services and support for veterans of our armed forces. This docket has been in place in the county since February 2015, and is designed to address the mental health and substance abuse issues that often result from the combat stress of military service.

Stakeholders Meeting:

Each quarter, a variety of stakeholders interested in diversion come together to discuss the county's progress and future efforts. The meetings are open to anyone interested in learning more about Diversion First in Fairfax County. For more information about these meetings, [click here](#).

5 Safety Tips to Conquer Home Improvement Season



May is Building Safety Month - just when you may start to wander the aisles of your local home improvement store, dreaming of updated outdoor patios, kitchens, and other upgrades to a house or condo.

Hiring a contractor, permitting, and inspections will most likely be part of your plan, but you may not realize when or how. We are here to help!

Swimming Pools -

Did you know that any pool that is 24 inches deep or deeper needs a permit before use? Why? Pools can be a real safety risk, especially for small children. Building code requires that homeowners place a proper barrier around or over a pool of this size to prevent accidental drownings. For more information about pool regulations, [click here](#).

New Decks -

Most often, you or your contractor will need to supply plans for review before obtaining a permit for deck construction. Luckily, we have [standard deck construction plans](#) available to submit in lieu of a plan, making the application process easier. If you already have a deck, be sure to maintain it regularly and inspect it often. To learn more, [click here](#).

Gas Appliances -

You gas fireplaces, furnaces, water heaters, dryers, and ovens all need a permit before first installation AND when you need a replacement. It may seem like a hassle, but the consequences of a faulty installation can be catastrophic.

Tree/Play Houses -

When building outside play structures for your kids, just keep in mind the size. Anything over 256 square feet requires a building permit. This is the same rule that applies to sheds and any outdoor "accessory structure." Regardless of the size, if you are putting electrical or plumbing in this kind of structure, you will need trade permits.

Hiring a Contractor -

Verify the contractor is licensed. You can look them up on Virginia's Department of Professional and Occupational Regulation [website](#) or call 804-367-8511. Though you may obtain permits in your own name, we recommend that your contractors be listed on your permit application to indicate their responsibility for the work. Make sure you read the contract before you sign and request a cost estimate. Always

ask questions for clarification. Check references and seek advice when needed.

Park Authority Updates Regulations on Remote Control Devices & Unmanned Aircrafts



On April 10, 2019, the Fairfax County Park Authority Board approved an administrative update to Park Authority Regulation 1.17, Remote-Control Devices and Powered Models or Toys, to align with the Virginia Code. The revised regulation pertains to the use of privately-owned unmanned aircraft systems or drones.

Pilots have been allowed to fly unmanned aircrafts in the parks system without prior authorization from the Park Authority since July 1, 2018. However, pilots must still operate within the Federal Aviation Administration's safety and airspace regulations. The use of hobby rockets and remote-controlled cars and boats remains prohibited without a Park Authority-issued permit.

The Park Authority reminds users to fly safely and respectfully of other park

visitors. It is recommended that pilots not operate near unmaintained, wooded, or natural areas, as our parks are home to wildlife species that may be sensitive to these aircrafts.

Take Time to Talk to Teens About Emotional Health



Adolescence is a difficult time for teens and their parents. This time of year, with exams, tests, social events, and the upcoming end of the school year, emotions and stress can be exacerbated.

Here are step parents and caring adults can take:

- **Ask** - Pick a time that feels comfortable, and ask your teen how they are doing.
- **Listen** - The most important thing you can do for your teen is to listen without judgment to what they are experiencing and how they feel.

- **Validate** - Do not brush away their feelings as "just" teen angst. Let them know that mental health disorders are common and treatable. It will get better for them, even if they are going through a rough patch.
- **Talk about next steps** - If they have been open to talking to you about what they are going through, discuss what ways they might be comfortable to get help.

Mental health and wellness issues are not a one-time conversation. Letting them know that you are there for them, that you care, and that you will support them in anything they are dealing with can help your child navigate the bumpy teen years.
