## Sully Historic Site's House to Close for Maintenance



The main house at Sully Historic Site will be closed to the public for the first five months of the new year. The historic house will undergo structural repair and maintenance, and **it is scheduled to be closed from January 1, 2020, into May.** Exhibits, historic artifacts, and furniture in the house will be safely protected and packed to make room for work crews.

The historic site's grounds, outbuildings, and visitor center will remain open, and the center will remain the main point of contact for all visitors. The visitor center will be open Wednesdays through Sundays. Tours of the Fairfax County Park Authority property will resume in March, weather permitting. Cooking classes and demonstrations, scout programs, and all outreach programs will continue. The only building affected by the contracted work will be the site's main house. Tours of the house will remain available through the end of this year.

The repairs and maintenance at the main house are funded by the 2016 Park Bond. Repairs include work on siding and shutters, plaster and floors as well as painting and an electrical upgrade.

### **Back2Fairfax Teacher Seminar**





## WMATA: Public Feedback on Service Improvements on Blue, Orange & Silver Lines



Metro recently released <u>several preliminary concepts</u> to improve reliability, meet future ridership demand, and better serve customers on the Blue, Orange, and Silver lines. The concepts, part of the two-year Blue/Orange/Silver Capacity and Reliability Study (BOS Study), include a range of infrastructure improvements and service alternatives to address both short- and long- term needs.

Metro will hold a series of open houses to provide information about the draft concepts, answer questions, and gather community feedback.

### Land Development Process FAQ: By-right Use



The zoning and land development process in Fairfax County involves comprehensive reviews by numerous county and non-county agencies and may involve many steps before a project can be approved. Every project is unique and subject to its own set of requirements depending on the location and complexities of the project.

#### **By-right Development:**

Proposed development projects that are considered a permitted use (by-right use) allowed by the <u>Zoning Ordinance</u> do not require approval from the Board of Supervisors, Planning Commission, or the Board of Zoning Appeals.

#### **Example (Commercial Property) -**

The proposed project is to open a restaurant in the Sully Square Shopping Center zoned C-8 (Highway Commercial). A restaurant is a permitted use in this district so county approval is not required from the Board of Supervisors, Planning Commission, or the Board of Zoning Appeals.

#### **Example (Residential Property) -**

The proposed project is to build single-family attached dwelling units (townhouses) on private open space (planned development) zoned R-12 (Residential 12 DU/AC).

This use is a permitted use in the R-12 District and would not require approval from the Board of Supervisors, Planning Commission, or the Board of Zoning Appeals as long as density does not exceed 12 dwelling units per acre.

## Parking Rates Adjusted to Accommodate Modern Retail Industry Trends



The Board of Supervisors approved a new minimum parking rate for large shopping malls at its Tuesday, December 3 meeting. The changes give Fairfax County's largest commercial retail centers additional flexibility to adapt to a changing retail marketplace as residents increasingly shop online.

The minimum parking requirement for malls of 800,000 net square feet or more is being reduced from four spaces per 1,000 square feet to a rate of 2.5 spaces per 1,000 square feet. This approved change comes after a parking analysis conducted by Nelson/Nygaard revealed that no more than 70 percent of available spaces were occupied during peak holiday shopping seasons at Fair Oaks Mall and Springfield Town Center.

Reducing required parking at large malls will provide an additional opportunity to re-purpose parking areas and is aligned with several key county goals including reducing environmental impacts and fostering the ability to create a higher-density, mixed-use, multi-modal community.

## 5 Things to Know About Fairfax County's New Solar Energy Initiative



Fairfax County is continuing to lead the way in advancing solar energy by launching a largescale renewable energy initiative to reduce our utility costs and carbon footprint. We are awarding contracts to solar power purchase agreement service providers to install solar panels on county properties. We will purchase electricity generated by the solar panels from the solar power service provider.

### Here are five important things to know about the new solar initiative:

- 1. This is the largest solar power purchase agreement (PPA) initiative launched by a local government in Virginia to date.
- 2. More than 100 county buildings are included in the first phase of this initiative including schools and parks.
- 3. Fairfax County will purchase solar energy generated by rooftop and carport/canopy arrays placed on site at county buildings but will not be responsible for installation, maintenance, operation or decommissioning of the arrays. That responsibility will rest with the PPA service providers.
- 4. The contracts include favorable electricity rates that are fixed, as a result, this initiative could potentially yield over \$60 million in electricity cost savings over the terms of the contracts.
- 5. The contracts established with the solar PPA vendors allow other local governments in the area to take advantage of the competitive rates and reduce their own greenhouse gas emissions and energy bills.

## A Bunch of Reasons to Hug a Tree

Understanding an urban forest's structure, function, and value can promote management decisions that will improve human health and environmental quality. An assessment of the vegetation structure, function, and value of Fairfax County's forest was conducted in 2017. Data from 203 field plots located throughout the county were analyzed using the i-Tree Eco model developed by the U.S. Forest Service, Northern Research Station.

- 44,400,000 trees
- 51.2% tree cover
- Most common tree species: American beech, red maple, and tulip poplar
- Percentage of trees less than 6 inches in diameter: 67%
- 4,500 tons of pollution removed per year, with a value of \$1.83 billion
- 7.4 million tons of carbon stored, worth \$969 million
- 232,900 tons of oxygen produced each year
- 392.6 million cubic feet of runoff avoided per year, valued at \$26.2 million/year
- \$34,300,000 in building energy saved per year
- 51,940 tons of carbon emissions avoided per year, valued at \$67.4 million
