The public meeting on Monday, September 18 will be hosted by the Commonwealth Transportation Board and the Virginia Department of Transportation (VDOT). They will provide information on transportation projects in Virginia. VDOT will hold a public hearing on Thursday, September 21. At the meeting VDOT will present information about a plan to add a third lane to northbound Route 29 in Centreville. Both meetings are open to the public. More information is below.

Commonwealth Transportation Board Public Meeting



The Commonwealth Transportation Board will host nine public meetings across the commonwealth so that the public may provide comments on transportation projects and priorities. The meetings will begin with an open house followed by a town hall style meeting. The open house will provide information on various transportation initiatives including proposed changes to Virginia's project prioritization process (SMART SCALE), recently funded projects in the Six-Year Improvement Program, Virginia's Statewide Transportation Improvement Program, VTrans Multimodal Transportation Plan, and Scenario Planning and Freight plans. Representatives from the Office of Intermodal Planning and Investment, Departments of Transportation and Rail and Public Transportation, along with Metropolitan Planning Organizations, Planning District Commissions, and Transit

organizations will be in attendance to highlight their transportation programs and to discuss your ideas and concerns on Virginia's transportation network. The open house will be followed by a town hall session, where you can engage in discussion and ask questions about the various initiatives. Comments will be accepted informally at the meeting and may also be submitted via email, or online.

Monday, September 18, 2017 - Open House begins at 4:00 p.m. and presentation will begin around 4:30 p.m.

Old Lee Road Vehicle Storage/Maintenance Site & Facility (RZ 2016-SU-005)

Commission Hearing Date: 9/14/2017

An applicant is proposing to construct a vehicle storage and maintenance location on Old Lee Road near a Fairfax County bus storage and maintenance site. It would be situated across Stonecroft Blvd. from Westfield

High School with the entrance to the site on Old Lee Road. The site will be sub-divided and fenced so that vehicle storage is separated from the vehicle service facilities.



Arden Courts Assisted Living/Memory Care Facility (FDPA/PCA 82-S-077-04; FDPA/PC 94-Y-020)

Commission Hearing Date: 10/05/2017

This particular project is a memory care/assisted living facility proposed to be constructed in the Compton Village Subdivision area. The site is adjacent to Centreville Road (which falls on its west-side) and surrounded on the east, north, and south by elements of the Compton Village Subdivision. As noted in my earlier newsletter, the facility would have a 64-bed capacity for residents/patients.



Parkstone Drive Office Facilities (PCA 85-S-061-05)

Commission Hearing Date: 10/19/17

A multi-office construction project is proposed off of Parkstone Drive.

Parkstone Drive is off of Conference Center Drive and the two-office facilities would sit adjacent to Braddock Road. The site falls within the Washington Technology Parks sequence of office campuses.



Taco Bell Restaurant (SEA 89-C-047-02)

Commission Hearing Date: 11/02/2017

A Taco Bell Restaurant has been proposed for construction in the McLearen Square Shopping Center adjacent to the existing Burger King at the corner of Centreville Road and McLearen Road. The proposed development would sit next to a Shell Gas Station and the aforementioned Burger King. The McLearen Square Shopping Center Is anchored by a Food Lion grocery store.



Mini-Warehousing Facility (SE 2017-SU-022; RZ 2017-SU-025)

Commission Hearing Date: 11/30/2017

A mini-warehouse facility has been proposed for development off of Fort Drive behind the Centreville Crest Shopping Center. The project would sit at the terminus of Fort Drive and be adjacent to Centreville Road and just south of the intersection of Lee Hwy (29) and Centreville Road (28).




Dulles Discovery South Office & Parking Facilities (FDP/RZ 2017-SU-011)

Commission Hearing Date: 11/30/2017

A new office facility has been proposed to be relocated from its originally approved site on the Dulles Discovery South office campus to a new location on the same site but closer to existing or under construction office facilities. The new facility was previously approved as part of prior applications. In addition, a complimentary parking structure has been proposed to be located near the relocated new facility and the existing office structures. The site sits between Route 28 and Historic Sully Way (on one side) and Centreville Road.

Dynamically Tolled Express Lanes on I-66 Set to Open in December



Good news for drivers who need to get in and out of Washington D.C. during rush hour traffic: Single-occupant vehicles will now have a new option to travel on I-66. But there will be a toll if you travel alone.

Starting in December, dynamic tolling will begin along a 9-mile stretch of I-66, from I-495 to U.S. Route 29 in Rosslyn during peak hours – 5:30 to 9:30 a.m. eastbound and from 3:00 to 7:00 p.m. westbound, Monday through Friday.

The lanes will remain free to all users during the off-peak periods, including weekends.

This will be the first time since 1982 that single occupant drivers can use that stretch of road during those hours.

How the Tolls Will Work:

Dynamically priced tolls change with variances in traffic volumes and speed, which keeps traffic moving at free-flow speeds. When traffic volumes are heavy, tolls will increase; when volumes are light, tolls will decrease. Free-flowing lanes enable all users to experience more predictable trips that take less time.

All vehicles traveling during these periods will need an E-ZPass transponder, and HOV-2+ vehicles will need an E-ZPass Flex transponder switched to HOV-mode to travel for free.

The project involves installing eight toll gantries (frames over the road) spanning the eastbound and westbound travel lanes of I-66 along with a gantry that spans the eastbound lanes of the Dulles Connector Road (to differentiate trips east of the Dulles Connector Road). Also, approximately 125 signs are being installed along I-66 and approaching roadways. The current toll rate will be prominently displayed on some of these signs so drivers know what they will be charged.

Testing Now Underway:

The Virginia Department of Transportation (VDOT) is currently conducting field testing of the electronic tolling equipment through the fall to ensure the system is fully functional when tolling begins this December.

Drivers are now seeing flashing lights indicating testing of tolling equipment mounted on overhead gantries along I-66 inside the Beltway including cameras and E-ZPass readers, as well as test messages displayed on new

electronic toll signs on I-66. Crews also are testing indicator lights, which briefly flash to show that a vehicle is traveling with an E-ZPass Flex in the HOV mode and will be used for HOV enforcement once the express lanes are in operation.

Looking Ahead to the Future:

A new lane will be added to a 4-mile stretch of eastbound I-66 between the Dulles Connector Road and Fairfax Drive/Glebe Road (Exit 71), removing a chronic bottleneck that slows travelers and compels some to divert from I-66 onto streets in Falls Church and Arlington. Construction is anticipated to start in 2018 with the lane opening to the public in 2020. Additionally, improvements to exits 69 (Washington Boulevard/Lee Highway) and 71 (Fairfax Drive/Glebe Road) will further enhance traffic flow.

The high-occupancy limit will be increased to HOV-3 when the I-66 express lanes outside the Beltway open in mid-2022. Raising the occupancy requirement will move more people in fewer vehicles, relieve traffic congestion and help the region meet federal air quality requirements.

The change to HOV-3 also will make I-66 consistent with the Capital Beltway, I-95 and I-395, which currently are designated HOV-3, as well as other HOV-2 facilities throughout our region that will be changing to HOV-3 in the future.

Sully Historic Site is seeking history enthusiasts. Volunteer Touring and Teaching Docents are needed to lead the public through this important local 18th century historic house museum. No formal experience is required; training will be provided.

Touring Docents at Sully guide public tours Wednesdays through Mondays, sharing existing historical research, with a flexible schedule and no rigorous script to follow. Teaching Docents work with school children in one or more

unique, hands-on Museum Education centers; subjects include Open Hearth Kitchen, 18th Century School, Slave Life, and Textiles. Dressing in historical clothing is optional. Docents must be 18 or older.

Part of the Fairfax County Park Authority, Sully Historic Site is the 1794 home of northern Virginia's first congressman, Richard Bland Lee, as well as more than 30 enslaved African-Americans. Sully, which includes extensive grounds and outbuildings, is located at 3650 Historic Sully Way in Chantilly, approximately ½ mile north of US Route 50 on SR 28.
