


Proposed First \$5 Million

- ➤ DPWES Trail Maintenance (Attachment B) \$1 million
- > FCPA Trail Maintenance (Attachment C) \$1 million
- Crosswalk "Lower Cost" Projects (Attachment D) \$3 million for First Group of Projects
 - Coordination with VDOT for expedited process underway
 - District priorities documented
 - > Advance 1-2 projects per district
- ➤ Board Item with Priority Projects at November 1, 2022, Board Meeting



Project Prioritization Process - Status



Proposed Next \$25 Million

- Circulate First Results from Prioritization Process to Board Offices
 - ➤ Anticipate in October
- ➤ Develop Short List of Projects with Board Members
- ➤ Public Outreach
 - Conduct online public survey sometime in December
 2022 January 2023
 - > Other outreach suggested by Board members
- ➤ Bring Final List to Board for Consideration
 - Anticipated in March 2023





Proposed Next \$25 Million

- ➤ \$6 million for Safe Streets and Roads for All (SS4A) Federal Grant Local Cash Match (If Awarded)
- > \$1 million for Additional DPWES Trail Maintenance
- > \$1 million for Additional FCPA Trail Maintenance
- > \$7 10 million for Remaining "Low Cost" Crosswalk Projects List
 - > From projects considered for the initial \$5 million
- ➤ \$1 million Contingency for Project Cost Increases and Future Local Matches for Grant Applications
- > \$100,000 for Additional Speed Feedback Signs for FCPD
- > Approximately \$11 to 14 million for Projects from Prioritized List
 - > Following the outcome of the prioritization process anticipated in March 2023





Proposed Next \$25 Million – Specific Requests

- ➤ Example Projects and Allocations Already Discussed for Funding Consideration:
 - ➤ Blake Lane and Bushman Drive Pedestrian Intersection Improvements (Note: applied for federal funding in September 2022)
 - Route 7 Westbound Sidewalk from Magnolia Avenue across 5930
 Leesburg Pike (Liberty Gas Station) Frontage
 - ➤ Vale Road and Flint Hill Road Crossing (Flint Hill Elementary School)
 - Lockheed Boulevard from Hybla Valley Elementary School to Huntley Meadows Park

- Board Item with List of Priority "Low Cost" Projects at November 1,
 2022, Board Meeting
- > Implementation
- > \$25 million
 - Submit High Priority Locations List to Board Offices (Step 1 of Project Prioritization Process)
 - Develop Short List of Projects for Funding
 - Conduct Public Outreach
 - > Board Item with Final List of Projects and Start Implementation
 - Anticipated in March 2023
