Opening Remarks of Chair, Roll Call, and Electronic Meeting and FOIA Procedures

The meeting was called to order by Chair Champness at 7:34 p.m. To fulfill procedural obligations of virtual meetings, Chair Champness and Vice Chair Jones performed the opening procedures for a virtual meeting via WebEx. The meeting notes from the September 15th meeting were presented and approved unanimously by voice vote.

Update on Public Outreach Strategy for the ActiveFairfax Transportation Plan

Nicole Wynands with the Fairfax County Department of Transportation provided an update on the ActiveFairfax Transportation Plan. This plan was designed to bring together the myriad of different trails—for pedestrians and bikes—throughout the County.

The ActiveFairfax Transportation plan will accomplish a number of tasks, beyond the muchneeded reconciliation of the reconcile the Bicycle Master Plan, Countywide Trails Plan and regional connectivity in Area Plans. It will coordinate with neighboring jurisdictions, identify and address missing links in the network and improve access to activity centers, schools, parks and transit, bring the planned regional bicycle and trails network recommendations up to current standards, reinforce Active Transportation as a key element to Placemaking and provide guidance for context sensitive street design A tremendous amount of progress has been made on this project. A public website is launching in October, as is a working group on the systematic safety action plan. In November, a number of public engagement strategies will be launched, including community meetings, an interactive map, and targeted outreach to low-income and minority communities.

Implementation of Connected Autonomous Vehicle (CAV) Mosaic District Demonstration

Dale Castellow and Eta Nahapetian with the Fairfax County Department of Economic Initiatives reviewed the Relay project, which is a connected autonomous vehicle (CAV) that launched in the Mosaic District in October (a few days after the meeting).

Relay connects the Mosaic District to the Dunn Loring metro stop and is the outcome of a manyyears long project designed to improve transportation options in our community, and ultimately support the Fairfax County Strategic Plan.

This project began with a series of meetings in 2016, 2017 and 2018—including the Smart Cities Readiness Workshop that was attended by a number of members of the TAC.

There are a number of partners responsible for making the Ready CAV project come to fruition, including not only Fairfax County but also Dominion Energy, the Virginia Department of Transportation (VDOT), the Virginia Transportation Research Council (VTRC) and Virginia Tech Transportation Institute (VTTI), the Virginia Department of Rail and Public Transportation (DRPT), EDENS (the developer of the Mosaic District), Easily Mile (the shuttle manufacturer), Transdev and the George Mason School of Business.

This is not only an incredibly exciting project, and an opportunity to learn a lot that can help us moving forward, but really a truly groundbreaking exercise.

Other Business and Announcements

Commissioners discussed the agenda for the next meeting, as well as plans for the annual TAC holiday dinner and agenda for the December TAC meeting. The 2020 TAC award was discussed, with potential award winners nominated. Also discussed was creation of an award for the previous TAC Chair, for all of the work that he did during his long tenure on the TAC.
