### **Opening Remarks**

Acting Chair Hoskin made a third motion that "all of the matters on the agenda previously furnished and posted on the TAC website are necessary for continuity in Fairfax County government, and/or are statutorily required or necessary to continue operations and the discharge of this Commission's lawful purposes, duties, and responsibilities". It was seconded by Commissioner Sitnik and unanimously approved by the Commission.

#### **Minutes**

Acceptance of May minutes meeting as amended. A motion to accept the May meeting notes was made by Commissioner Morse and seconded by Commissioner Sitnik. The minutes of the May meeting, as amended by Commissioner Hancock, were accepted unanimously.

**West Falls Church and Huntington Active Transportation Plans** – Tim Kutz, Transportation Planner, Transportation Planning Division, FCDOT.

The impetus for the study was the West Falls Church planning amendment adopted by the Board of Supervisors (BOS) in July 2020. The goal was to allow for increased land use density and mixed-use development at the West Falls Church Metro station. Virginia Tech obtained a Smart Cities grant to development.

Most of the redevelopment will occur within the one-mile radius of the Metro station, the walk shed, and a two-mile radius planned for cyclists. Input was sought from area residents by advisory panels. That input was used by technical groups made up of public agencies that would motivate specific plans to improve safety accessibility and comfort for all users, increase connectivity in surrounding neighborhoods and to inform the rezoning process for developments.

The innovation with this study is to evaluate pedestrian infrastructure with respect to pedestrian comfort goals. Developed for the Montgomery County Maryland Planning Department, it is a

point-based rating system based on factors that contribute or detract from perceived pedestrian comfort.

The Huntington Metrorail Active Transportation Study is similar to the West Falls Church Study but resulted from a Metropolitan Council of Governments grant. The goal was to assess the conditions for pedestrians and cyclists. Two different metrics were developed to assess pedestrian and bicycle quality. Ultimately, these studies will motivate zoning and uses in both areas.
