Opening Remarks

The meeting was called to order by Chair Champness at 7:43 pm. The Chair then proceeded with the protocol necessary to justify a virtual meeting.

The Chair made a first motion to "determine that each member's voice can be adequately heard by each other member of this Commission." It was seconded by Commissioner Morse and unanimously approved.

The Chair made a second motion that "the State of Emergency caused by the COVID-19 pandemic makes it unsafe for this Commission to physically assemble and unsafe for the public to physically attend any such meeting. The Chair made a third motion that "all of the matters on the agenda previously furnished and posted on the TAC website are necessary for continuity in Fairfax County government, and/or are statutorily required or necessary to continue operations and the discharge of this Commission's lawful purposes, duties, and responsibilities". It was seconded by Commissioner Morse and unanimously approved by the Commission.

Minutes

A motion to accept the July meeting notes was made by Commissioner Morse and seconded by Commissioner Sitnik, and unanimously approved by the Commission.

Safe Streets for All Program Recommendations

The Safe Streets for All Program stemmed from a Board of Supervisors (BOS) motion on Pedestrian Safety in January 2020. The elements of the Program are Street Design and Traffic Engineering, Equity concerns, Education, Implementation, funding, and monitoring outcomes. The goal is to improve access for all modes of transportation, including pedestrian and bicycle traffic, such that all can safely coexist. These criteria will guide future transportation design.

The outcome will be a Countywide Complete Streets Policy and Design Guide. The improved road and street design standard will accommodate different travel modes, and reduce vehicle speeds (this will require VDOT cooperation). The Program will establish an interdisciplinary Safe Streets for All Task Force. Small, easily implemented safety improvements will be expedited.

A Safe Streets for All Program Recommendations draft report has already been published. Board action in May 2022 has already implemented immediate key strategies and staff positions and program funding have been requested for FY 2024.

Public Comment Period

Since there were no members of the public present, there were no comments.

Officers Election

The incumbent Chair, Mike Champness, was nominated in last month's meeting and was elected at this meeting in accordance with TAC bylaws. As the Vice-Chair position was vacant, Commissioner Pete Sitnik accepted a nomination for Vice-Chair and was duly elected. The incumbent Secretary, Roger Hoskin, agreed to serve another term and was elected.

Other Business and Announcements

Future TAC meeting topics were discussed. A sub-committee was selected to review and select the TAC Achievement Award for 2022.

Topics and a strategy were discussed for the TAC meeting with the BOS on September 30.
