Chair Champness made a first motion to "determine that each member's voice can be adequately heard by each other member of this Commission". It was seconded by Commissioner Hoskin, and unanimously approved.

Chair Champness made a second motion that "the State of Emergency caused by the COVID-19 pandemic makes it unsafe for this Commission to physically assemble and unsafe for the public to physically attend any such meeting. Agenda and Discussion Topics:

TAC Work Plan

Discussed was the role of the public outreach role for the TAC. Also discussed was the types and variety of groups the TAC could and/or should work with. The TAC is already aware of and is proactively supporting the Active Fairfax initiative.

TAC members expressed interest in particular subject areas with the intent of developing expertise in that area. The issue of "Complete Streets" was discussed along with parking policies and public safety. Two Commissioners have already taken leadership in cycling access and safety. It is clearly acknowledged that subject areas may and do overlap.

The County's Comprehensive Plan is a vessel in which other topics could be subsumed. Coordination with VDOT was raised as a subject area for the TAC; specifically, street standards and roadside maintenance e.g., mowing.

TAC Transportation Achievement Award.

The TAC initiated the procedure and timeline for the 2021 TAC Transportation Achievement Award. An awards committee was impaneled. The solicitations for nominations will go out in October; nominations will be closed in November. December. and the TAC will reach a decision with an announcement by January.
