#### **Opening Remarks**

The virtual meeting was called to order by Chair Champness at 7:37 p.m. The Chair read the virtual meeting script and did the roll call. The Commissioner's voice and location were clearly announced and heard by everyone. A copy of the roll call is attached at the end of this meeting notes.

#### **Approval of the November meeting summary**

The November Meeting Summary was approved with minor edits.

#### **Transportation Policy Plan Updates**

The Board of Supervisors authorized the update in December 2022. The Plan provides guidelines for Staff. Policy Plan Elements include land use, environment, and transportation. New elements are equity and community health. Recent additions are Parks and Recreation and

Human Services. Ongoing elements are public facilities and housing and being updated. The Policy Plan update will take most of 2024.

TAC input would be welcome in formulating what trends in transportation should be considered for the update. What near and long-term goals could be recommended for the County's transportation system? The TAC could contribute a critique of particular elements.

The Commission raised service issues to more rural parts of the County, such as connector service substituting for WMATA service and bus rapid transit substituting for fixed rail. Active Fairfax Program will be rolled into the Policy update. Additional EV charging stations and paratransit are expected to be added to the update. The TAC could be extensively involved in the Policy Plan update process.

#### **Active Transportation Updates and Review of Bicycle Parking Guidelines**

Fairfax County already has a bicycle and trails Master Plan, but they are outdated. Active transportation adopted in 2020 means self-propelled or human-powered travel for transport and recreation. The objective is to update the bicycles and trails plan in light of Active Fairfax. The project goal is to develop a connected network of sidewalks, bikeways, and trails to serve residents of all ages and abilities and aid planners and engineers in designing such facilities. Recommend policy changes that support the project goals. Finally, recommend initiatives to encourage people to use alternative transportation means. The project schedule is in two phases. The first is already complete. The second will span 2022 to 2024. Presently, progress is ongoing in developing the network and associated maps. Then, the program will be rolled out to the Community.

Fairfax County first endorsed bicycle Parking Guidelines in 2014. More recently, in 2020, the Bicycle Parking Guidelines were included in the Public Facilities Manual. As a result of the "Parking Reimagined" Zoning code changes in 2023, bike parking rates and basic requirements were approved. The latest step is to align Parking Guidelines with Zoning Code requirements. The updated guidelines will provide additional guidance since the Zoning Code doesn't cover everything. Commioners' questions delved into details regarding the number of bicycle parking spaces, location, and how this would be determined. Another question concerned whether these Guidelines were guidelines or requirements. Another issue raised is accommodations required to provide charging for electric bicycles. Any of these requirements can be waived in some circumstances.

Agenda for future TAC meetings. A major one is a planned future meeting with the Planning Commission. Another possible topic would be the Tysons Community Alliance. A future planned topic is progress and obstacles to self-driving vehicles, probably later in spring.
